

Arguments for Summer Music Booked for **Budget Meet**

Argument for restoration of the customary \$1000 appropriation for summer band concerts in the Salem city budget will be presented at the council meeting Monday night when the budget comes up for final action.

Members and friends of the municipal band contend it will not be possible to carry on the program with the \$500 appropriation approved by the budget committee, and have pointed out that in addition to the concerts, the band gives its services free for many other civic events. A statement issued by friends of the band reads in part:

"Can it be possible that this beautiful capital city of our wonderful state of Oregon can no longer help maintain a city band? "For the past fifty years, ever

since our beloved city was a small village, its successive city councils have set aside each year a modest sum for the purpose of encouraging and sustaining a city band. And on nearly all holidays and public occasions our citizens, young and old, have marched to its inspiring rhythm.
