

## **Development Loans Authorized For Marion County Farmers**

Loans to provide spring devel- cants for farmstead water loans opment, wells, cisterns and puri- or farmers wishing more detailed fication safeguards for farmstead information should contact the Presbyterian church. water facilities including water for livestock and domestic water and irrigation of not more than one acre of farm garden, have been authorized for farmers in Marion county according to word received this week by O. K. Lemmon, county Farm Security administration supervisor, old high school building, Salem,

"Eligibility will not differ ma terially from regular rural rehabilitation loans," Lemmon said. "The borrower must show that he is unable to obtain satisfactory financial assistance elsewhere. Applications for the present fiscal year ending July 1, should be made not later than May 15 and will be processed in the order they are received. After exhaustion of present available funds, applications will have to await further allocation of funds after July 1."

Farmstead water facilities loans can be made for the life of the facility not to exceed 20 years with interest at three per cent, it was explained. Wherever approved engineering plans or technical assistance is necessary, services of the nearest soil conservation service area offices will be available to borrowers. Loans under this authorization cannot be made to provide plumbing for the house


