NOTICE IS HEREBY GIVEN, that application has this 24th day of October, 1942, been filed with the County Clerk of Marion County, Oregon, for Judgment and Decree of the circuit court of the state of Oregon for Marion County, foreclosing the tax liens appearing in the foreclosure list of said Marion County, Oregon, and that each of the properties described in said foreclosure list, unless redeemed in the manner provided by law, will be sold to Marion County, Oregon, for the respective amounts of taxes and interest for which such properties severally are liable in conformity with the Judgment and Decree to be hereinafter entered; which said foreclosure list is as follows, to-wit:

AND, WHEREAS, the liens for unpaid and delinquent taxes on the respective parcels of such real properties are subject to foreclosure by Marion County, Oregon, as provided by law: NOW, THEREFORE, by virtue of authority vested in me as the tax collector for said county, I have prepared this foreclosure list embracing sheets numbered 1 to 54 inclusive hereto attached containing the names of the several persons appearing in the latest tax roll as the respective owners of the tax delinquent properties, a description of each such property as the same appears in the said latest tax roll, the year or years for which such taxes are delinquent on each property together with the principal amount of delinquent taxes for each year and the amount of the accrued and accruing interest thereon to June 15, 1942.

All the property described in the foregoing tax foreclosure list is situated in Marion County, State of Oregon.

Where the word "year" appears in the foregoing tax foreclosure list, it has reference to the year of delinquency of the taxes upon the respective properties described therein.

Where the word "tax" appears in the foregoing tax foreclosure list, it has reference to the principal amount of delinquent taxes for the years and upon the respective properties described therein.

Where the word "interest" appears or its abbreviation "int" appears in the foregoing tax foreclosure list, it refers to the amount of accrued interest to June 15, 1942, on delinquent taxes due for the respective years upon the respective properties set out therein.

Where the word "total" appears in the foregoing tax foreclosure list, it refers to the total sum of the delinquent taxes plus the accrued interest thereon to June 15, 1942, for each respective year upon the respective properties described therein.

Where the word "deed" appears in the hereto attached foreclosure list, it refers to the deed record for Marion County, Oregon.

Where the abbreviation "R.T." appears in the hereto attached foreclosure list it refers to the Register of Title in and for the records of Marion County, Oregon.

Where the abbreviation "C.C.J." appears in the hereto attached foreclosure list, it refers to the Circuit Court Journal in and for the County of Marion.

Where the word "Wills" appears in the hereto attached foreclosure list, it refers to the Record of Wills in and for Marion County, Oregon.

Where the abbreviation "P.C.J." appears in the hereto attached foreclosure list, it refers to the Probate Court Journal in and for the County of Marion.

Where the abbreviation "Sec" appears in the hereto attached foreclosure list it refers to section of land in Marion County, Oregon.

Where the abbreviation "Twp." appears in the hereto attached foreclosure list, it refers to Township in and for the County of Marion.

Where the words "Range E" appear in the hereto attached foreclosure list, it means Range East.

Where the words "Range W" appear in the hereto attached foreclosure list, it means Range West.

Where the abbreviation "W.M." appears in the hereto attached foreclosure list, it means Willamette Meridian.

Where the abbreviation "Vol." appears in the hereto attached foreclosure list, it has reference to volume of the tax roll for Marion County, Oregon.

Where the abbreviation "Deed" appears in the hereto attached foreclosure list, it has reference to the Volume of the Deed Record in and for Marion County, Oregon.

Where the abbreviation "P" appears in the hereto attached foreclosure list, it refers to Page of the Deed of Records in and for Marion County, Oregon.

Where reference is made in the hereto attached foreclosure list to townships, plats, additions, re-dedication of additions, subdivisions extensions, heights, town and parks, such descriptions refer to the duly recorded map and plat of each of said descriptions, duly filed and of record in the office of the County Clerk of Marion County, Oregon.
