State Court Orders Firm To Insure Men

The George A. Rahoutis company, Portland real estate firm, must have its 13 real estate salesmen covered by the state unemployment compensation law, the state supreme court held here Tuesday in an opinion written by Justice Brand.

The opinion upheld Circuit Judge James W. Crawford's decision in Multnomah county. Justice Rossman dissented. The company, which filed suit against the state unemployment compensation commission, contended its salesmen were independent contractors and not employees and were not subject to provisions of the law.

The court ruled that the salesmen were regular employees and subject to the act. Petition for rehearing was denied in a suit brought by the Portland Postal Employees Credit Union vs. the United States National Bank of Portland. The court's decision held that the un-
