

As far as institutions and corrective procedure

are concerned there is still far too little remedial treatment of offenders and far too much vindictive punishment, he said.

Delinquency, while clearly a symptom of personal maladjustment and an index of an unhealthy society in the opinion of the sociologist, is hardly as serious and widespread as many statistics and much publicity of certain cases would indicate, said Argow. Three variables in such statistics. as listed by the sociologist, are the types and frequency of offenses, the efficiency of enforcement
