

Sweet Home Boy Scouts End Lengthy Tour

Nine members of Boy Scout troop 31 of Sweet Home returned recently from a 3,418 mile-camping trip into the northwestern United States and Canada.

The Salem office of the Cascade area council said the eight boys and their scoutmaster Sam P. Cairnes of Sweet Home made the two-weeks trip in the troop truck.

In the U. S. the traveling scouts camped at Yellowstone national park in Wyoming and at the Maleta island national senior scout camp in Glacier national park in Montana. They went through Calgary and Edmonton, Canada, and camped at Banff and Lake Louise.

The scouts stepped across the Columbia river at its headwaters in the Columbia Rockies. They camped on the Columbia ice fields and returned to Sweet Home through Idaho and the Columbia river highway in Oregon. While at Lewiston, Idaho, they visited Harry Michelsen, former Cascade area council field executive, who is council executive at Lewiston.

Five Juveniles Draw Fines for Having Liquor

Five juveniles were fined in municipal court Monday and three others turned over to Marion county juvenile authorities following their arrests Saturday night by city police on charges of illegal possession of beer.

A Salem boy and a Jefferson girl, both 17, were arrested late Saturday night by Officer Don White near his home at 1940 Broadway st. White said the girl tossed an empty bottle from the boy's moving auto, nearly striking his young daughter after it spat-tered on the sidewalk.

Later the boy was charged with illegal possession of liquor, driving a car with defective headlights and fenders and with a noisy muffler. He was turned over to juvenile authorities Monday afternoon after posting \$50 on the four charges in municipal court. The girl, charged with disorderly conduct, was also handed over to the juvenile court.

A 14-year-old Rickreall youth, charged with being intoxicated and illegal possession of liquor, was confined in the county juvenile ward at Salem Memorial hospital. He and five other minor companions, ranging from 17 to 20 years of age, were apprehended by city police Saturday night in a trucked car on the 600 block of South Commercial street. The other five were fined \$25 each in municipal court Monday.
