Stock Market Recoups Loss

NEW YORK, Sept. 21-(AP)—In a long and determined effort, the stock market today fought its way back in a recovery movement that wiped out nearly half of its severe loss of yesterday.

The Associated Press average of 60 stocks gained 5.4 of a point to 67.2 as against yesterday's loss of 1.1.

Of 959 stocks traded, 379 advanced and 333 declined. And for new lows were set for the 57 as against yesterday's 101 stocks moving into new records.
