Area Seen as 'Power Center Of the World'

James Walton, Salem, president of the Cascade Electrical Contractors' association, told the senate committee on railroads and utilities Tuesday that the Pacific Northwest might soon be the "electrical center of the world."

Walton appeared in behalf of a senate bill prescribing an enforcement of the electrical safety code throughout the state. The legislation provides for a state electrical supervisor at a salary as yet undetermined.

He told the committee that due to lack of finances, many of Oregon's large cities are without adequate supervision of electrical contracts. Walton declared that over 22,000 jobs were performed in the state last year.

No new legislation is needed for test supervision, only the staff to check the contracts performed, Walton concluded.

CONTROVERSY . . . **HB 3 (Joint Ways and Means)** . . . Provides that all state employees, except those with salaries fixed by statute, be given \$20 pay increase effective until June 30, 1948.

HB 4 (Joint Ways and Means) . . . Provides money for fixing up temporary quarters for state tax commissioners. . . **HB 125 (Fisheries Com.)** . . . Eliminates unused sections of fisheries code.

HB 126 (Food & Dairy Com.) . . . Requires replacement of dairy products commissioner if he moves from congressional district from which he was elected. . . **HB 127 (Food & Dairy Com.)** . . . Increases tax on butterfat from 1/4 to 1 cent per pound. . . **HB 128 (Greenwood)** . . . Adds surplus to persons who can obtain liens against property.
