NEWARK, N. J., June 12 - (AP) - Nine-year-old Lamont Huntly had a sparkplug sticking three inches out of his forehead today.

The boy said the rusty plug was thrown at him by a vengeful school companion with whom Lamont had refused to share a box of crackers.

The plug struck his forehead over the right eye and stuck there, its terminal end embedded half an inch in his skull.

Young Huntly was reported in good condition at City hospital, despite his bizarre appearance. Doctors anticipated no difficulty in removing the plug, which had not penetrated the skull far enough to injure the brain.

## Father Charged With Neglect in Family's Death

PORT TOWNSEND, Wash., June 12 - (AP) - The father of a 12-year-old boy was charged with criminal neglect of the child today after the death of the boy and his mother from heavy lead poisoning.

Pros. Atty. William J. Daly filed the charges against Egmont G. Hildner, 55-year-old former ferry ticket agent at Port Ludlow. The boy, Jonathan Hildner, died June 7, his mother, Mrs. Adeline Hildner, 56, on Saturday.

Daly said an autopsy conducted by Dr. H. G. Plut, deputy coroner of Jefferson county, revealed traces of heavy lead poisoning in the kidneys of both victims.

Jonathan had been ill two days before a doctor was called, the prosecutor said, and was dead when the doctor arrived last Wednesday morning. The charge filed today specifically accuses Hildner of wilful neglect in failing to provide the necessary medical care.

Mrs. Hildner subsequently became ill and was hospitalized Thursday.

The poison, Dr. Plut said, can be taken only through the mouth.

**Smuts' Condition Reported Serious**  
JOHANNESBURG, South Africa, June 12 - (AP) - Field Marshal Jan Christian Smuts had a quiet day today after a poor night, a medical bulletin announced.

The 80-year-old statesman and former prime minister, suffering from pneumonia, had a relapse Saturday. The bulletin said he is more rested but that his condition is still serious.

## Columbia Crest Estimate Cut

PORTLAND, June 12 - (AP) - With the Columbia river flood threat eased by favorable weather, river experts today revised downward the predicted crest of the spring freshet.

The water will go no higher than 23 feet in the Portland-Vancouver harbor area, said Col. E. S. Ellison, director of the Portland weather bureau office. Earlier the bureau had estimated the crest would be between 25 and 28 feet.

## Law School Alumni Hear Dean Prosser

The number of present day law students incapable of spelling common words and unable to place their thoughts on paper in an understandable manner is increasing, William L. Prosser, dean of law at the University of California, told the Lawyers' Alumni association of Willamette university here Sunday.

Prosser said he didn't know where to place the blame but commented that when a student with 16 years of preparation and an AB degree is so inadequately prepared there is something radically wrong with the current educational methods.

The speaker denounced the question and answer form of examinations now used in both secondary and high schools throughout the nation. He said this type of examination can be graded by an assistant janitor.

Prosser also contended the question and answer examinations prevented the student from forming and expressing his own thoughts. "It certainly is too mechanical for any good to the student," Prosser continued. "They also tell me they are teaching phonetic spelling."

Prosser said he could well understand that because of the amazing number of law students who are unable to spell most common words. "I consider the English language, both spoken and written, the backbone of the lawyer's day by day work," Prosser averred.

He said many lawyers are inadequately trained for the profession. District Judge Joe Felton presided and introduced the speaker.
