Court Affirms Verdict on Water Rights

The State Supreme Court Wednesday affirmed a decree of Circuit Judge M. A. Biggs, Harney County, in a suit brought by Earl W. Withers and others, involving a water right.

The lower court held that the state forfeited its water right during 13 years it owned a 40-acre tract of land in Harney County for failure to irrigate although water was available from Mill Creek and Coffee Pot Creek.

The opinion was written by Justice Hall Lusk with Justices Earl C. Latourette, Walter L. Tooze and George Rossman dissenting.

The state acquired the land by deed but sold it in 1945 to Ralph E. Reed. The state engineer had applied the forfeiture law to the state and contended its successor, Reed, had no right or interest in the waters of Mill Creek or Coffee Pot Creck.


"Here the public interest is manifest." Justice Lusk wrote, "and any other construction would tend to diminish the value of the act and to defeat what we conceive to be the intention of the legislature.'
