## New 84-Page Manual Issued to Salem Police

What is believed to be the first all-inclusive police manual ever issued in Salem is now being used by members of the Salem Police Department.

The 84-page booklet was issued to members of the department last week and to City Councilmen Monday night. It has been compiled over a period of some three years, since Clyde A. Warren became chief of police.

Among items included in the manual are care and handling of firearms, laws of arrest, what constitutes crime, apprehension of criminals, searches and seizures, and laws of evidence.

The books is modeled to a great extent on a manual presently in use by the Eugene Police Department, which is also a compilation of several other manuals.

All sections dealing with law were written in conjunction with the Salem city attorney's office. Warren said, with explanatory information added by that department and the police department.

Warren said the manual will be used in all police training classes and will also be issued to members of the Salem police reserves.




