Court Slices Damage Award By \$24,000

The State Supreme Court, with two justices dissenting, Wednesday reduced from \$65,000 to \$41,000 a judgment of the Douglas County Circuit Court in a personal damage suit brought by R. K. Shelton against Frank V. Lowell and Los Angeles-Seattle Motor Express. The majority opinion was written by Justice Earl C. Latourette with Justices George Rossman and Hall S. Lusk dissenting. Rossman and Lusk contended the proceeding should go back to the circuit court for retrial.

The plaintiff, who suffered serious injuries, was 44 at the time of the accident. The court record showed, however, his earnings from his business had increased from \$500 to \$700 a month since the accident.

"In view of plaintiff's increased earning capacity his earning ability was not entirely impaired," Justice Latourette wrote. "Under the mortality table of which we take judicial notice, plaintiff has a life expectancy of 25 years, but it cannot be reasonably assumed he would continue to earn his present salary over that period of time."

"We could safely say, however, that in the course of ordinary events it would extend over a period of 10 years and amount to \$24,000. Deducting this from \$65,000 allowed by the jury would leave \$41,000 which we assess as general damages, in addition to \$2,031.45 as special damages."

First Citizen Selection Due

Salem Chamber of Commerce again will select a Salem First Citizen of the year.

Officials said Thursday a committee of representative citizens is working on the selection which will be kept a surprise until formal presentation of the award at a banquet in January.

Charles A. Sprague was first citizen year before last when the chamber inaugurated the project, and Robert L. Elfstrom last year.

Origin of the fire was not determined.

The two spent the night with friends in the hills. All of their possessions other than the clothing they were wearing and the car the father was driving were destroyed, Fowler told Silverton police.
