

# China Challenged To Reveal Names Of Held Students

WASHINGTON (AP) — The United States was reported Friday to have challenged Red China to name names and be otherwise specific in its charges about U. S. detention of Chinese students.

This became known as the Nationalist Chinese issued a statement decrying Red Chinese efforts

to deal with the United States on the student issue. The Nationalists called it a sinister maneuver to win some sort of diplomatic recognition for the Peiping regime.

U. Alexis Johnson, U. S. representative at the ambassadorial talks with Red China in Geneva, is understood to have made the demand for case-by-case information.

Red China's Premier Chou En-Lai made his double pitch last weekend. In a speech at Peiping Chou said there are "a great many overseas Chinese in the United States, among whom students alone number several thousands."

He also suggested that, since there was no U. S.-Red China diplomatic relationship, a third country should be called in to handle "the task of looking after the affairs of its civilians in the other country," particularly repatriation.

Thus, Chou was asserting a claim to an interest in all the Chinese in the United States. Further he was completely bypassing the diplomatic missions of Nationalist China which are recognized by the U. S. government as the agency in such matters.

By asking Red China at the Geneva meeting, now in recess until Monday, to name names and provide specific data, the United States got around both of these.

Johnson avoided dealing with the principle of what government acted for the Chinese—which is to say the principle of diplomatic recognition—and confined the repatriation question to individual cases, each to be handled on its merits.

## Police Fear Kansas City Wife Slain

KANSAS CITY (AP) — Mysterious disappearance of the pretty young wife of a wealthy automobile dealer followed within 14 hours by discovery of her bloodstained automobile and clothing Friday set police hunting for her body.

Maj. Eugene Pond, chief of detectives, said 24-year-old Mrs. Wilma Allen, mother of two small boys, apparently had been kidnapped, forced to drive to an isolated spot and slain in a brutal attack.

The attractive brunette was last seen at noon Thursday, leaving a beauty shop where she had received a hair set and manicure in preparation for dining out with her husband, William R. (Bill) Allen Jr., operator of one of Kansas City's larger Chevrolet agencies.

Mrs. Allen's 1955 blue and white convertible, locked and undamaged was found by a patrolman in a parking area near the Union Station off one of the city's busiest thoroughfares at 2:10 a. m.

The rear seat of the car, partially pulled out, and the floor were drenched with a great quantity of blood. Stuffed into the car's trunk compartment, and also blood-smeared, were the blouse, skirt, shoes and underclothing Mrs. Allen had been wearing when last seen.

The death youth was identified as Lawrence F. Andriani, 34, a San Francisco, police said Andriani was driving home three other University of Santa Clara ROTC students, following a training camp at Fort Lewis, Wash.

The three passengers and their injuries: Robert Besozzi, 34, a San Francisco, broken nose; Paul Conrado, San Francisco, pelvic fracture, and Wilbur Gookasian, Merced, Calif., head injury.

Police said the other car was driven by Clive M. Hartzog of Long Island, Kan., who received a neck injury. His wife suffered a broken wrist and their 19-year-old daughter, Bernice, was treated for a sprained ankle and cuts.

Gookasian was hospitalized at Vancouver, Wash., and the other injured were taken to a hospital in nearby Longview, Wash.

Hillcrest Girls Hear Smoking Safety Talk — Hillcrest school girls, the older of whom will next week be allowed to smoke, Friday were visited by two Salem fire officials who urged the girls to acquire safe smoking habits if they smoke.

Long-Time Fugitive Gets Quick Release — FT. BRAGG, Calif. (AP) — "I never expected anything to happen like this — so fast!" fisherman Both R. White exclaimed Friday.

He referred to his overnight stay in jail — as a fugitive from Washington State Reformatory 22 years ago — and his sudden release Friday.

White, father of three children and widely respected in this Northern California fishing community, was taken into custody Thursday.

A routine fingerprint check when he purchased a small gun to shoot sharks caught in his fishing nets, identified him as the escapee.

Sheriff Reno Bartolome said White had walked away from the reformatory — where he was serving a 1½ to 15-year sentence for second degree burglary in 1933, when he was 18.

Bartolome said he received a telegram Friday from H. J. Spidier, superintendent of the reformatory, that "legal technicalities make it impossible to take (him) at this time."

The sheriff said there might be further correspondence on the matter, or the case might be dropped.

Several hundred townspeople had signed a petition asking that White's extradition to Washington be denied. Spokesmen said that if extradition was pressed they would present the petitions to Gov. Goodwin J. Knight.

White was a resident of Portland when he was arrested at Liljehat, Wash., Nov. 29, 1933.

## Widowed Mother Once Commie, Man Denied Naval Commission

KINGS POINT, N. Y. (AP) — A 21-year-old midshipman was graduated Friday with second highest honors in his class at the U. S. Merchant Marine Academy. But he was denied a naval reserve commission because his widowed mother once was a Communist.

"I wish they'd punish me instead of him," the other said.

Cadet Eugene Landy, a handsome athlete and would-be lawyer, stood with the rest of his class in dress white uniform as the ensign's oath was administered. But his hand was not raised. He took no oath.

He has a six months period during which he may reapply for the commission. He said he would do so.

Landy's own loyalty was not questioned. The Navy merely said he was "extremely close to his mother and she has been a Communist."

The mother, Mrs. Deborah Landy, 54, of Bradley Beach, N. J., said her son talked her into quitting the party about 1947 after she had been a member for 10 years. She added:

## Canada Police Officer Found Shot to Death

VANCOUVER, B. C. (AP) — A police superintendent was found shot to death in his home Friday — the second policeman shot in six weeks by his own gun.

The dead man was Harry Whelan, 51, who had been scheduled to appear a few hours later before a royal commission investigating charges of corruption and graft in the Vancouver police force.

Mrs. Whelan said her husband had been restless all Thursday night after receiving a "mysterious" telephone call.

Mrs. Whelan said she was in her bedroom and heard a shot. She found her husband lying on the Chesterfield, his service revolver beside him and a bullet wound in his chest.

Whelan stood up and then collapsed. He died on the way to a hospital.

Supt. Whelan's death followed six weeks exactly the shooting attempt of Lt. Sgt. Len Cuthbert who left with Whelan a confession of accepting bribes from bookmakers.

Cuthbert recovered and has testified to the commission he shared payoff money with Police Chief Walter Mulligan and other officers. Cuthbert's bid to end his life June 24 was followed by appointment of the commission.

A brother of the police superintendent, Jack Whelan promised to avenge his brother.

"I'll talk for my dead brother," sobbed Jack Whelan.

"My brother left me with a job to do and I'm going to do it."

"He had a lot to tell and believe me, had he told it, it would have blown things wide open."

"But I will tell it. I will take the stand and tell it all."
