The Jefferson Lions, who have won nine games in nine starts this season, six of which have been in the Marion County B League, take on another tough opponent tonight as the circuit rolls forth with another full round of five contests.

That listing represented a big change in one week. North Carolina, fifth last week, lost to Wake Forest; George Washington, formerly seventh, was beaten by Maryland and Richmond and wound up in 14th place. Iowa State, No. 8 a week ago, lost to Kansas State and fell to 15th place.

Duke, on the strength of its 65-53 decision over North Carolina State, moved up from 11th place to sixth, but the experts couldn't overlook a loss to giant-killing Wake Forest earlier last week.

Ohio State made a big climb from 10th to seventh place merely by remaining idle for a week, after compiling an 8-1 record earlier.

Temple, another of the few remaining unbeaten major college teams, slipped into 10th place just ahead of Holy Cross. But the Owls, while running their string to eight straight, didn't find Lehigh and Scranton the kind of opposition that makes much impression on the experts.

Regional-National Plan . . .

Control of College TV Plan Asked by NCAA

LOS ANGELES (AP)—Continued control of college football television was recommended Monday by the TV committee of the National Collegiate Athletic Assn. (NCAA).

The report of the 1955 committee, headed by E. L. (Dick) Romney, commissioner of the Mountain States Conference, will be submitted to a full delegate session of the 50th annual NCAA convention Tuesday.

It suggests that the 1956 plan should embody many of the features used last fall—both national and regional telecasts of football games.

The 82-page Romney committee report termed the 1955 plan "quite successful." It urges its successor committee to give "careful consideration to the 1955 plan with the thought of embodying both regional and national features in some combination in the plan finally adopted" for 1956.

Last fall's program included eight games televised nationally and five regionally.

Discussion of the report Tuesday is expected to raise several questions. The Eastern and Midwestern sections of the nation reportedly are satisfied, basically with the 8-5 distribution. Several other sections, particularly the Pacific Coast, are expected to ask for more regional and less national games.

Included with the committee report was the seventh annual study by the National Opinion Research Center on television's effect on college football attendance. The study said overall attendance reflected "a modest rise" but still remained "below the pre-television peak."

Adverse Effect Noted
"Were the present limited television program to be replaced by wide open televising of major games, or by any other program which would substantially increase the number of top games available locally on TV screens, all evidence indicates a renewed adverse effect on attendance levels generally," the study stated.

Relations OK After Forfeit

LOS ANGELES (AP)—Southern California Basketball Coach Forrest Twogood told the Basketball Writers Assn. Monday that relations between the Trojans and the University of California players in last Saturday's forfeited game were good.

Referee Al Lightner forfeited the game to the Trojans with 3 minutes, 15 seconds to play, and Southern California leading 77-64.

Said Twogood: "I'd like to go on record now in saying there was no animosity between the players and I'd like to exonerate Pete Newell (California coach) from any blame in the incident."

"If all the rooting sections, including Southern California's, conduct themselves in the same manner as the boys out there playing the game, there'll never be any trouble."

Twogood said he agreed with Referee Lightner's decision "from an injury standpoint." He did not elaborate, however. California fans were throwing debris on the court when the forfeit was imposed.

(Continued from preceding page.) to the official scorer, "That's it, the game is over and is forfeited to Southern California."

There was no demonstration around the table or around either the Cal or USC bench. Players, coaches and officials started to depart for the dressing rooms in orderly fashion, although as much cannot be said for some of the fans. I don't know who were, or from which section of the pavilion they came. But some they did, and had it not been for the fast and efficient work of four Berkeley policemen, I have my doubts as to just what kind of physical shape I would have been in when (and if) I did get to the dressing room. It was an interesting trip, believe me, and it took some manhandling tactics by the gendarmes to keep it under way.

There Were No Protests—Just Questions

The dressing room was of course overrun with newspapermen, photographers, broadcasters (including Tom Harmon) and school officials. None were in protest of what had occurred. All wanted to know what had happened to cause the decision. I told them just as I have told it here. Whatever else has been said or printed is in error.

I put no blame on California officials, the rooting section or the band. I cannot prove the flying objects came from them. It has been said that kids were seen throwing stuff. That may be. But what kids I saw in action were busy picking up the pennies and putting them in their pockets. Which is quite normal for any youngster these days.

Among my post-game remarks to the press, which were few, was the statement that I had never heard of a Coast Conference game being declared forfeit in such manner, let alone be a part of it, and that it would never happen to me here (at California) again, as I would not work here again.

What repercussions will come of the development, I cannot say. Nor do I hazard a guess. The incident is in the hands of Conference Commissioner Vic Schmidt, who is gathering reports from officials, competent game observers and school officials.

As far as we're concerned, the next time someone wants to toss something onto a basketball floor we happen to be on, please make it a dollar bill. They don't hurt as much, and spend better.

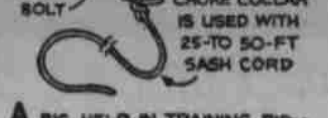

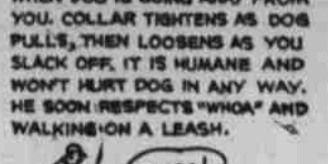

Helfand Orders Charges Filed Against London Sporting Club

NEW YORK (AP)—Julius Helfand, chairman of the New York State Athletic Commission, ordered his counsel to file charges against the London night fight promoters at St. Nicholas Arena Monday as he reaped additional rewards for his victory over the Boxing Guild of New York.

Although Helfand approved a Jan. 16 match for St. Nick's, he said he had instructed that charges be pressed against promoters Tex Sullivan and Willie Gilzberg and their London Sporting Club "on the Maryland situation and other matters."

Helfand said last Thursday he intended to call a hearing to find out if Sullivan and Gilzberg violated the law forbidding association with known criminals when they sought to transfer their operations from New York to Baltimore, effective Jan. 23.

The Baltimore deal was nullified when Maryland Gov. McKeldin asked his commission to revoke its permission.
