

### Delay of Third Polio Shot To Stretch Supply Okehed

WASHINGTON — The Public Health Service Monday approved postponement of the third Salk anti-polio vaccine shot as a means of stretching the supply.

The purpose would be to provide some protection with first and second injections to as many persons as possible by the start of the polio season this summer. The supply at this time does not cover demands by state health authorities and private physicians for that purpose.

Spreading the available supply among more people by postponing the third shot is the second recent step aimed at giving protection to as many as possible by summer.

Series of Conferences Secretary of Welfare Folsom last week completed a series of separate conferences with presidents of five manufacturing companies planning to supply vaccine this year.

Three Shots Ideal The health service said in a statement that it regards the recommended course of three injections as ideal under ideal conditions, but that it would not object to postponement of the third shot where local conditions seem to indicate

that it would be wise. The recommended course is one dose of one cubic centimeter, followed in four to six weeks or as soon thereafter as possible by another dose of the same size. A third or booster shot is recommended at an interval of seven months or longer after the second injection.

### Russia May Join World Church Board

MOSCOW — Conferences here between U.S. Protestant churchmen and leaders of the Russian Orthodox Church may lead to Russian membership in the World Council of Churches, an American said Monday.

The Rt. Rev. Henry Knox Sherrill of Greenwich, Conn.; presiding bishop of the Protestant Episcopal Church, explained at a news conference that the 10-man American delegation which arrived Sunday is not authorized to discuss World Council affairs, but the talks might pave the way for the Russian church to affiliate with the world organization.

Dr. Eugene Carson Blake of Philadelphia, president of the U.S. National Council of Churches, told the same news conference the American churchmen came here seeking to open channels of communications between churches in the United States and the Soviet Union and that they hope for even broader results.

"If Christians cannot talk to each other, who can?" he asked. His group's discussions with Russian clergymen during the next two days, Blake said, will cover "the two most critical items on our agenda—what the churches of the two countries have done and are doing to promote world peace and the freedom of churches to fulfill their missions in each country."

### Pretty Yank Milkmaid Aids U.S. Abroad

WASHINGTON — One of this nation's youngest and prettiest diplomats has just signed up for another hitch of foreign service. Ruth Marie Peterson, a 20-year-old farm girl from Lansing, Minn., who is the American Dairy Princess, represented this country in a dairy exhibit at the International Trade Show in Bogota, Colombia, last fall. And she will repeat as U. S. milkmaid in a similar trade show in Osaka, Japan, in April.

"She did such good job in Bogota," A. E. Johnson of the Agriculture Department said Monday, "that right away we began thinking of something bigger and more important for her. Japan, with its fine market for our products, is it."

Johnson thinks few of our diplomats do a better job. "They couldn't have picked a finer girl for dairy princess if they combed the whole country," Johnson said. "She's responsible, and she never forgot the job she went down there for — to represent the American dairy industry."

"Why, she even drank milk when she was not supposed to."

"Responsible" and "diplomatic" are hardly the first words that come to mind when one meets Ruth Marie.

"She's cute and friendly and vivacious, and if she is the result of steady milk drinking then the cow must be the beauty queen's best friend."

### 4 Cons Get Extra Year

Four inmates of Oregon State Penitentiary got an extra year added to their sentences Monday after appearing before Circuit Court Judge George Duncan.

Three of the men are former escapees, while the fourth is a probation violator. Laverl Fred Bowles escaped April 30, 1932, Earl Buckley on May 20, 1934, and James Baker Walker on Aug. 15, 1932. They all committed crimes after their escapes and served time in other prisons before being returned to serve out their Oregon sentences.

Robert Sharpe, violated his probation on an earlier conviction for forgery, and has now added another year to the two years he is already serving.

### Larceny Charge Jails Dallas Man

DALLAS, Ore. — James W. Ruth, 21-year-old Dallas man, was sentenced to 90 days in the Polk County jail Monday after pleading guilty to a charge of petty larceny in justice court here. Sixty days of the sentence was suspended.

Ruth was apprehended last week by Dallas police who said they found him in a Dallas bookstore looking at Easter cards at 4:30 in the morning.

### Morse Plans Bill to Better Forest Roads

WASHINGTON — Sen. Morse (D-Ore) said Monday he will introduce a bill to provide a 13-year, \$72 million dollar program for improving access road facilities in National forests.

The measure also would set up a 3 million dollar revolving fund to permit access roads on Indian timber lands, Morse said. The money would be repayable from timber revenues.

Contracts for mainline roads would be let to private contractors.

Morse asked Congress to authorize 32 million dollars for these forest roads in the year ending June 30, 1938. This would be raised to 40 million the next year and 50 million in each of the succeeding 10 years.

Morse told the Senate that timber access roads "are the key to not only profitable, but also to sound management of public timber."

Sens. Neuberger (D-Ore), Jackson (D-Wash) and Magnuson (D-Wash) were listed among co-sponsors of the proposal.

### Salem Boy Badly Hurt In California

Lance Stettler, nine-year-old Salem boy, suffered serious head injuries Saturday when struck by a car while visiting at San Diego, Calif. He is the son of Mr. and Mrs. John Stettler Jr., 970 N. 18th St.

The boy, a second-grader at Englewood School, reportedly has been unconscious in a San Diego hospital since the accident, which resulted in a skull fracture, lacerations and an eye injury.

Young Stettler, whose father is a captain at East Salem fire station here, was said to be visiting in the southland with his mother at time of the accident. The father left Sunday for his son's bedside.

### Bank Posse Jumps In Size, Looks for \$1 Million Note

### New 'Honest Elections' Bill Backed

WASHINGTON — Sen. Lyndon B. Johnson (D-Tex.), announced Monday night 83 senators now have joined in sponsoring what he termed a new "honest elections" bill. He urged its early passage.

He said he has asked Sen. Green (D-Ill.), Senate Rules Committee chairman, to expedite that group's consideration of the measure.

"To obtain early action," he said in a Senate speech, "we may have to delete temporarily from the bill those sections which would allow income tax deductions for political contributions. This type of legislation must originate in the House."

He said he intends to "press for enactment" of such a provision, but that "I would not object to a temporary postponement of Senate action" on it if this would speed consideration of the measure as a whole.

Johnson announced nine more senators have signed the measure as co-sponsors, bringing the total to 83. The new signers, he said, are Sens. Hill (D-Ala.), Aiken and Flanders (R-Vt.), Dworshak (R-Idaho), Millikin (R-Colo.), Mundt (R-SD), Purtell (R-Conn.), Schoepel (R-Kan.) and Watkins (R-Utah).

### Court Martial Rule on Army Wives Due

WASHINGTON — The Supreme Court Monday agreed to rule whether wives and other civilians who accompany military men abroad are subject to court martial.

The high tribunal accepted appeals in two cases.

In one Mrs. Dorothy Krueger Smith, who killed her army colonel husband in Japan, is seeking release from the federal reformatory for women at Alderson, W. Va.

She was sentenced to life for plunging a knife into her sleeping husband, Col. Aubrey D. Smith, 45, on Oct. 4, 1932 when they were living in Tokyo. Mrs. Smith is the daughter of Gen. Walter Krueger, now retired.

The second appeal was filed by the government seeking to overturn a decision by U.S. District Judge Edward A. Tamm here in the case of Mrs. Clarice B. Covert who was convicted by an Air Force court martial in England for the ax murder of her husband, Master Sgt. Edward E. Covert.

Mrs. Covert, 35, and formerly of Augusta, Ga., also had received a life sentence. However, her conviction was reversed on a technicality by the U.S. Court of Military Appeals here and she was awaiting a second military trial at Bolling Air Force Base here when Tamm ordered her release. Tamm said civilians accused of crimes were entitled, under the U.S. Constitution, to trial by civilian courts.

### New Business Expansion Forecast Due

WASHINGTON — Government agencies Monday were reported about ready to release a new business expansion forecast indicating that business men are betting heavily on continued prosperity.

The new forecast, officials familiar with it said, will report that business men have recently stepped up their plans for outlays on new plant and equipment this year. The most recent previous report indicated this spending would be at an annual rate of about 31 1/2 billion dollars for the first quarter.

An upward revision in the planning tempo would be welcome economic news. Downturns in two other major economic sectors—auto production and home building—have made plant and equipment spending a major sustaining factor.

Business expansion soaks up much of the same basic output that the auto and home building industries use—steel and other metals, plastics and rubber, cement, machine tools, lumber and the like. Consequently, an upturn in plans for new business plant and equipment would help take up slack and tend to halt the spread of unemployment.

It would also have the further effect of registering a vote of confidence in continued prosperity. This psychological impact could be important, since plant and equipment spending plans have in the past been highly sensitive to economic trends.

### Reedsport Firm Loses Labor Case

WASHINGTON — The National Labor Relations Board Monday dismissed unfair labor charges filed by Fircchau Bros. Logging Co. of Reedsport, Ore., against the International Woodworkers of America.

The charges were an outgrowth of a labor dispute. Henry J. Fircchau Jr. contended that the union and its agent, William Harris, had induced employees of the Reedsport mill of the Long-Bell Lumber Co. to refuse to process logs delivered to Long-Bell by Fircchau in violation of the National Labor Relations act.

The union, which had attempted to organize the Fircchau operation, declared that logs from the firm were "unfair" and members voted not to handle them. This was permitted under the so-called "hot cargo" clause of the union's contract with Long-Bell.

A hearing on the case was held at Reedsport and trial examiner Howard Meyers found in a preliminary conclusion last June that Fircchau's charges had not been sustained.

Subsequently, Fircchau filed exceptions to the intermediate report. But the board Monday, after a review of the case, found that evidence was not substantial enough to support a finding of an unfair labor practice.

### Insurance Firm Claims Theft Money

ALBANY, Ore.—The insurance company which paid Linn County's \$8,001 loss in the Jan. 17 holdup of the county treasurer's office laid claim Monday to all money recovered from the robbery.

Sheriff George K. Miller and two men accused of the robbery are named as defendants in the suit filed in Linn County Circuit Court by Hartford Accident Indemnity Co.

The complaint says the sheriff holds \$1,876.69 found when Harvey Roberts, also known as Robert Roberts, was arrested at Coos Bay the day after the holdup. Miller said he cannot give the money to the insurance company unless ordered by the court.

Roberts and Ernest L. Gibson, arrested in Coos Bay two days after the crime, are awaiting trial. The rest of the \$8,001 reported lost, has not been found.
