WOODBURN—Funeral services for Charles I. Black, Eugene, will be held at 2 p.m. Tuesday at the Ringo-Cornwell funeral home.

Black died Saturday morning in Eugene following a heart attack. He was 45.

Black resided in Woodburn from about 1925 until 1942. He worked for the State Highway Department here for about eight years.

He was born in Bayfield, Colo., April 10, 1911. He was employed as a construction worker in the Eugene area at the time of his death. Black was a veteran of World War II.

Former Salem Resident Dies

Word has been received here of the death of Dr. Arthur V. Hollenberg, Morris Plains, N. J., a former resident of Salem.

Hollenberg, who died Saturday, is the son of Mr. R. V. Hollenberg, Salem.

Hollenberg was born in Corvallis May 21, 1910. He came to Salem with his parents in 1919 and attended public schools here. He graduated from Willamette University in 1931.

He entered New York University in the fall of 1931 on a teaching fellowship in the school of physics and received his Ph.D. from that institution in 1938.

Hollenberg taught in Queens College, New York, from 1938 to 1942. During the war years he was engaged in government scientific work as a member of the Manhattan Project.

In 1946 he became an employee of the Bell Telephone Laboratories and remained with the company until his death.

Survivors in addition to his father include his widow, Jane, a daughter, Virginia, 15; a son, Richard, 19; and an uncle, Dr. J. H. Belknap, Denver, Colo.

Light Vote Seen for Primary Election

Oregon's Primary election campaign, which began with all the fury of a mid-winter hurricane and then died down to a balmy spring whisper, heads into its final week today with no forecast of new political storms.

Two major campaigns, one in each party, have failed to fan any enthusiasm among the state's voters and indications five days before Friday's balloting were for a light vote. A drop in registration over the two previous elections gave support to the feeling among political seers that vote counts would be below the elections of 1952 and 1954.

Senate Race
Douglas McKay, former Oregon governor who resigned as secretary of the interior in a final-hour decision to run for the Senate, and his opponent Philip Hitchcock, one-time state senator and church leader, continued to run against Incumbent Wayne Morse instead of one another in their bid for the Republican nomination.

Hitchcock continued to base his bid "on a defensible record" in one of the most ambitious barnstorming campaigns the state has seen. McKay, also an energetic campaigner, has placed emphasis on "proven service" in seeking the chance to oppose his one-time political com-patriot Wayne Morse in November.

Edge Claimed
McKay, who inherited the old Snell machine to carry him into the governorship, had picked it up again after his surprise return from Washington. Ten days before the election his campaign headquarters was claiming a 2 to 1 edge over Hitchcock who had quickly gathered a sizable statewide organization of his own.

Hitchcock on the other hand was building a lead of state newspapers in editorial support. Five major dailies had endorsed the Lewis and Clark College faculty member to three for McKay. A poll of weekly papers indicated about an even split between the two candidates.

Democratic Race
On the Democratic side, two aspirants for the party presidential nomination were doing their best to drum up write-in votes.

Adlai Stevenson, 1952 banner bearer, will visit Woodburn, Salem and Lebanon Monday in the mid-valley swing of his three-day election week campaign of Oregon. He'll be followed two days later by Sen. Estes Kefauver who has 21 Oregon cities including Woodburn and Salem on his two-day itinerary. Both will speak from the courthouse steps.

Local political interest remained at an all-time low with chief activity centering around a six-way race for the Marion County District attorney nomination and the county's four seats in the House. Democrats have launched a write-in campaign for

Cecil Farnes, Steve Anderson and Sheila Laue in a plan aimed chiefly at bolstering the November chances of Guy Jones, the only officially filed candidate for the post.

Farnes is a Salem radio and hi-fi dealer who sought a state senate seat in 1954; Anderson, a one-time state chairman of the Young Republicans who switched parties four years ago along with
