Canadian Pro Grid Game Friday

For the first time as the Pacific Coast football season is about to begin, the Canadian Pro Grid Game will be played in Canada by the three major Canadian champions, the Edmonton Eskimos and the B.C. Lions from Vancouver, B.C. The game is scheduled for Friday night, Aug. 2nd, at 8:30 p.m. in the Muttart Stadium, Portland.

The nucleus of all Canadian teams are made up of brilliant ex-All American college stars, some with previous experience as American professional players. The higher salary scale in Canadian professional football attracts the cream of the crop of college graduates when they have not already been committed to some U. S. team.

The game from a spectator viewpoint is faster paced and generally considered more exciting than the American game for many reasons. The five man backfield can be in motion in any direction, resulting in some fantastic deception with the ball on split T and "Belly" series plays. With only 3 downs to make 10 yards, the quarterback is working harder all of the time to advance the ball. The Canadian field of 10 yards wider and 10 yards longer than U. S. soccer, tends toward a more wide open style of football. "No fair catch rule" results in the punt receiver having to run the ball back. The rules do not allow him to have any interference but he must be at least 5 yards away when he receives the ball.

In Canadian football, if a runner is tackled in the end zone after receiving a punt behind his own goal line, one point is scored and the ball is put in play. (By the way, the Eskimos scored against the Lions in the 1957 game.) The same rule applies to a kicked ball rolling out over the deadline behind the 25 yard end zone. But if the kick goes over the deadline on the fly—

then providing an opportunity for the defending team to run it out—the ball is brought out and put into play on the scored-on team's 40 yard line, rather than the 25.

The advantage of the "Range" as an offensive weapon is that it greatly reduces the number of the games. If a team gets in a close but can't break through for a touchdown, a quarterback can at least call in his kicker and go for the single point shot setting up an exciting duel between the kicker and the enemy safety man. If the safety is in a game, it is his insurance point against the game. Canadians are rabid football fans and the annual Grey Cup game for the professional football championship creates a fervor equivalent to what one might expect if the North and South fought the Civil War each year. Regional pride of teams has developed an intensity never noticeable to the extremes as in Canada. The reason for this is the fact that the spectators of the fast paced Canadian game.
