Dedicated formally on July 25, Rooster Rock State Park has been attracting thousands a week. The park is located on the Columbia River, 25 miles east of the center of Portland, and offers boating and picnicking, in addition to bathing. It is the newest of the state parks and possesses 835 acres.



This odd rock is found at Fogarty Creek State Park on the Pacific Ocean, 75 miles from Salem. The area is one of the two newest state parks and has been drawing substantial crowds in recent months. Improvements for nearby parking and cooking were installed in June. The lone tree atop the rock has survived years of roaring surf and


