### Survey to Find Number of TV Sets in Homes

How many homes have television sets is a question the U. S. Bureau aims to determine in January population survey.  
A similar survey conducted in April of last year showed four out of five American homes contained one or more TV sets.  
Census officials said first survey of this type made in 1950 showed 12 per cent ownership of sets. In June, 1955, the figure had jumped to 67 per cent, it was 73 per cent in February, 1956, climbed to 76 per cent in August, 1956, and hit 80 per cent in April, 1957.  
Information for the latest survey will be collected in the Salem area by census worker Opal Nieswander, Salem, and working the Albany sector will be Mary McCubg.

### Court Upholds Tenant's Right Of Privacy

(Editor's note: Basic legal principles are set forth in this exclusive every-Monday series, "Know the Law," put out as a public service by the Willamette University College of Law. Purpose is not to give legal advice as such. Facts and situations vary and readers are cautioned not to apply law to any particular problem without consulting an attorney.)  
A few years ago a landlord ordered his tenants, a man and wife, to move. Their rent had been paid and they refused to get out. The landlord and his wife moved into the small living room of the leased home and remained there "interfering with tenants' home life and offending tenants' sensibilities" for a period of 17 days. The landlord had to pay damages for this invasion of the tenants' right of privacy, for the courts feel that the individual should be protected from unauthorized invasion of his private affairs.  
The courts also feel that the individual should be let alone in the conduct of his personal business. Such was not the case when a business man put a placard in his store window stating that "Dr. M. (who later complained) owes an account here of \$95.67 and it promises would pay account, this account would have been settled long ago."  
In another situation a 10-year-old girl's picture was taken as she lay in the street after having been struck by an automobile. Almost two years later a magazine published the picture to illustrate an article on the negligence of children entitled "They Ask to Be Killed." This, too, was an unwarranted invasion of her privacy.  
A movie company circulated a letter that appeared to have been signed by a lady, designated as Miss K. In advertising a movie, the letter cast doubt on Miss K's moral character. The court said her right of privacy had been invaded.  
A person can, of course, give his consent by implication, if not expressly, to be photographed and the photograph later used. If a man attends a baseball game and sits in the stands he certainly could not rightfully complain when a picture of the crowd, including him, is taken and later published.  
Many events are newsworthy in their nature and such news value often overrides the tender feelings of the individual. This is especially true where public figures such as politicians, explorers and athletes are involved.  
However, the right of privacy, of being left alone, is a very real right. In most states, if that right is violated without cause, it may be vindicated by civil action.

### Marketing School for Farmers Planned by Yamhill County Agent

McMINNVILLE, Jan. 12—That there is something "that smells" in the farm marketing situation was the indication of Louie H. Gross, Yamhill County extension agent in an interview today.  
"It appears to me that there is something behind the market that some of us do not understand, when with a large crop the price is higher than with a small crop," Gross said. He plans a marketing school to aid farmers.  
The remark grew out of a recent fruit and nut crop market review from Oregon State College economists who wrote that "Adverse weather during the growing season hurt this past year's state peach and prune crops. Nearly 11,000 tons of peaches were harvested or one-fourth less than in 1956. Production of some 22,000 tons of prunes was a little over half as large as the year before. Prunes not harvested because of low prices are indicated in the production estimate. About 5,000 tons were reported abandoned in Western Oregon."  
In 1957 prunes sold to the processor for around \$25 to \$40 a ton on the average. The year previous, when the crop was much larger, the price was approximately \$5 a ton more.  
"We think this information gives us good reason to conduct a marketing school for farmers here in the Willamette Valley," Gross said.  
He added that "there are other

factors entering into this picture which makes it even more confusing to us. In the 1957 year the size of prunes was large. This, in our opinion makes them a higher grade than the 1956 prunes which were of average size."  
Gross said that occasionally he found the same type of "marketing" happening in other crops and he believed the best way to overcome this is "for us farmers to be well informed about markets and market conditions." He said he believed that the farmers can help themselves to a higher price per ton if they furnish themselves with basic knowledge that is necessary to discuss selling the product to the buyers.  
"I think it is only human that when someone else sets the price and pays you what they desire that they are not going to pay the maximum that could be paid for the crop. None of us is going to pay more for anything we buy than we have to. If someone asks you what you'll pay for something, you aren't going to tell them the maximum right off the bat. None of us is built that way—not even fruit buyers," Gross pointed out.  
Gross has lost no time. He has set Jan. 23 for the first night of the Yamhill County marketing school. This will be followed through with three succeeding Thursday night meetings.
