

Compromise Made in Tax Deficiency Suit

PORTLAND 4P - The government Tuesday accepted a one-third compromise figure in a \$2,300,000 income tax deficiency it claimed was owed by the estate of Seattle lumberman Charles Ward Stinson.

Government attorneys and the estate told U. S. Tax Court Judge Bruce Forester they had agreed on \$800,000 as the assessment. The Internal Revenue Service had placed a \$700 a share value on 65,000 shares of Stinson Lumber Co. stock. The estate had said the stock was valued at \$190 a share. Later both parties agreed on a stock value of \$125 a share.

Portland Man Dies After Car Crash

PORTLAND 4P - A 73-year-old Portland man died here Tuesday of injuries suffered when his car collided with another vehicle Monday.

He was Herman Hawkins, whose death pushed Oregon's 1958 traffic toll to 63 persons. Seven have died this month.
