

Counties Must Bear Cost of Cattle Tests

The 1945 law providing for the eradication and control of communicable diseases of cattle makes it mandatory on counties to provide funds for testing of cattle, Attorney General George Neuner ruled Monday for Director E. L. Peterson of the state department of agriculture.

Neuner held that if counties fail to appoint veterinarians, the testing should be done by the department of agriculture, but with the cost still to be borne by the counties.

The state department of agriculture, Neuner continued, may enter into agreements with the federal department of agriculture to have the testing done, but the counties cannot make such agreements. If the government consents to perform and pay for the testing, then the counties would be relieved of paying for it.

Neuner also ruled that no county veterinarian may be appointed without first having been approved by the state department of agriculture. He further held that the owner of a diseased animal must slaughter it if he is paid his indemnity, but if he does not get his indemnity, then he doesn't have to slaughter.

Anderson, Des Moines, Iowa, Ray Anderson, N. York, Harold Anderson, Seattle; two sisters, Mrs. Morris Hunt, Salem, and Mrs. Christine Ackley, Portland, and two grandchildren.

Typographical Rates Raised

PORTLAND, Ore., Jan. 7.—(AP)—Secretary A. R. Clayton reported today the typographical union had accepted daily boosts of \$2.15 for day work and \$2.40 for nights on Portland newspapers.

Based on 7 1/4 hours, the increases will put daily pay at \$12.50 for day and \$13.25 for night work, he said. The agreement was a counter-offer made by publishers during negotiations, Clayton stated, and is effective as of Dec. 31—expiration date of the old contract.

Application for Dennis Prison Term on File

Formal application for commutation of the death sentence to life imprisonment in the case of Andrew Dennis, convicted of first-degree murder for the slaying of his mother-in-law, Mrs. Anna Belle McNealley, in a Portland apartment house in January 1944, was filed with Gov. Earl Snell Monday. A copy of the application was referred to the state board of parole and probation.

Dennis is scheduled to die in the lethal gas chamber at the state penitentiary later this month. A previous death sentence was set aside by the state supreme court because Judge Martin Hawkins, Multnomah county circuit court, failed to issue a death warrant. Dennis was re-sentenced recently.

Sponsors of the application indicated that they would rely largely on letters received at the executive department from Judge Hawkins and James R. Bain, Multnomah county district attorney at the time Dennis was prosecuted.
