REYNOLDS TO MAKE BUST OF SHOWMAN

Jack Reynolds, Eugene sculptor, has been commissioned to "do" a bust of Calvin Heilig, 75-year-old pioneer showman of Portland. Reynolds, a son of Mr. and Mrs. J. F. Reynolds, of Eugene, left Wednesday for Portland and will begin actual work on the piece Friday.

The bust will be cast in either bronze or stone. Reynolds first attracted Heilig's notice with a practice model of a friend which he made during leisure moments at the theater where he was employed. Reynolds recently modeled a statue of a kneeling woman which came in for a good deal of attention. He studied sculpturing at the University of Oregon.

Reynolds will be the guest of the veteran showman while in Portland and expects to have the piece done in two weeks. The bust will be life size and will be modelled in clay.

Slattery, and stated he would take charge of his own defense.

"That's entirely a voluntary matter," said the officer.

"I'm not casting any reflections on Mr. Johnston," said McAweeney. "But I believe I am in a position to conduct this defense better than he can. I want to do it that way."

Mr. Johnston, before retiring, said he wished to offer the motion for a directed verdict in behalf of the defendant, but McAweeney declined the offer.

"You will have to inform me as to the correct procedure to follow," said McAweeney, addressing the judge.

"I can't direct your defense," said Judge Skiptworth. "I am not running a law school."

Grills Witness

McAweeney then called A. V. Carlson, the state's chief witness, to the stand, and put him through a long grilling, dealing with Carlson's contacts with McAweeney as a supposed prospective buyer of his property at Central Point.

Judge Skiptworth at one time criticized McAweeney sharply, asserting that he was cross-examining his own witness and otherwise violating rules of procedure. When McAweeney said he was trying to follow the right method, the judge said:

"You made a mistake when you fired your attorney. It's poor policy to swap horses in the middle of the stream."

McAweeney then called other states witnesses as his own witness, including the arresting officers, and called for suitcases, golf bag, and other articles taken from the car in which he and John Berg, convicted bunco man, were arrested. The question of his defense was that he had nothing to do with whatever stock market or other dealings were going on, the state having sought to show that these operations were intended to bulk Carlson out of \$19,500. He tried on a coat in one of the suitcases to show that it did not fit him.

He sought to show that he had nothing to do with fake money found in one of the cases.

McAweeney, in addressing the jury after presenting defense evidence, asserted he had nothing to do with the bunco dealings, but happened to be along.

The tracing of the case of both McAweeney and John Berg, convicted last week of attempted bunco, and the final arrest was carried on by Joe Brown, deputy sheriff, in charge. Josephine county officers co-operated with Lane officials in the case and Deputy District Attorney Eugene V. Slattery carried on the prosecution in court.

NURSES' SCHOOL IS DISCONTINUED HERE

The nurses' training school at the Pacific Christian hospital was discontinued Monday of this week, and 28 students of the school were sent to other larger hospitals to complete their training.

Ten were sent to the Multnomah county hospital, 1 to the Salem general hospital, 10 to the St. Vincent hospital, Portland, and seven to the Good Samaritan hospital, Portland. Five more will be sent to St. Vincent's on Aug. 1.

The training school was discontinued here in line with a movement throughout the country to give the nurses opportunity of training in the larger hospitals, the local hospital staff announced.

All student nurses at the hospital are replaced by graduate nurses from the local school, the hospital has only graduate nurses from now on.

WASHINGTON, June 17.—(U.P.).—The Navy department was advised today that a marine gunner, Elmo Reagan, died today of injuries received when his training plane crashed late yesterday at the Pensacola, Fla., naval air station. Naval records list Reagan's home address as Overton, Tex.

PORTLAND, Ore., June 17.—(U.P.).—Elmo Reagan, marine gunner who was killed in an air crash at Pensacola, Fla., was a brother of E. M. Reagan of Portland, former publisher of the Albany, Ore., Herald.

Elmo Reagan was a resident of Portland before he enlisted in the naval air service in 1916. He was one of the first naval fliers to arrive in France in 1917.

His widow was the former Miss Nellie Cox of Eugene, a former student at the University of Oregon. They were married in Portland.

ed since Lincoln's death have written on the scroll of history changes bewildering in their variety, momentous in their consequences. They have broadened and enriched life beyond the imaginations of Lincoln's contemporaries. The years have not only yielded rich treasures, material and spiritual, but they have brought challenges to readjustment, both by government and individuals, to a changing world. Our country has become powerful among nations. It is charged with infinitely new responsibilities both at home and abroad.

"What a poet has called the endless adventure, the government of men, discloses new and changing human needs from generation to generation. As we scan our history even since his day, who can doubt Lincoln's own words that our national heritage is 'worth the keeping.'"

"And it was Lincoln who stated and restated in impressive terms that its foremost rests upon obedience and the enforcement of law. There can be no position or his influence, stands above the law. That the public cannot admit and still live. For ours is a ordered liberty safeguarded only by law."

"The eternal principles of truth, justice and right, never more clearly stated than by Lincoln, remain the solvent for the problems and perplexities of every age, and of our day. It is to those who, like Lincoln, have made these principles serve the needs of mankind that the world pays it homage. At his shrine we light the torch of our redemption to the love and ideals of the nation which he loved and served with the last full measure of devotion."
