

GARNER OUT FOR PROHIBITION LAW REPEAL

PROHIBITION IS LEADING ISSUE OF DEMOCRATS

Raskob Says Question To Figure Largely In 1932 Campaign

Warlords Of Democratic Party Arriving For Big Convention

CHICAGO, June 21.—(AP)—Prohibition was named as the outstanding issue of the 1932 presidential campaign today by Chairman John J. Raskob of the democratic national committee upon his arrival at convention headquarters.

He said any attempt to supplant Raskob would be a breach of good faith.

It drew an issue with Governor Roosevelt's forces who were backing Senator Walsh, of Montana, for the post.

No Choice Named

Raskob declined to name a choice for the presidential nomination. He declared repeal of the eighteenth amendment in favor of state control of liquor.

Among New Yorkers arriving here were Ray O'Sullivan, secretary of Tammany Hall and Eugene Conley, a member of the Tammany board of strategy. They said 1000 Tammany men would be in Chicago by Sunday night.

As for prohibition, Raskob said he was willing to leave the plank to the decision of the delegates. He has indicated repeal of the eighteenth amendment in favor of state control of liquor.

Two other warlords of the democratic party, ancient enemies of William F. Smith of New York, and Alfred G. McAdoo, of California—

Anniversary Of Lindy's Baby's Birth Sad One

ENGLEWOOD, N. J., June 21.—(AP)—Tomorrow is the second anniversary of the birth of Charles A. Lindbergh, Jr.

The little nursery in the Lindbergh home in the Soudland Hills is empty. His mother, awaiting birth of second child, will spend a sad anniversary with the colonel in the Englewood home of her mother, Mrs. Dwight W. Morrow.

It is Mrs. Lindbergh's birthday, too, the 20th. The joyful joint celebration that would have been held with the blue-eyed, curly-haired toddler explaining over his cake with two candles, has been snatched from the Lindberghs by the heartless kidnapping and murder of their child.

The announcement on June 22, 1932, that the child was born at the Morrow home here, went around the world and caused universal celebration.

The baby's first pictures, his first birthday, the news that he was learning to walk and talk, were followed everywhere with eager interest.

Then on March 1 the baby was torn from his crib in the Lindbergh home near Howpelt, never to be seen alive again.

The nightmare events of the next three months deepened the tragedy, which reached its climax when the body of the child was found in bushes near Jersey.

VETERANS' RANKS MAY BE REDUCED

WASHINGTON, June 21.—(AP)—Negotiations looking toward evacuation of the larger part of the war veterans in the capital seeking payment of their bonus certificates were initiated today by Falgout D. Glassford, Washington superintendent of police.

RUMOR SPREAD AMERICA WILL CANCEL DEBTS

Gibson's Statement About Armaments Gives Rise To Reports

U. S. MAKES DENIAL

Americans In Geneva Make Trip To Lausanne To See MacDonald

LAUSANNE, Switzerland, June 21.—(AP)—United States Ambassador Gibson's assertion at a conference with Premier Herriot that America will not consider cancellation of debts while Europe continues heavy armaments expenditures gave rise to reports here today that the United States has agreed to cancel if the armaments outlay is reduced.

This afternoon Mr. Gibson and Norman H. Davis, another member of the American disarmament delegation, came here from Geneva. The visit was regarded as highly significant in view of Mr. Gibson's conference with the French premier.

Messrs. Gibson and Davis were immediately admitted to the private quarters of Ramsay MacDonald, Britain's prime minister. Mr. MacDonald and Sir John Simon, the British foreign secretary, were having lunch when the visitors arrived.

The Americans broke a precedent when they hurried into Lausanne, but they remained with Messrs. MacDonald and Simon for a half hour. Mr. Simon accompanied them back to Geneva.

On leaving Mr. Davis said debts had not been discussed and that the visit "did not mean we have entered the financial field."

The reports, not entirely in line with the facts, coincided with an unusual stir of activity among the more prominent delegates to the conference on war debts and reparations.

The American proposal, the report said, was made at a dramatic midnight interview between Ambassador Hugh Gibson and Premier Herriot of France.

Experts here professed to see in the new developments a complete reversal of the American standpoint that there was no connection between war debts and disarmament, and consequently between the Lausanne and Geneva conferences. They hailed the Gibson-Herriot interview as linking the United States definitely with reparations problems.

JUMPS INTO BATTLE FOR PRESIDENCY

Speaker Declares He Voted Against Amendment In First Place

SPEECH IS KEYNOTE

Democratic Leaders Believe It Expresses Opinion Of Party

WASHINGTON, June 21.—(AP)—John N. Garner, speaker of the house, swung his politicalariat toward the democratic presidential nomination today with a statement urging repeal of the eighteenth amendment.

In a formal statement to newspapermen, the speaker said he had voted against the eighteenth amendment and added: "I have never believed it sound or workable and it should be repealed."

Claims Strength

He said California and Texas democrats are sending delegations to the Chicago convention "instructed to vote for my nomination for the presidency."

"This has been done without my solicitation," he continued. "I appreciate support of my friends and am willing to serve my country and my party to the limit of my capacity."

His statement follows in full: "Many of my friends, not only those residing in my own district and state, but throughout the country, have asked me repeatedly to express myself on various public questions."

"I have maintained the position I assumed when I was elected speaker of the house of representatives, that I would not indulge in the discussion of controversial issues not immediately under consideration by the house."

NEEDY WILL HELP CAN THEIR FOOD

Plan Evolved By Relief Groups To Use Lane's Surplus Products

A plan whereby the needy families of Lane county will be allowed to work to pay for some of the provisions supplied them during the depression has been evolved by the relief agencies of the county and announced Tuesday by Miss Mary Annin, executive secretary of the Lane county chapter of the American Red Cross.

Lane county each year grows an excess of fruits and vegetables over and above the amount sold or preserved by the growers, and especially in this year owing to the lack of market for the produce. It is the plan of the relief organizations to allow the members of the needy families to gather these fruits and vegetables, can them under the direction of persons who are familiar with the work and to pay for them they are to turn over to the county court one can out of every six given them.

In the rural districts the county will be divided into separate districts.

Salem May Borrow From Federal Fund

SALEM, Ore., June 21.—(AP)—Congress probably will pass legislation at this session to allow the reconstruction finance corporation to loan funds to government units on self-liquidating projects. United States Senator McNary notified City Attorney Trimble.

A plan has been proposed that the city of Salem borrow \$2,000,000 from the federal government to finance the proposed municipal water system approved by voters last year.

The county's stand on the matter, as explained by County Judge C. P. Barnard, is that with a two-mill tax levied for the elementary schools, only money collected from this tax should go to the schools. The county should not be forced to make other funds in order to make up the complete amount required by law to be sent to district schools as the elementary school fund, county officials decided Tuesday. It was decided to send out only the money already collected in taxes levied for this purpose on July 1 when the fund is due.

Under an opinion handed down by the state attorney general, a had been held that counties were bound by law to send out the elementary fund entire, making it mandatory upon the county to take money from other funds to make up the required amount which is \$51,709.59, due to be sent out July 1.

CASCADE AREAS TO BE CLOSED LATER

Three areas in the Cascade national forest will be closed during the hot fire season, it was announced Tuesday by Perry A. Thompson, supervisor of the Cascade forest.

The closing will probably be effective starting July 1, but if rains intervene between now and that time the closing date may be put off till July 15.

In the South Fork, the area lying between Walker creek and French Pete creek, about five miles of territory, will be closed. Fishermen and others going into the South Fork area will be required to obtain a permit to enter the closed area from a ranger stationed at the Walker creek lake. They will not be permitted to stay in the closed area and will be escorted through by another ranger at French Pete. Mr. Thompson said the Portland creek water shed will be closed during the hot fire season and the Western Lumber company timber sale area will be closed. The Fall creek area, closed last year, will probably not be closed this year, Thompson said.

EUGENE MEN SPEAK ON SCHOOL MERGER

COTTAGE GROVE, June 21.—(Special)—Edward F. Bailey and T. O. Russell of Eugene, of commerce, regular luncheon of the Cottage Grove chamber of commerce today at noon on the question of the proposed removal of the University of Oregon and Corvallis and the physical consolidation of the university and the state college. J. A. McLean, manager of the Osburn hotel, accompanied Mr. Bailey and Mr. Russell and headed the luncheon.

Mr. Bailey gave figures to refute the claims of the proponents of the bill, stating that the claims of saving to the state in the cost of operation of the two institutions if merged were ridiculous. He gave figures to show that the present cost of operating both the university and state college is lower than in any other state and to show that where two such institutions have been consolidated the cost was not reduced.

Mr. Russell, who is president of the Eugene chapter of commerce, pointed to the federal survey of the university and college which resulted in a recommendation against a physical merger of the colleges and university and advised that the people allow the state board of higher education to go ahead with his broad plan of developing the two institutions separately under one head and one management.

25 DEAD IN RIOTS IN CHILEAN CAPITAL

SANTIAGO, Chile, June 21.—(AP)—Rioting here caused 25 deaths and 75 injured in Santiago's streets today and a bakers' strike threatened to cut off the city's bread supply as the socialist government ordered strict martial law.

Groups of extremists attacked Carabineros stations in both Santiago and Valparaiso early today, causing reports of even more casualties.

Regular troops were sent to Valparaiso to aid the Carabineros.

United States Ambassador William S. Carrleton asked the government of Chile to provide greater protection for United States citizens and interests after 5,000 men went on strike at the Barden copper mines.

A mob stormed an arsenal on the outskirts of the city, but was repulsed. Serious rioting also occurred at Valparaiso.

WIMBLEDON, June 21.—(AP)—Henri Cochet, French tennis ace, and favorite to win the English singles title, was eliminated in the second round at Wimbledon today, falling before the flashy play of the Englishman, Ian G. Collins. The score was 4-2, 8-6, 0-6, 9-3.

RICHMOND, Va., June 21.—(AP)—Confederate veterans from throughout the southland moved into Richmond today to encamp with its advance guard of the gray-clad army which arrived in time to witness the dedication yesterday of the Petersburg national military park.
