

### T. J. SHERIDAN TO HEAD LABOR COUNCIL

New officers for the Eugene Central Labor Council were elected Wednesday evening as follows: T. J. Sheridan, carpenter, union, president; Charles Sullivan, hod-carriers and building laborers' union, vice-president; Van N. Kemery, cannery union, secretary; O. A. Richardson, letter carriers' union, W. R. Kinsey, plumbers' union, Roy Steen, butchers' union, trustees.

The council also endorsed the appointment of A. C. Dixon for the federal home loan bank board.

The group voted to have the secretary write C. H. Gram, labor commissioner, in protest against wages paid at the cannery of the Eugene Fruit Growers' association. According to Mr. Kemery, secretary of the labor group, 27 1/2 cents per hour was the amount listed by the labor commissioner for cannery workers, and the labor group says the local cannery is paying 22 1/2 cents an hour.

J. O. Holt, manager of the E. F. G., said, when the matter of the council's action was called to his attention, that he believed the wages paid here were in line with the results farmers are getting from their produce.

No report was made on the university-college consolidation matter at the labor group's meeting. W. R. Sallee is chairman of the committee which will report later. The next meeting of the council is to come on the first Wednesday of August.

Half Million Asked

Judge Barnard made application on behalf of Lane county for a federal loan of \$500,000 to be applied to construction of the Willamette highway east of Oakridge while in Portland Wednesday. It was not known yet whether Lane county will be able to get all or a portion of this amount since the purposes for which the money is available are not yet clear here. Judge Barnard hopes that some money will be available for this type of work so that the work could be started to relieve unemployment in this county. The loan would be obtained from the government under the newly approved federal relief bill, providing funds for federal road building.

Dr. E. R. Moon, a former resident of Eugene and now professor in the department of religious education at Butler university, Indianapolis, Ind., will speak at the First Christian church at the mid-week services Thursday at 7:30 o'clock.

Before going to Butler, Dr. Moon served for 12 years as a missionary in central Africa. During his first term he was located at Bohanga, where he had charge of the native schools. Later he established a new station at Mondombe and served as superintendent of that field for several years. He and his family are spending their vacation in Oregon and Washington.

#### Dr. Zook Has Been President of Akron University Since 1925

Dr. Zook has been president of Akron university since 1925. He is the author of various survey reports of higher educational institutions. He was born in Fort Scott, Kansas, in 1885, received his bachelor of arts and master of arts degrees at University of Kansas, and his degree of doctor of philosophy from Cornell in 1914.

Dr. Zook's educational career shows him to have been a fellow in European history at the University of Kansas; assistant in modern European history at Cornell; instructor in modern European history at Penn State; traveling fellow in Europe for Cornell, and professor in modern European history at Penn State.

#### He Was Associated with the Committee on Public Information of the Government in 1918 and After

He was associated with the committee on public information of the government in 1918 and after that was associate director of the section of educational institutions of the treasury department.

#### Just Prior to Going to Akron, Dr. Zook Was for Five Years Chief of the Division of Higher Education of the United States Bureau of Education

He has written several books, including "America at War," and "The Royal Adventurers Trading Into Africa."

Dr. Zook is a member of the American Historical association, of Phi Kappa Phi, of the University club, and is a communicant of the Methodist church.

#### On the charge of larceny carries a maximum sentence of ten years in prison.

In announcing that the complaint had been issued, Longley made the following statement:

"With the idea in mind of filing the present larceny charge, this office has

been for more than a week in close conference with Hector Macpherson and his associates who sponsored the consolidation measure.

"The crime of larceny, as every lawyer knows, includes several vital elements, besides the mere taking of property, and Mr. Macpherson and this office have at all times endeavored to proceed carefully in this matter, having in mind that it is a serious thing to file a criminal charge of this character against a man of this community."

"A careful examination of the evidence available convinces us that there is sufficient probable cause for the issuance of this warrant, and we intend to continue the investigation and prosecution as speedily and vigorously as possible."

The district attorney said further: "We can assure the public that the efforts of the police department and of this office will be unsparring to bring to light and prosecute any persons who may have operated invisibly and behind the scenes in this matter, and all others criminally implicated."

The complaint charges that on July 4 Brownell "did unlawfully and feloniously take, steal and carry away 200 sets of printed and signed initiative petitions for a bill moving university, normal and law schools of the state of Oregon, and establishing junior colleges... which petitions were then... of an aggregate value of more than 25 cents each, and... of more than \$55, all of which sets of petitions were the personal property of Henry Zorn, Willard H. Stevens and numerous other persons" composing the Taxpayers' Equalization league.

The tour will be held August 4 and 5. One of the days will be spent on farms where truck crops are being irrigated and the other day will be spent where there is irrigation for Ladino clover pastures, it was announced.

P. E. Price, former soil specialist, and now doing special work on electricity on the farm, will be available on one of these days. His work with electricity ties in with irrigation as most of the farmers who irrigate use electric motors to operate the water pumps.

County Agent Fletcher will be in charge of the tour.
