

REPEAL IS MOVE FOR TEMPERANCE, DECLARES CARSON

Attacking the republican administration for lax enforcement of the eighteenth amendment and declaring that the democratic repeal plank is a step forward in the right for temperance, Joseph E. Carson, Jr., of Portland, addressed about 150 persons Wednesday night at the court house in the first major party rally of the year.

Carson was a member of the platform committee at Chicago. In outlining the platform he interpreted the views of most of the committee of 55 which drew up the democratic platform at the convention. Lynn Black of Dallas, also a delegate to the convention, accompanied Carson to Eugene.

The speaker stressed the three major points of the platform, public debt, banking and repeal.

He ended his speech with a plea for temperance, declaring that the war against booze is to continue still.

"The prohibition enforcement directed by the Hoover administration missed its purpose in the large population centers of the east," he said. "The republicans centered the attack on the small and sparsely settled states, leaving New York and Chicago as much as ever in the hands of the liquor traffic. At the convention there was a feeling that something must be done to clean up these cities. When the dries put prohibition over they stopped their drive against booze to defend the amendment, and since its ratification have even been on the defensive. We propose to get on the offensive again and draft laws which will really work for temperance."

Carson attacked bureaucracy in the federal government. He declared that a vast machine has been built up in Washington which reaches into every part of the country.

"At a time when credit was needed most," he said, "10 billion dollars of credit were tied up in this bureaucracy. If the democratic party gets in power, it pledges itself to cut this unnecessary cost at Washington by at least 25 per cent."

He opposed banking methods fostered by the administration, saying that the international bankers drained the country of its money to float dangerous loans all over the world. This, he said, both took the money out of the country and built up ill-feeling against the United States when the borrowing nations found themselves unable to pay. He said the offenders in banking methods were the ones being helped by the administration through the Reconstruction Finance corporation, although he held this aid was necessary to maintain public credit. He said his party was pledged to see to it that the state department shall not lend approval to the banking methods used by the syndicates if it gets in power.

The meeting was sponsored by the Women's Democratic league of Lane county, Anne Whitaker, famous Lane county pioneer and vice-president of the organization, presided. L. L. Ray introduced Mr. Carson.

145 ARRESTS ARE MADE IN AUGUST

A total of 145 arrests were made and 28 transients given lodging during August, according to the monthly report of Carl F. Bergman, chief of police. Fines for the month totaled \$356.

Boys at Woodburn Helped, Says Marsh

Constable John Marsh's contention that 75 per cent of the boys sent to the state training school in Woodburn come out "good" was more than upheld when he visited the training school Tuesday.

"I looked into the records," he said, "and found that 80 per cent of the boys dismissed from that school have never been in trouble since. It rather explodes the common idea that sending a boy there is putting him on the way to the penitentiary."

Reserve Officers Have New Chief

Reserve officers of Oregon have a new executive officer.

Col. Richard W. Walker of the cavalry, having reported for duty at the headquarters of the second reserve area in Portland, has been assigned executive of the third district. His office will be in Portland.

Announcement of the formation of two regimental areas was announced Thursday. The 381st Infantry will comprise Clatsop, Columbia, Multnomah, Washington, Clackamas, Tillamook, Yamhill and Hood River counties. The rest of state is assigned to the 382nd Infantry, which has its headquarters in Eugene.

years, thereby making a 25 per cent reduction of the county tax.

Suggests Some Savings

"1—Cutting the general fund of \$263,501 by 20 per cent, thereby saving \$52,700 could have been done as follows:

"a—Cutting out emergency fund of \$21,900 as all probable items of expenditures are budgeted.

"b—Service of the home demonstration agent, a salary \$2100, should be dispensed with until financial conditions improve, saving the taxpayers county share of \$1100.

"c—County agriculturist who receives salary of \$3300 per year should be dispensed with until financial conditions improve, thereby saving taxpayers \$2500.

"d—The work heretofore done by the traffic patrolman should be delegated to the constituted officers of the law and to the road supervisors, thereby saving the taxpayers \$2100 per year.

"e—After \$5300 was placed in the 1932 budget for the Lane county fair the fair board voluntarily eliminated the county fair this year on account of financial conditions. Why did not Judge Barnard use the same foresight last December when the budget was prepared?

"f—According to the 1932 budget the health doctor received \$5000 per year and \$720 for travel. The two nurses receive \$1800 salary and \$720 for travel, each, while \$600 was allotted for clerk's salary and \$800 contingent salary or a total of \$12,200. While I favor keeping this service for the good to be rendered our poor, these salaries are too high. I believe that at least \$5000 should be saved the taxpayers in this service.

"g—Salaries should be reduced and on the 1932 budget could have been reduced, at least 12 1/2 per cent on salaries from \$1000 to \$2000 and 15 per cent on salaries from \$2000 to \$3000, with no loss of efficiency. This reduction of salaries, together with the elimination of some help and a 10 per cent cut of office expenditures would amount to over \$20,000, thereby saving the taxpayers \$20,000 on the 1932 budget. Items a, b, c, d, e, f, g, amount to \$37,800.

Cash and Bookkeeping

"2—Budget law requires all cash items to be set forth in the budget. On Jan. 1, 1932, the report of the county treasurer shows cash on hand \$145,790.23; of this amount at least \$98,963.98 should have been considered as cash items under general fund receipts. A \$15,000 cash item known as a revolving fund should have been considered as cash items under general fund receipts. These cash items would have lowered the tax levy as an offset by \$81,063.98 and thereby saved the taxpayers raising this amount.

of coming here for five persons they said were responsible for shooting 14 pickets, Sheriff Tilton today stationed 75 armed deputies in the court house to guard against trouble.

Leaders of the farmers' holiday workers, who seek higher far prices by preventing marketing of goods, declared they had eight witnesses to the shooting yesterday when two automobiles raced through picket lines and fired on the farmers with shotguns and rifles, wounding 14.

The leaders said five men allegedly concerned in the episode were known to the witnesses and that the group planned to march on Cherokee to "get" the assaults.

Lloyd Sankwin, a retired farmer who lives here, conferred with Sheriff Tilton and County Attorney R. G. Rodman and told the authorities no attack on the court house was planned.

Wood Bridges Only

Yesterday a delegation from the pickets met with businessmen and officials and were promised an investigation of the shooting.

Dodman telephoned Governor Dan Turner, he said, and quoted the governor as saying he was in close touch with the situation and asked to be advised concerning developments.

unit trade courses, according to Drew.

C. A. Coulter has been appointed as coordinator from the faculty and will assist the students in finding positions which offer real chances for training and advancement. Third prize in the design contest is a 10 1/2 quart aluminum preserving kettle, donated by the McMoran and Washburn store. COMMUNISTS RAID COAST GUARD BOAT

ASTORIA, Ore., Sept. 1.—(AP)—Three men believed to be communists raided the small coast guard picket boat No. 2359 at its moorings at the Port of Astoria terminals last night, bound the man on watch, and escaped with part of the boat's armament of guns.

Coast guard officials and police refused to issue any information today regarding the raid, which occurred at 11 o'clock last night, although reports to state police indicated that the raiders stole a Lewis machine gun, two rifles and two automatic pistols.

The boat carries a crew of four men, but three of the crew sleep ashore at night, one being left aboard the boat.

Reports of the raid indicate that

one of the raiders stayed on watch on the dock, while the other two boarded the boat, bound the coast guardsman, and stole the guns. They also disconnected the boat's telephone.

It is known that the local national guard company has been maintaining a permanent guard about the local armory since about three weeks ago, for fear of a possible communist raid upon the arms stored there, although national guard officers refused to admit it.

Saturday night's incident when police broke up a meeting of about 200 communists on a downtown corner and arrested two leaders after a minor riot is known to have caused bitter feeling among the large radical element in Astoria.

CHOLERA TAKES TOLL
