higher commodity prices and lack of definite assurance their own revenue would increase or even continue at its present level.

As one merchant put it, "I may hire two more people and the price of my stock may go up, forcing me to increase the price of my goods. But if the price then becomes too high for me to maintain my sales volume, due to persons being unable to pay the increased price, I am faced with a serious problem in keeping to the president's proposal."

To the employers of large numbers of workers, the problem of adjusting their staffs to the 40-hour week was a difficult one, requiring considerable study to work out. Employers have till August 1 to complete their readjustments and file their certificates of compliance with the postoffice here. The agreement is sent to the department of commerce when it is signed by the employer.

Classifications Puzzle
Under the agreement, after August 1, the employer agrees not to employ persons under 18 years of age except in certain specified instances. He agrees to work his employees not more than 40 hours per week or 52 hours per week according to his classification. The minimum wage is to be \$14 per week.

Many employers were puzzled as to what classification they came under. For instance, officials of the water board were uncertain how to handle the hours of their plant operators, but believed they came under the classification calling for a 52-hour week.

City officials also were studying the agreement to determine their status and had reached no definite decision Thursday.
In connection with the wage phase of the agreement, some were finding difficulty due to the fact much of their work was voluntary. The local Red Cross chapter was one of these. Mary Annin, executive, being uncertain as to the status of volunteer workers.

In the case of some mills, employers of which wished to hire additional people but found themselves faced with the necessity for increasing housing capacity, the problem arises as to how they shall meet the increases in expense in the face of no assured increase in revenue.

All these problems, however, were expected to be worked out in time to file the certificates of compliance by August 1 and all employers reiterated their intention to cooperate with

President Roosevelt in every respect. The board of directors of the Eugene chamber of commerce met at the Eugene hotel Thursday noon and discussed the recovery program, but decided not to call a meeting of merchants till more detailed instructions were received.
Instructions on mobilizing local businessmen into a united plan of action for recovery are expected to be received Monday and when these arrive, Edward R. Morris, president of the chamber, will call a meeting of all merchants and the matter will be outlined to them at that time.

was proceeding without hitch in all areas.

Bales of additional material, posters and stickers bearing the characteristic blue eagle of the campaign, together with detailed instructions to local committees, were being shipped everywhere.

More than 17,000,000 pieces were being distributed.
Intensive work proceeded on the substitute codes for portions of the oil industry which the recovery administration has undertaken to whip into shape by Monday.

Similarly, a committee of the lumber industry was trying to revise labor and price control terms of its own code to conform with administration policy.

A new code was received from the retail coal industry, accompanied by a request that its members be allowed to put its labor terms into effect immediately in place of the slightly more stringent ones of the blanket voluntary agreement.

Hearings continued on the code for the men's clothing industry taken up yesterday and a new hearing was begun for the rayon manufacturing trade.

Important questions at stake included whether employer of labor now under contract will be expected to reduce working time while maintaining the current rate of pay, whether employers with a formal code of fair competition calling for longer work hours and lower wages than the blanket agreement could put into effect their own terms temporarily, and still receive the blue eagle badge of honor, and whether workers of all kinds paid on an hourly rate must receive as much wage as at present on the reduced schedule.

William Green, president of the

American Federation of Labor, insisted that no contracts between employer and labor should be allowed to stand in the way of carrying out the terms of the agreement on a voluntary basis.

It was clearly indicated the administration had no intention of applying the blanket agreement to agricultural employers and in fact expected to confine its use generally to urban areas. Domestic employment also is not intended to be brought under its provisions.

BACKS REPEAL

JACKSON, Miss., July 27.—(AP)—A public declaration by Senator Pat Harrison favoring an early vote on repeal in Mississippi was interpreted by democratic leaders today as an indirect appeal to Governor Conner for a prohibition session of the legislature.
