alpenstock. These latter articles are always carried by mountain climbers. If the going is steep, one should always be equipped with a good climbing rope. The best rope for this is made of linen, but cotton climbing rope can also be used. Ordinary manila rope is impractical for mountain climbing.

An emergency kit to care for minor bruises is always carried by experienced mountaineers. If a camp is established, a large first aid kit should be included.

As a protection against the sun and the glare from the snow experienced climbers recommend grease paint and dark glasses. Ordinary cold cream is not sufficient protection against the sun's glare from the snow.

Condensed food is carried by mountaineers only when a trip of two or three days' duration is to be made and where it will be impossible to build a fire, as on Mt. Rainier.

1 pint boiling water. 1/4 cup sugar. 1 egg. Juice of 1/2 lemon. 6 peaches. 1/2 cup chopped nuts.

Cook tapioca and salt in hot water in double boiler for 15 minutes, stirring constantly. Add sugar. Pour small amount of mixture over slightly beaten egg and stir well. Return to double boiler and cook until mixture thickens like custard. Remove from fire and add lemon juice, peaches, sliced or cut in halves. Cool. Place in ice box to chill thoroughly. Pile lightly in sherbert glasses and garnish with whipped cream. While chilling the fruit-flavor has a chance to permeate the tapioca mixture and is therefore better if made a day or two in advance.—Mrs. A. G. Lyle, 1226 Lincoln street, Eugene.

Nudism Film Set For Presentation Here On Thursday

For the presentation of the authentic film on nudism, "Back to Nature," Cecil Julian Farnes, of Portland and Seattle, has leased the Colonial theater for Thursday, Friday and Saturday of this week. It was announced Tuesday by Glen Godfrey, Colonial manager. Mr. Farnes will bring the complete show, which has just finished a record run of two weeks in the Playhouse in Portland, and will add to it a complete feature picture, "The Phantom Broadcast," he announces.

"Back to Nature" is an authentic account of various nudist colonies both in America and in Europe. While it shows the activities of these people, it is said not to border on the immoral. The film was thoroughly investigated by the Colonial management before granting the lease to Mr. Farnes.

Although all phases of nudism are taken up in the picture, at no time does it become propaganda for this cult, Mr. Farnes says. The picture is well made, beautifully photographed, and contains a great deal of highly interesting material both in this country and abroad.

"Phantom Broadcast," the second feature on the bill, is a radio broadcast mystery story, and is one of the most entertaining mystery pictures of the year. Ralph Forbes is starred and gives an excellent portrayal of a sympathetic character.

Mr. Farnes' activities in promotion of nudism in the northwest have been along strictly health lines, and the colonies with which he is associated, are highly regarded by many prominent persons interested in his work. The entire program will be shown both at matinees and evenings starting Thursday, it is announced.

SWIM CARNIVAL TO MARK POOL CLOSING

Sixth, 30 yards back stroke for seniors. Seventh, 50 yards free style for all girls. Eighth, 75 yards free style for all boys. Ninth, 100 yards medley for all boys. Tenth, diving for juniors and seniors. The first will be plain front or swan dive, second, jackknife and third, back dive. Eleventh, carnival and life-saving demonstration. Twelfth, presentation of awards.

Rev. W. G. Taylor Dies at Hospital

Rev. William G. Taylor, pastor of the Springfield Baptist church, died at the Pacific hospital Monday evening following an illness of about three months' duration. Rev. Taylor underwent a major operation a week ago and was convalescing very well when he became much worse Monday in an attempt to save his life. Rev. Taylor was born on Dec. 6, 1902, in Keiss, Carthage, Scotland. He spent most of his life in Canada, being employed by the Bank

of Canada for several years. Shortly after he graduated from the Northwest Bible school in Minneapolis in 1926 his father died, and he took his pastorate at Riceville, Ia., where he stayed five years. In 1931 he went to southern California, where on June 26, 1931, he was married to Miss Dorothy Corning of Los Angeles. In June and July of 1932 he served as supply pastor at Prineville, and he in September of the same year was called to Springfield where he has been the pastor of the Baptist church since.

Rev. Mr. Taylor is survived by his widow, Mrs. Dorothy Taylor; his mother, Mrs. W. G. Taylor of Riceville, Ia.; three sisters, Margaret and Anne of Riceville, and Mrs. Guy Byars of Elyria, Ia.; one brother, Burns Taylor of Riceville; and other relatives in Scotland.

Funeral services are to be held in the Springfield Baptist church at 2 o'clock Wednesday afternoon. Rev. Alfred Danielson, pastor of the Bend Baptist church, will officiate. Interment will be at Resthaven Memorial cemetery. Poole-Gray-Bartholomew chapel in Springfield is in charge of arrangements.
