

EMPLOYERS TO BE SUED BY OREGON ACCIDENT GROUP

Employers in hazardous occupations who have not put up a cash bond and whose records with the state industrial accident commission show delinquencies will be sued in the courts to enjoin them from employing labor until they do put up the deposit, it was announced Thursday by Ralph H. Campbell, attorney for the commission, who was here on business in that connection.

Quite a number of Lane county employers will likely be made defendants in such suits, Mr. Campbell said, as many of them are delinquent in this regard. The amount of the bond depends upon the size of the operation, Mr. Campbell said.

The law also requires employers in hazardous occupations to notify the commission in advance of its intentions of beginning operations and many of the employers are derelict in this regard, he stated. Two Lane county men were arrested one day this week for failure to report in advance and they are to appear in court later on. These men are Harry P. Stafford and Kenneth Chase, who operate a small mill in the Mohawk valley. They have been allowed to go on their own recognizance.

Mr. Campbell declared that the commission sustains an estimated loss of \$100,000 a year by reason of the failure of such employers to make a proper report to the commission.

GARDINER, Aug. 24.—(Special)—The remains of Louis Charles Schelling, who died August 18 in the general hospital at Alturas, Cal., were brought here for burial, and a Masonic funeral was held August 20.

Lincoln Lucas
GARDINER, Aug. 24.—(Special)—Lincoln Lucas, for 48 years a resident of this place, died in Portland August 18, and was buried by the Odd Fellows in Scottsburg cemetery, August 21. Rev. Conner of the Episcopal church at Coquille in charge.

He was born in Wyandotte county, Kansas, June 5, 1860, and moved to California with his parents in 1874. At the age of 18 he went to Alaska, spent three years and came here to join his brothers. WHEAT MEN SHOW INTEREST IN PLAN

A total of 178 wheat growers of Lane county attended the first series of meetings on the wheat production control plan of the federal government, it was announced by O. S. Fletcher, county agent, Thursday. The last of the first series of meetings was held Wednesday night at Cottage Grove with 25 growers in attendance.

The first of the series of second meetings, at which organization under the control plan will be effected, will be held at Irving, Thursday night at 8 o'clock. On Friday night wheat growers of the Springfield area will meet at Taylor's hall and on Saturday a meeting will be held at the Danish hall in Junction City. At 2 o'clock in the afternoon, on the date of the meetings, Mr. Fletcher will be at the hall where he will assist growers in making out contracts for the wheat production control campaign.

The meetings are conducted by Mr. Fletcher with the assistance of Bruce Shawne, of Eugene.

matter from them before any determination can be reached as to the extent of funds necessary to be reached to provide for those persons who are unable to obtain employment.

"If after these estimates are available," he continued, "and it develops, as Mr. Wilcox believes, that it will be necessary for the state to raise money to match the federal government funds for relief purposes, the next step will be to formulate a revenue-raising program which will have the approval and support of the people generally."

"Unless such a program can be worked out in advance, it would be futile to convene the legislature in special session, for it would only mean that any legislation it might enact would go down to defeat just as the sales tax did at the recent special election."

Agreeing that the situation is acute and that there is real need for relief, Osborne, secretary of the state federation of labor, declared "our solution is a capital levy on wealth, because it puts the load on those who can pay." Osborne reiterated that "they can't sugar-coat the sales tax so that we will swallow it." "Labor," he said, "will again fight the sales tax as it fought it before. We feel it is fundamentally wrong. It violates fundamental principles of taxation because it is not based on the ownership of wealth or the ability to pay. It's the same old story of trying to compel by legislation the poor to take care of the poor."

100,000 Help Needed
Chairman Wilcox issued a statement today in which he declared it was his opinion that "it is clearly the duty of the governor under the president's policy and in view of the necessity of at least 100,000 of our people to call the legislature in special session."

The governor, Wilcox said, "is wisely refraining from hasty action so that the measure of relief that can be looked for from the NRA and public works program can be measured, and so that members of the legislature may have an opportunity to sound public opinion as to methods to be pursued in providing the necessary funds."

Wilcox said there are now about 30,000 families in Oregon, representing more than 100,000 individuals, who are receiving all or part of their support from public funds. By Sept. 30, he declared, the state relief committee will be practically without funds, "and the amount then available from the federal relief administration together with all resources now in sight from the subdivision of the state, are insufficient to carry the

cost of relief even through October."

He estimated that there will be required from the state and local sources between \$4,000,000 and \$6,000,000 for relief before the end of 1934.

"It is clearly the duty of the people of Oregon," Wilcox declared, "to meet the situation as they have all other emergencies, and do it promptly and even though the pill may be bitter, swallow it with good grace."

Klamath Reports New Fish Malady

KLAMATH FALLS, Ore., Aug. 24.—(AP)—An epidemic of undetermined origin has killed scores of fish in Link river and Lake Ewauna, the Klamath Sportmen's association reported today.

The malady has taken a huge toll of catfish, mullet, sucker and chub. Only trout appear to be immune from the disease.

Prince Starhemberg, organizer of Dollfuss' heimwehr or home guard, might become head of the government and by means of a placative German policy, serve as a medium for nazification of the country.

Rumors in Vienna, on the contrary, have been that Dollfuss might propose Starhemberg as regent of a kingless kingdom in order to frustrate the nazis.

Dollfuss meantime increased strength of the frontier guard and

was recruiting a force of 1,000 picked marksmen of the heimwehr to reinforce the soldiers, police and heimwehr already on the German border with orders to shoot to kill any suspicious persons.

The Sarre situation, made tense by recent kidnappings of Sarre residents, allegedly by nazis, was expected to be brought before the league of nations assembly in September, along with mistreatment of Jews and the Austrian situation.
