Peach growers of the county met Tuesday evening at the Chase Gardens and outlined grades and prices for the season.

The local peach crop is just starting to come on now. There will be three grades, ranging from \$1.50 for No. 1 stuff down to \$1.25 for No. 2's, and \$1 for No. 3's.

Merle Chase was named chairman of the group. Besides attending the meeting, further details on the prices and grades will be announced later this week.

When completely fermented, with only 0.1 of sugar remaining, wines are referred to as dry.

PEDDLER'S LAW TO BE ENFORCED; OFFICER ARRIVES

A representative of the state department of agriculture arrived in Eugene this week to take applications for the state peddler's license from persons peddling fruit, vegetables, dressed meat and poultry.

The law, which was passed by the legislature at its last session, provides for the licensing of all persons peddling farm produce, Howard Merriam, prominent in horticulture circles, explained Wednesday.

The measure is expected to minimize promiscuous market wrecking by non-taxpaying itinerant vendors bringing in sub-grade produce from whatever the state and selling it at whatever price they can get.

The bonafide farmer and grower is given a financial advantage over the peddler by allowing him to peddle his produce either in the wholesale or retail market by taking out a \$1 license. The farmer who brings his produce to market only occasionally need not take out this license...

The law becomes effective March 31, of this year but was immediately contested by peddlers in Portland, where the circuit court upheld its constitutionality. It is now being considered by the supreme court...

Licensed peddlers, selling either to wholesale or retail, will carry a red and white tag on the back of their truck next to the state automobile license. State department of agriculture men are privileged to stop any vehicle carrying produce at any time...

The principal purpose of the measure is to give the grower and legitimate dealer an opportunity to sell his produce at a fair price in an orderly market, without fear of being underbid by an out-of-state peddler handling inferior fruit or vegetables.

Persons desiring to make application for the state license may do so by writing to the division of market enforcement, state department of agriculture, in Salem.

Triangle Power Petition Is Filed

SALEM, Aug. 30.—(AP)—The Triangle Lake Peoples' Utility district in Lane county today filed preliminary petitions with the state engineer for organization with a view of appropriating water from Lake creek, tributary of the Siuslaw river, for power development within the boundaries of the district.

The district comprising about 600 people is not served at the present time with electric power but many of the farmers own their own plants. C. E. Stricklin, state engineer, announced. The district would be formed for the purpose of constructing a \$500,000 hydro-electric plant. Transmission lines would cover a distance of 20 miles.

Mr. Gould held that this appointment could not be made (since the Eugene school district pays the salary) without dropping one of his regular teachers. He therefore suggested that the school of education people pick from his entire staff a person suitable for this post.

For this post he is recommending Mrs. Lulu C. Garrett with the notation that she has had wide experience, holds an M.A. degree and should be well qualified for the supervisory work. The board sustained Mr. Gould in his position.

It directed the education committee to prepare a resolution setting forth the position of the board as one of eagerness to cooperate with the university in every way at all times in the development of the best possible teacher training, but pointing out the peculiar financial circumstances this year make it difficult to accept the school's recommendations.

Mr. Gould held and board members agreed, that it would be best for the moral of the regular teachers to drop a teacher at this time to make room for a new appointee.

One janitor, Alfred T. Osburn, night man at Eugene high school, will be dropped for the coming year. This is due to the closing of Geary school. Osburn, the last to be employed, was dropped from the list.

SALEM, Aug. 30.—(AP)—Alson Bristol of Eugene, who advocates five cents a pound for hop pickers, was arrested at the Lakebrook yard north of here last night when he attempted to address workers at the conclusion of a motion picture entertainment.

The sheriff said he and his deputies stopped Bristol who jumped to a chair and began speaking, and arrested him when he protested. Bristol, who was not employed at the yard, will be given a preliminary hearing in justice court here today.

Burk said Bristol shouted "Go ahead with the meeting," as he was being taken away. More than 1000 pickers were at the gathering. The Lakebrook yard is paying a cent a pound for picking, Burk said.

A charge of trespassing or disturbing the peace will probably be placed against Bristol, who will be given preliminary hearing late today or tomorrow. He is held in jail here on an open charge.

The ambassador received a telephone call from President Roosevelt in time to permit him to rush aboard the liner at the last minute. Sailing was delayed only a few minutes.

chamber of commerce Wednesday night to discuss a code and other organization details.

On Thursday night O. J. Hayes, second national vice president of the International Retail Clerks Protective association will meet with the local clerks' group at the Labor hall.

An appeal for unanimous support of the NRA program, by employer and consumer, was made in an address over KORE by Rev. Bryant Wilson, pastor of the First Baptist church, Wednesday morning.

"September," he said, "is a momentous month in American history. Fifteen years ago this September the American army took the field at St. Mihiel and in the Meuse-Argonne to

bring to a speedy and victorious close the greatest war in history. In September, 1933, after our days of preparation in August, we propose to put to rout the greatest enemy that has appeared since those critical days of the World War—the sinister forces of depression.

"What are we, the consumers, asked to do in this emergency? Discriminate in our buying, patronizing those who are flying the Blue Eagle by Sept. 1. This NRA program cannot be successfully adopted by a few only; it must be entered into and adopted by all. Let us all unite in putting over the NRA program, that the awful burden of unemployment may be lifted and prosperity and peace may be our common lot."

Dr. Victor P. Morris, professor of economics at the University of Oregon, who addressed the Rotary club Tuesday, spoke before the Lions club Wednesday at the Eugene hotel. Dr. Morris again emphasized the economic soundness of the NRA program and stressed the vital necessity of universal cooperation under the Blue Eagle if the new conditions which have baffled individualism are to be met. The new cooperation under the National Recovery movement, he said, is the opening move in what may well be a successful new policy.

Tuesday night, speaking over KORE, Rev. Milton S. Weber, pastor of the Central Presbyterian church, pointed to the NRA as a way to end the unseemable conditions which have prevailed in this country for the last few years, when "it was possible for people to be homeless with too much lumber on hand. People were without work when there was much work to be done. People were without food while the shelves of warehouses were filled with food. We can do without large wages and tremendous profits, but we need inner peace. We must have it. When we cannot be won to it on a mass, a national program may be our best way."

Mr. Weber will speak again Wednesday evening at 8 o'clock over KORE. At 7:15 Mrs. Ella Edmondson will speak especially to the women during the women's democratic hour on KORE. The speaking program of the day will conclude with a theater address at the State theater at 9 o'clock by L. L. Ray and one at the Rex at the same hour by E. G. Harlan.

compared with the amount used in August.

Trustees of the Lumbermen's Loggers' association were in today following extended sessions Tuesday that ended at 11 p. m. in conference yesterday was the Douglas Fir Plywood association, the Washington-Oregon association and the Pacific Northwest lumbermen's association.

The West Coast association is powered by the NRA code and is working hours for a given week to distribute among the mills the production allocated to this district. The National Lumber Association of which J. D. Tennant is president is which J. D. Tennant is president is

Lumbermen estimate that the Pacific Northwest allocation for the month is about one-third of the wood to be produced in the West. The allocation will run over the shift for a five-day week and west lumber industry has been in position to control its own production and prevent the piling up of stock that have proved disastrous to market and sustained production the past.

LANE OUTPUT CUT Under the schedule of hours by the West Coast Lumbermen's association for the period from September 4 and lasting until the end of October, the mills will operate a total of 120 hours during the month. This is a reduction of 30 hours from the 150-hour week schedule. There is no estimate at all of the daily production of the Lane county as present, but a number of them are down, but that are operating on the basis under the NRA code will usually curtail their output in proportion to the reduction of the 30-hour week. The shorter hours would mean a reduction in the output of several thousand feet a day.

The Booth-Kelly Lumber Co. Lane county's largest operator, presented for the week a schedule of 40 hours a week with a production output of 200,000 feet of lumber. The curtailment of 30 hours would mean a reduction of 10 per cent of the company, said. The schedule had not been officially notified.

The Western Lumber company operating a big mill at Westport, present operating only on a 30-hour week basis and the new schedule would reduce the output of the great deal as it would mean a reduction of only 6 hours a week in operation. Under a 30-hour week the production of the mill has been a day.

The Giustina Lumber company this city operating a mill at Westport about Dexter, has a present output of about 30,000 feet a week under the new schedule. It would mean a reduction of 10 per cent of the company, said. This has been operating steadily for some time.
