STAFFORD INVENTS IMPROVED METHOD TO MAKE CHARCOAL

Patent claims for an improved process of making charcoal, believed to be the cheapest possible method of obtaining this product from wood waste, have been granted for an invention of O. F. Stafford, head of the chemistry department of the University of Oregon. Word that the claims had all been allowed and that the patent is to be issued were just received from the government patent office in Washington, D. C.

The improved process involves the feeding of a stream of chipped wood and sawdust into a rotating cylinder, where the material is dried and carbonized by heat produced principally as a result of the burning of the combustible carbonization products of the wood itself.

The method makes no attempt to recover any of the other by-products of wood waste, and was perfected chiefly because of the expense involved in making charcoal as only one of the products.

The improvement represented in this process over similar ones consists in a device which permits the carbonizing material to be protected from furnace gases containing hot free oxygen, while at the same time permitting the combustible decomposition products of carbonization to burn and thereby supply the heat necessary for the drying operation, Professor Stafford explains.

Professor Stafford began work upon an improved method of utilizing wood wastes by carbonization about 20 years ago at the university as a research project. By 1918 this work had led to the discovery of a continuous process for the carbonization of such material, which involved not only the formation of charcoal but the recovery of all other carbonization products. From 1918 to 1922 Professor Stafford was on leave of absence from the university and in cooperation with a prominent engineering firm in the east, gave all his time to this project. During this time the Stafford process was tried out on a semi-commercial scale and was installed commercially at the plant of the Ford Motor company at Iron Mountain, Michigan.

It was while working on the carbonization project that Professor Stafford attacked the problem of producing charcoal from waste wood in the cheapest possible method without regard to other by-products recovery.

Professor Stafford is nationally recognized for his research work and discoveries in chemistry. A project he is now at work on, that of manufacturing "heavy water," recently received national attention, as did a recent discovery that acetamide is the greatest known solvent.

LAST OF MANCHUS ENTHRONED FIRST MANCHUKUO RULER

HSINKING, Manchukuo, March 1.—(AP)—Henry Pu-Yi, last of the emperors of old China, became Emperor Kang Teh, first of the rulers of the new nation of Manchukuo today.

His enthronement, through religious and secular services, was performed in sub-zero weather under the protection of soldiers of Japan, the nation which carved Manchukuo out of China and gave Pu-Yi an ornate throne in place of the throne of the dragon. History probably will record the enthronement of the 18-year-old sovereign as the briefest, most perfumery, and most machine-like ever held. The ceremonies moved with the precision of the Japanese military machine.

Mr. Pu-Yi drove the five-mile trip, down a way festooned with bunting, in a bullet-proof, made-in-America limousine, to the "altar of heaven" for the religious ceremony.

But bunting was not all that lined the way, all along the route stood armed soldiers in unbroken ranks. They were troops of the Manchukuo army, but spaced at regular intervals through the Manchukuoans were Japanese soldiers—every fourth soldier was a Japanese.

The only spectators of the procession were the soldiers and a few groups of handpicked Manchus. Chinese and Japanese, carefully herded behind barred wire stockades 300 feet from the imperial procession.

At the altar of heaven, the witnesses were even more carefully weeded out and the only foreigners present there were two score newspapermen, including many Americans.

These, attired in the evening dress made compulsory by the occasion and wearing no hats, literally froze as they were forced to stand on the bare earth for nearly two hours with the temperature below zero.

The ceremony they witnessed was brief, and Mr. Pu-Yi, now Emperor Kang Teh, returned immediately to the palace for the secular ceremony.

Like the religious ceremony, the secular ritual was equally marked by Japanese military precision and stiffness. The spectators in the palace were restricted to highly placed Japanese and Manchu officials.

The Emperor Kang Teh himself gave the only human touch to the occasion when, shortly after ascending his superb ebony throne, decorated with the orchid of the dynasty, he declared in the quaint, flowery Chinese language that the new empire was founded on the principles of love for all men and heavenly will.

Russian Tells of Fate of Christians

A capacity audience in the lower auditorium of Lighthouse Temple listened Wednesday evening to John Wadasky, Russian missionary, tell his story of Christian work in Russia.

As a resident of that country until six months ago, Mr. Wadasky was an eye-witness to the recent oppression of the church in 1931 and the previous revolution in 1917. Himself a convert of American missionaries, he knows from experience the conditions under which the Christians must live in order to escape the six million soldiers detailed to find and kill them. No public or home worship is possible, consequently, caves, barns, and other obscure hiding places are used for religious services.

Incidents in his own career as an evangelist were related—of the hardships and privations endured, and the unique methods necessarily employed to observe Christian ordinances. No public baptismal services could be held because of the inevitable slaughter by machine guns, so abandoned wells and even barrels were pressed into service under cover of darkness.

Perhaps the high point of his message was the account of the destruction of 80,000 Christians in Moscow during the course of one month in
