

SOLONS WRANGLE OVER VETO; CLOSE VOTE PREDICTED

to uphold the veto could not justify that attitude in view of their previous votes, but Robinson took sharp issue with this view.

He said some had voted for the house amendments previously believing they were better than the more liberal benefits of the senate, but they were not "stopped from voting to sustain the veto."

Inasmuch as there was no limitation on debate, there was no indication when a vote would be reached. Several more senators were understood to be ready to speak.

Robinson said it had been his hope that a compromise would be worked out, but that was found to be impossible.

He added that the president had restored thousands of World War and Spanish war veterans to the rolls pending review and described this as "evidence that he wants to work this out justly."

Charge Broken Promises
Senator McCarran (D., Nev.), breathing heavily, entered the chamber while Robinson was speaking. He had come by airplane from New York to be on hand for the vote.

"All I ask," Robinson concluded, "is that the senate give to the executive that fair treatment and fair measure of cooperation that, by reason of his great service, he is entitled to. When that is done I shall have no complaint."

Senator Robinson (R., Ind.), said he would not be at all surprised if a rejection of the president's veto would make some senators happy, as "the president has embarrassed this body many times in veterans' legislation."

The Indiana republican asserted many implied promises of presidential support for veterans' legislation had been broken, and that administration leaders had intimated "very strongly" that the bill under discussion would be signed.

Approval Held Implied
Gesticulating vigorously, he said the motion by Senator Byrnes (D., S. C.), to concur in the house amendments had been an implied promise of administration approval.

Byrnes obtained the floor to deny he had ever made any statement to this effect, but Robinson stuck to his contention that a promise had been implied.

The senate "went along," he said, "only to be struck in the face with this veto."

Senator Harrison (D., Miss.), at the conclusion of the Indiana Robinson's speech, said:

"It's just the language he employed, the tactics he displayed and the votes he cast in 99 cases out of 100 that precipitates war. If he's ever done anything to preserve peace since coming to the senate, I don't remember it."

Senate in Confusion
Referring to Robinson's statement that other allied nations treated their war veterans more generously than the United States, he demanded that Robinson "rise up now and deny it!"

Agreeing they were, Robinson shouted:

"What has the senator from Mississippi ever done for either war or peace in all the years he's been here?"

With Senator Long (D., La.), vainly trying to gain recognition on a point of order, confusion on the floor spread and loud applause at Robinson's remark burst from the galleries.

Senator McAdoo (D., Calif.), who was in the chair, threatened to clear the galleries if it was repeated.

Long said both senators were "trying to start a bull fight."

ern Oregon and in the eastern section of the state, brought joyful reports from farmers and orchard owners today.

Especially in the fruit and grain areas was the precipitation referred to as "a million dollar rain."

Salem, Portland, Albany, Eugene and Marshfield received the greatest amount of rainfall, which was generally the heaviest since the last week in December.

The weather bureau predicted unsettled conditions for today, with rain tonight and Thursday, and snow in the mountain areas. Little change in temperature was expected.

The precipitation yesterday and last night in Portland amounted to 1.81 inches, more than in the previous 26 days of March. Salem had 1.90 inches, Eugene 1.08, Albany 1.22, and Marshfield 1.28.

Baker had only .04 of an inch of rain. At Walla Walla the precipitation amounted to .72 of an inch; Umatilla had .11, and The Dalles .86 of an inch.

A little more than half an inch fell at Medford, and Roseburg had slightly less. Wolf Creek had 1.10 inches.

In eastern and central Oregon last night's rain extended over the interior wheat districts which had been parched for a month.

The rain was said to have caused no damage to fruit blossoms, although it was accompanied by a stiff wind. The Dalles reported that although pollenization of cherry and pear orchards had been delayed, little damage is expected to result.

Umatilla county wheat and other crops were greatly benefited last night when .38 of an inch of rain fell, bringing the total to .43 of an inch for the two days. The precipitation was extremely necessary. A light rain was falling there this morning.

sent out. Invariably they found the post completely deserted.

"For a long time," said Captain Herman, "it was assumed that the crews were 'going native,' running away to the tribes on the nearby mainland. Then it was supposed that they were being carried off and murdered by the savages. Finally the mystery was cleared up.

"On one side of the light was a deep pool, a good place to fish. As one of the men approached it a huge arm lashed out and dragged him down. The others saw him go and learned at last that the hidden enemy was a great octopus which had his home in the depths. Dynamite was brought to the reef and the monster was blasted out. So the story goes, at any rate."

The Pacific coast has some of the most dangerous and interesting posts in the world, says Captain Herman. One of the most difficult is St. George's reef, off the California coast, and another is the wicked Tillamook Rock.

Both points must be guarded because they stand directly in the path of navigation, but the men who are assigned to those posts know that when they go on duty they will be marooned for months. Both men and supplies must be hauled by use of special tackle. When heavy storms come, they are completely cut off.

During a great storm a few years back "green water" was breaking clear over the light on Tillamook Rock, and a vast boulder sailed from the floor of the ocean was buried through the light itself. For days, as the storms continued, the light was out and the men were completely cut off. Water poured down through the top of the light flooding the living quarters and the men lived on a few cans of tomatoes which they were able to drag up.

The records of the lighthouse service are full of tales of heroism and sacrifice. And the record is also one of constant improvement. Captain Herman started his career back in the days when the lights were part of the navy's work. Now they are under the department of commerce and part of a vast network which protects the seaways as well as the waterways of the earth.

Except in positions where it is absolutely necessary, the government is no longer building the great toll towers reaching 100 to 150 feet into the air. Electricity is replacing the huge kerosene burners everywhere.

Sharp attacks on the Gary, Ind., school superintendent marked the committee's hearing on a resolution of Rep. Alfred L. Bulwinkle, D., N. C., for an investigation of the charges by a special house group.

Bulwinkle pleaded for the investigation so that Wirt's statement could not be used for political purposes in the coming elections.

"I do not think anything of this talk of revolution," said Bulwinkle, "but if there is any such man in the government as Wirt charges, the congress should know it and take action to get rid of him."

Charge Publicity Stunt
Bulwinkle related how James H. Rand, Jr., of the Committee on the Nation had read at a stock market hearing Wirt's charges that "brain trusters" were boring from within the administration in an effort to establish communism in this country.

"My idea is that Wirt should be required to testify and if there are no such men, the people are entitled to know it," said Bulwinkle. "If there are any, they should be run out."

"Who is this man Rand who relayed Wirt's charges?" asked Sabath. "I think this is all bunk and he is a publicity hound."

"Rand is chairman of the Committee on the Nation."

"That's a propaganda organization," added Rep. William J. Driver, D., Ark.

It was brought out that Rand had been asked to appear on the stock market bill at the request of democratic instead of republican members of the interstate commerce committee.

"Would you summon anyone Wirt might name?" asked Rep. Carl E. Macpherson, R., Mich.

"Absolutely," replied Bulwinkle.

Student leaders Wednesday were forecasting that even more memberships would be taken in the student body with the approach of annual student body and class elections. Non-members of the S. U. O. will not be able to vote, and these elections are usually hotly contested.

O. S. C. FEELS PINCH
CORVALLIS, March 28.—(AP)—The Daily Barometer, student newspaper at Oregon State college, today issued a special edition devoted largely to an appeal to students of the college to rescue student self-government from threatened collapse because of the recently ordered "optional fee plan" which leaves the Associated Students only 28 per cent of their expected income.

The attorney general has ruled that the associated students may not impose fees on students at the institutions of higher learning.

Warren Reid, editor of the Barometer, declared in a front page editorial that no agitation for optional fees had occurred at Oregon State and that normal payment of fees probably would have taken place had not orders been received from the board of higher education Saturday night requiring the posting of optional notices and making other changes in the plan after it was too late for campus leaders to meet the situation.

Unless the condition changes this week, either by voluntary payment or by some action of the board, the college will be obliged to put the Daily Barometer on a twice-a-week basis, to reduce by one-half support of forensics, band, glee clubs, orchestra and lyceum activities, and to curtail the spring athletic program by eliminating either baseball or track entirely, or by reducing both to a "back yard" basis, it was declared by Carl Lodel, graduate manager.

Butler Indignant Over House Action

NEW YORK, March 28.—(AP)—Dr. Nicholas Murray Butler, staunch supporter of the administration, arrived from Italy today indignant over the defeat sustained by President Roosevelt in the house yesterday.

"These people," declared Dr. Butler, referring to the congressmen who voted to override the president's veto of the veterans' allowance bill, "have betrayed their country and people. The only way to take care of them is at the polls."

"Personally, I wouldn't vote for any of them."

Considerable interest has been manifested around here in the matter of the presidency of the senate at the coming state legislature, local people feeling it desirable to have a man there favorable to local interests. It was learned here Wednesday that Senator Harry Corbett was being mentioned prominently in connection with this job and it is said he has 17 or 18 votes lined up for the job. No other name has been mentioned much in this respect and it is thought Corbett has a good chance of winning the position.

C. A. "Shy" Huntington, candidate for the republican nomination for representative in the state legislature, Wednesday announced he was

in no way associated with the National Economic League. This league had for its avowed purpose the reduction of financial benefits for veterans and as such is not a popular with veterans throughout the country.

Recently lists of names appeared in this city, the names of prominent Eugene citizens being the list. At first glance, many of these lists to be a roster of local members of the league, but on scrutiny, it was revealed that at least one of the lists appeared to be a "Please forward \$5 membership fee." Most of the lists were their way into waste baskets, some apparently did not and it was believed some think names on the list were those of actual members.
