be ran, Wilcox is reported to have sworn at Klepper. It was a minute or two before the officer could get out of the car as he was in the back seat and had to move the front right seat before getting out. Hartley is reported to have leaped against the seat.

Bullet Pierces Body Klepper finally got out and shot after the fleeing Wilcox. He ran in the grass about Wilcox's feet but the fugitive got on Wilcox. He climbed over a fence nearby and started running again. Klepper said he fired two more shots at Wilcox's feet.

The ground was rough there and Wilcox fell just as the next shot was fired, Klepper reported. The bullet entered Wilcox's back just a shade to the left and went entirely through his abdomen, coming out just above the stomach.

Soon after he was shot, Wilcox is reported to have said to Klepper, "Well, I'm Blackie all right. You got me," and proceeded to swear some more.

When he reached the hospital doctors found him practically pulseless and had to work for some time to get circulation restored. He lapsed into unconsciousness.

Wilcox is 34 years of age. The house at 1300 Chambers was rented in Wilcox's name. No one was on the premises when officers made the raid.

On June 31, Wilcox was arrested on a charge of possession of liquor and was fined \$250, serving time in lieu of payment.

MARCH NORMAL; TEMPERATURE AND RAINFALL AVERAGE

March brought much normal, its mild temperature and little fall, except for the last few days, but the monthly report from the weather office shows the March passed was quite normal. It was the highest maximum, a record of 72, which figure was reached on March 12, March 18, and March 21. The month in past years has occasionally hit up to 77 and 80 degrees for the maximum.

Precipitation was exactly 3 inches of the past March, which is considerably more than some Marches had, although not as much as March, 1933, when 4.38 inches were recorded.

There were eight clear days, 18 partly cloudy days, and ten cloudy days.

The chart for the highest maximum and lowest minimum for each March during the past 12 years is as follows: 1924, 72 and 32; 1925, 70 and 27; 1926, 68 and 25; 1927, 77 and 28; 1928, 71 and 28; 1929, 70 and 35; 1930, 70 and 26; 1931, 71 and 29; 1932, 69 and 30; 1933, 80 and 25.

The rainfall for the Marches on record at the weather office is as follows: 1924, 3 inches; 1925, 4.38 inches; 1926, 6.04 inches; 1927, 4.87 inches; 1928, 1.73 inches; 1929, 2.88 inches; 1930, 7.81 inches; 1931, 2.87 inches; 1932, 4.0 inches; 1933, 1925, 1.63 inches; 1924, 2.52 inches; 1929, 2.29 inches.

Twenty-seven applications have been gone over by the commission and are being held pending hearing from relatives and other questions involved, while 27 applications have been received since March 1 and have not been acted upon by the commission.

Seventy-seven applications have been denied. This is 18 3-4 per cent of the applications acted upon. Most of those denied the pension were denied on the ground that children and relatives were able to supply support.

Since the law states that allowance made under the pension law is intended only for persons who are without funds or other means to provide for their needs, and who have no children or other persons responsible for their care and who are financially able to care for them. Under this law "brothers, sisters, sons, unmarried daughters, brothers and sisters" are legally responsible to provide funds for relief to their relatives. It is pointed out.

Dressing over all.—Mrs. B. Little, 1877 Villard St., Eugene. Wilted Lettuce

2 quarts leaf lettuce 1 small onion (coarsely chopped) 1/2 cup vinegar 1 cup lard grease 1/2 teaspoon salt

Into a large frying pan put the bacon grease, vinegar and salt and heat until sizzling hot. Add the lettuce and onion and cook for about 5 minutes. Lift lettuce from liquid and serve immediately. If desired, the strips of bacon from which the grease was fried may be added.—Mrs. Cliff Gregor, 1707 Orchard St., Eugene.

Fresh Spinach Balls 3 finely chopped uncooked spinach 1 c bread crumbs ground fine 3 egg whites Salt, pepper, paprika Meat broth or drippings from beef or ham

Mix finely chopped spinach with bread crumbs and add the whites of eggs. Season with salt, pepper and a little paprika. Set the mixture in the refrigerator to become cold. Bring to a boil in a deep kettle any meat broth, meat flavored soup or drippings from beef or fried ham to which is added a little water. Shape the spinach mixture in small balls and boil them in the liquid for five minutes. Serve hot.

In this unusual recipe of spinach with just the right combination of seasoning, its sweet spring goodness cannot be equaled.—Mrs. Waldemar Christensen, route 2, box 304, Eugene.

Soup Verte 4 tablespoons flour 3 tablespoons shortening 2 quarts stock 1 lb. spinach 1 bunch parsley 1 teaspoon sugar 2 egg yolks 1 lemon Salt and pepper to taste

Put stock into saucepan; add spinach and parsley, picked and thoroughly washed; let all boil twenty minutes; strain, rubbing puree through sieve. Return it all to saucepan, add shortening and flour mixed together with couple of water, sugar and strained juice of a quarter of lemon. Let boil five minutes. Beat yolks of eggs with 1/4 cup water, add them gradually to soup off fire, and stir near fire until cooked. Soup must not boil after yolks are added. Season with salt and pepper and serve.—Mrs. A. Spinach Rechauffe (French Recipe) 2 cups cold spinach 4 tablespoons butter 3 tablespoons flour 2-3 cup chicken stock 1 teaspoon powdered sugar Salt and pepper

CITIES OF COAST TO HOLD OUTDOOR EASTER SERVICES

By the Associated Press Thousands of worshippers will attend sunrise services Easter morning on the slopes of hills and at parks and churches in Pacific coast cities.

Beneath a huge, 103-foot lighted cross atop Mt. Davidson in San Francisco, nearly 30,000 persons are expected to see the heralding of Easter morn. President Roosevelt recently touched a golden key which lighted the new cross.

Mt. Rubidoux, the scene of the first Easter service in Southern California 26 years ago, annually draws nearly 25,000 persons while a like number will attend worship at the Hollywood Bowl.

Plans are being made to erect a 100-foot cross on the top of Mt. Whitney, the highest peak in the United States, and a special sermon will be preached at the mountain's base this Easter.

Upwards of 30,000 persons will attend services on Mount Tabor and in Portland's city parks, while in Washington a chorus of 500 voices from 30 church choirs will greet the dawn at Washelli. The eighth annual sunrise service will be held in the University of Washington stadium.

The latest sunrise service in the west will be held at Yosemite national park in California, with the congregation in the valley near the base of massive Half Dome. The sun will come over the dome at 9:31 a. m., signaling the start of the services.

CAPITAL FEARS RAIN WASHINGTON, March 31.—(U.P.)—This capital city somewhat cheerlessly faced today an Easter morn the two traditional main drawing cards—the cherry blossoms and the president.

Rain all day today, and uncertainty further reduced the number of Easter smiles. The chances didn't look any too good for a stylish show.

Watching the skies anxiously were thousands of small children, who have known what it was in past years to have an Easter morning egg-rolling blighted by rain.

Mrs. Franklin D. Roosevelt was among those outfitted with new Easter togs, but uncertain as to whether she'd get a chance to wear them.

She slipped off to New York last week and added two new spring costumes to her wardrobe. One, a dress of blue print with cape of black, to be worn with a smart black hat, blue-trimmed. She chose for the Arlington ceremony a service at Arlington cemetery.

But if it pours rain, as has happened the last two Easter sunrise services, she'll wear a black dress.

One of Washington's outdoor traditions is the Easter morning memorial service at Arlington. A trumpet sounds at seven o'clock to signal the start of the service. Dr. James Shera Montgomery, chaplain of the house of representatives, will conduct the service, annually held by the Knights Templar.
