LANE HELD LITTLE AFFECTED BY HALL WITHDRAWAL MOVE

Indifference, the radical element is more likely to turn out than is the conservative element. Thus, those who feel like doing something about the present state of affairs are likely to turn out in force while others who are not so wrought up are not likely to make the effort to reach the polls. This means in turn, that candidates appealing to radical tendencies may stand more chance of being nominated.

As a result of this tendency, the conservative forces are making a strong effort to get as heavy a vote as possible in the hope of nominating their candidates.

In Lane county, the matter of scratching the name of Charles Hall from the ballot must await official notice of his withdrawal at the county clerk's office. Then, according to County Clerk Walter Dillard, notice must be sent out to each of the election judges in the 50 precincts. If official notice of the withdrawal is not received very shortly, it will be impossible to get word to all the judges in time to have the name scratched, says Dillard.

Judges Non-Partisan
Of the total registered voters in Lane county, only republicans and democrats may vote on the party candidates in the primary election. However, voters who registered as independents, of which there were 665; socialists, with 27; prohibitionists, 58; progressives, 27; communists 1; and liberty party, 4, may vote for the non-partisan judges and on the special measures on the ballot.

Thus, these voters may go to the polls to cast their vote for either George R. Bagley, of Washington county, or John L. Rand, of Baker county, for judge of the state supreme court, position number four.

In the second judicial district, three circuit judges are to be elected and four candidates are running. Judge George F. Skidmore, of Eugene, Judge James T. Brand, of Coos county, Judge B. L. Eddy, of Douglas county and Carl E. Wimberly, of Douglas county are the candidates. The only contest is between Eddy and Wimberly. Voters not registered as republican or democratic may vote on these candidates.

Measures On Ballot
They also may vote on the following measures:

1.—County indebtedness and funding bond, constitutional amendment: Requiring a two-thirds vote in counties to authorize county indebtedness exceeding \$2500 for roads, issue warrants evidencing liabilities imposed by law and which they are powerless to prevent and to issue bonds in amount equal to the amount of its outstanding warrants Dec. 31, 1933, but not exceeding 2 1/2 per cent of the assessed valuation of all property in the county.

2.—Criminal trial without jury and non-unanimous verdict, constitutional amendment: Providing that persons accused of criminal action may waive trial by jury and be tried by the judge alone, providing that in the circuit court ten members of the jury may return a verdict of guilty or not guilty, except a verdict of guilty of first degree murder.

3.—Bill authorizing state tuberculosis hospital in Multnomah county: Providing the construction and maintenance of a hospital in Multnomah county when funds are available.

4.—Bill authorizing state insane hospital in Multnomah county: Similar provisions to tuberculosis hospital measure.

5.—School relief sales tax bill: Providing collection of tax of one and one-half percent of gross receipts from retail sales of tangible personal property and utility service, exempting gross receipts of each person up to \$50 a month, law to be effective two years.

Statements Misleading
The audit covered the period of July 1, 1932, to June 30, 1933. Assets and liabilities were listed at \$17,222,247.67.

Funds available during the year were listed at \$4,915,822.54. "It appears," the audit continued, "that the state board of higher education not only subsidized the dormitories but also subsidized some of the students by indirectly paying for part of their room and board, since the service rendered the students using the dormitories certainly has not been charged to them in full, as evidenced by the operating losses shown by the statement."

Cherry and Loganberry Preserve
5 cups pitted black or dark cherries
5 cups mashed loganberries
5 cups sugar for each cup fruit.
Put cherries and put in preserving kettle. Add mashed loganberries. Measure and add one cup sugar for each cup fruit.

Cook until very thick—about 25 minutes. Seal in sterilized jars.—Mrs. W. R. Kirkpatrick, 1654 Charleston, Eugene.

Pickled Cherries
Wash and pit large, sour, red cherries. To the cherries add three-fourths of the sugar over the fruit. Sprinkle the sugar over the fruit in layers, and let stand overnight. In the morning stir until the sugar is dissolved and then press the juice from the cherries. Tie a small quantity of whole spices in a loose cheesecloth bag, drop this into the juice, and boil it down until it is about three-fourths of the original quantity. Pour the hot syrup over the drained cherries, and add 2 tablespoons of vinegar to each pint. Seal and let stand for about 2 weeks to blend before using.

Cherry Pie
4 cups tart, juicy, pitted cherries
2 tablespoons cornstarch
1 cup sugar
2 tablespoons butter
1-2 teaspoon salt
Pastry

Simmer the cherries for five minutes, and drain. When the juice has cooled mix the cornstarch with it. Cook until thickened, add the cherries, sugar, butter, and salt, and mix thoroughly. Pour the hot fruit mixture into a baked pastry shell, add the top sheet of dough, and bake in a moderately hot oven (375 to 400 degrees Fahrenheit) for 25 to 30 minutes, or until golden brown.

Cherry pie made in this way should have crisp under crust. In place of the upper crust, twisted strips of dough may be laid in lattice fashion around the fruit. Very good.—Miss Arvilla Plaster, Cottage Grove.

Cherry Preserves
Make a thick syrup of 2 cups of sugar to 1 cup of water. Seed and drain fruit. Drop in the boiling syrup and let boil five minutes. You can use the juice from the cherries in place of the water. This makes a thick and rich preserve.—Mrs. Denton Sheeks, 1102 High street, Eugene.

MEIER APPEALS TO F.D.
SALEM, May 16.—(AP)—In a telegram sent to President Roosevelt last night, Governor Julius L. Meier urged the president to use his influence to promote arbitration of the longshoremen's strike and the movement of perishable and other urgently needed commodities.
