

TRIBUTE PAID TO U. S. WAR DEAD IN FRANCE WEDNESDAY

PARIS, May 30.—(AP)—The solemn notes of "Taps" today echoed over the graves of almost 30,000 American soldiers, sailors and marines whose bodies still lie in France.

French and Americans joined in commemorative services in the five military cemeteries in France over which still floats the American flag.

The day began with a tribute on the part of American veterans to the French unknown soldier, who lies under the Arc de Triomphe.

Following services at the American cathedral church of the Holy Trinity, and Saint Joseph's church, the color guard of the American Legion in Paris marched to the Arc where Ambassador Straus placed a wreath on the tomb.

At the same time services were held at the five chief American cemeteries where the stars and stripes were raised by delegations of American veterans and the local French authorities.

At 2:30 p. m. the main ceremony of the day was held at Suresnes cemetery with Harold Smith, commander of the Paris post of the American Legion presiding. Ambassador Straus spoke in behalf of the American government, while General Denain, minister of air in the Doumergue cabinet, spoke for the French government.

After the Suresnes ceremony, the French and American delegation went to the Lafayette Escadrille memorial where a final ceremony was held.

At Romilly-sur-Seine, the grave of Edward Mandell Stone of Chicago and New Bedford, Mass., first American killed in the World War was decorated by a delegation of Paris members of the French aid association of the American volunteer combatants in the French army headed by Philip A. Rogers of New York, secretary of the association. The mayor of Romilly and a group of French veterans were present at the ceremony.

HOLLIS TO PRESIDE AT HI-Y REUNION

Former members of the local club, now living in other parts of the country, will send letters of greeting to the meeting. The roll call of every member of the Eugene Hi-Y club will be read and responses either in person or by message will be given.

The member living at the greatest distance from Eugene at present is Richard Hayden, former Eugene high school student, who is now a missionary on the headwaters of the Amazon in South America.

BRITAIN PLANS OFFER

LONDON, May 30.—(AP)—A new British war debts proposal will be dispatched to Washington within 24 hours, under government plans reviewed finally by the cabinet today.

Unless the ministers decide a last minute revision is necessary, the text is expected to be telegraphed today.

Neville Chamberlain, chancellor of the exchequer, plans to outline the war debts situation fully to the house of commons tomorrow.

Official quarters did not reveal the nature of the note but it was believed to be Britain's final effort to avoid the stigma of default by proposing a conference on the whole problem, with a continuation of debt payments if necessary to seal the bargain.

avarice or other forms of self-interest. For what took millions of men into hardship, danger and defeat during the last three great wars? In every one it was a cause of human service which called for all and offered no selfish reward. Dare any of us stand by these graves and say that there are no higher motives than economic or political self-interest? Dare we stand by these graves and say that we will not give of our best to human welfare unless we find it to our personal advantage to do so?

"You old soldiers have set a good example in your fraternalism as brothers—the blue with the gray. The wounds are bound up; the old enmity is dead. Fondly do we hope, fervently do we pray that all men shall learn that God has made of our blood all peoples of the earth and that we are to treat each other as brothers, not needing to go to war to settle our differences, but solving our problem in a brotherly fashion by peaceful and honorable means."

"You veterans of the Civil war represented the rank and file—those men who marched, dug ditches, slept on the ground, rose cold and stiff in the morning to be shot at, knowing that many would fill the trenches of the dead. You kept it up through those long terrible years until the slaves were freed and the union preserved. Very few of us can be generals in the battles of life. But God grant that grace may be given to us of the rank and file to be true to your example, to finish the tasks you have so nobly advanced and to keep faith with the higher things for which you were willing to die!"

Graves of World War veterans were decorated with flowers and flags Tuesday and Wednesday. Bridge Contracts
Extended 90 Days

SALEM, Ore., May 30.—(AP)—Senator Charles L. McNary today notified Joseph Devers, state highway commission attorney, that President Roosevelt had signed a bill extending 90 days the time for letting contracts for the five coast highway bridges.

The original act of congress authorizing the bridges provided that all contracts should be let June 1. The extension, granted because of a delay of the public works administration in authorizing the structures, extended the period to October 1, allowing ample time, Devers said.

AMERICANS TOLD TO "GET OUT OF CUBA IN 30 DAYS"

HAVANA, Cuba, May 30.—(AP)—Renewed attacks on United States residents and a mysterious warning for all Americans "to get out of Cuba within 30 days" caused serious alarm today despite the news that the Platt amendment had been abrogated.

While the populace celebrated termination of a permanent treaty with Washington that restores full Cuban sovereignty, the rattle of police gunfire added to disturbances created by attacks on Americans, including Ambassador Jefferson Caffery and attaches of the United States embassy.

Latta Carly, an employee of the Havana Post, was the victim of the fresh wave of attacks. He was set upon by a group of negro ruffians and beaten and robbed. Police gunfire dispersed the attackers.

The warning for Americans to leave Cuba came in an anonymous telephone call to the secretary of the publisher of the newspaper El Mundo.

"You Americans better get out of Cuba in 30 days," the message said. A double guard was maintained around members of the embassy. They minimized the danger but Cuban authorities insisted that there must be no change of a mishap now when the republic is making progress toward a new deal with the United States.

A soldier guarding Caffery's home was wounded fatally and another outbreak near the embassy marked attacks of the past two days.

Impromptu demonstrations throughout the capital followed arrival of word that the Platt amendment was doomed. Cubans long have held that the treaty hampered their freedom as a sovereignty because the amendment gave the United States authority to intervene with military if necessary, whenever it deemed conditions in Cuba were sufficiently grave.

Rum Board Reports
\$58,000 In Profits

PORTLAND, May 30.—(AP)—The state liquor control commission sold \$103,441 worth of liquor through its stores and agencies during the month of April, and has sold \$310,075 worth since the control system was established in February.

This statement was made to the commission here by George L. Sammis, administrator.

The commission was said to have made a profit of \$58,300 since the store system has been operating. Included in this amount is \$27,353 from sale of permits.

Total receipts from the license division amounted to \$93,600 and this figure is expected to exceed \$100,000 by the end of May.

Revenues from the pollage tax on beer and wines to May 1 totalled \$40,972, and since May 1 an additional \$29,034 has been added for a total of \$70,006.

brave armies of Americans once met in combat. Not far from here, in a valley likewise consecrated to American valor, a ragged Continental army survived a bitter winter to keep alive the expiring hope of a new nation; and near to this battlefield and that valley stands that invincible city where the Declaration of Independence was born and the constitution of the United States was written by the fathers.

Surely, all this is holy ground.

"It was in Philadelphia, too, that Washington spoke his solemn, tender, wise words of farewell—a farewell not alone to his generation, but to the generation of those who laid down their lives here and to our generation and to the America to tomorrow.

Perhaps if our fathers and grandfathers had truly heeded those words we should have had no family quarrel, no battle of Gettysburg, no Appomattox."

Common Stake Held

He spoke of the journeys of Washington through the 13 states while president to knit together all sections by their common interest in great enterprises.

"We are all brothers now in a new understanding," the president said. "The grain farmers of the west do not set themselves up for preference as we seek at the same time to help the cotton farmers of the south; nor do the tobacco growers complain of discrimination if, at the same time, we help the cattle men of the plains and mountains."
