pageant to crown a queen. They had a coronation of their own. Miss Anne Whiteaker, daughter of Oregon's first governor, was the queen. Attended by little girls and flower bearers and sturdy grandsons of pioneers as pages and trainbearers, Miss Whiteaker, wearing the robes she wore at the Medford Diamond Jubilee was escorted to a throne on the lawn.

During the afternoon, Lester G. Hull read a brief history of the Pioneer organization in Lane county. Another important piece of business was the selection of a pioneer grand marshal for the Oregon Trail celebration.

Most of the day, however, was spent in "visiting." Oldest of those present was Rev. W. H. Myers, 82. Next oldest, according to best accounts was Mrs. Dr. Abram Sharples, widow of one of Oregon's pioneer surgeons and physicians. A notable visitor was Will Edwards, 80, of Fossil, Oregon, a brother of Ira Edwards, for many years one of Lane county's leading citizens.

Mr. Edwards met Marion Wilkins and learned that Mr. Wilkins and one of his brothers had attended school together in Portland long ago. Other interested groups gathered around Mrs. Samantha Dillard, who came out from Illinois in 1836. Dr. M. M. Davis, pioneer physician, who was born in Oregon in 1851. To interested groups, Henry Smith and B. F. Howard explained just why it is all wrong to call the Smithfield by the name of Franklin, and Mr. Howard had a photograph of original road signs showing that Smithfield was the proper name for the town.

appear before the commission to argue his case if a code authority has complained. He thereby obtains a legal forum not previously in existence. 2. Similarly the code authority must argue its case before the commission. 3. The commission sits as a non-partisan judge.

The order in point was issued in the case of three rubber concerns which NRA accused of violating price fixing provisions of the code. NRA and the companies will argue before the commission, which may either proceed against the companies or dismiss NRA's complaint. Under previous rules, the commission had to make its investigation before issuing a complaint. Now it may accept NRA's complaint and let hearings determine the justice of the proceeding. The commission is further enabled to hand down decision to begin the creation of a body of law under which code authorities will operate. The order does not alter past procedure on matters not coming under the codes. It affects only NRA cases. The memorandum explains that another purpose is to furnish data regarding NRA which will be helpful to congress when it sets about determining the recovery unit's feature.

their dispute by the department of labor. Fair Deal Promised "Will you submit the one point still in dispute between employers and employees in the longshoremen industry, namely, the control of the hiring halls, to arbitration by an arbitrator of the United States department of labor?" the secretary's telegram read. "I earnestly recommend this to the consideration of both employers and employees in the interests of justice and in the public interest. An agreement was reached on all other matters in dispute and for the preservation of orderly civil, economic and social life I urge you to accept this. The resolution passed by congress in the closing days authorizes and provides for this particular type of voluntary arbitration of any point or points. I give you full assurance that the persons appointed to act for the department of labor will be fair, honorable and practical and that the decision will be in the public interest."

LITTLE HOPE SEEN SAN FRANCISCO, June 21.—(AP)—Officials of hot sides of the controversy indicated today that they do not believe Secretary of Labor Frances Perkins is fully informed of the status of the longshoremen's strike, which she asked be settled by federal arbitration. part of the great Douglas fir stand which was killed by fire last summer. This allocation represents an increase of 30,000,000 feet above the second quarter quota. For all purposes, the log quota for the west coast logging and lumber division was fixed at 1,119,000,000 feet. One spokesman for the lumber code authority said "The severe curtailment of production for the next quarter partly is due to the fact that production totals have been consistently kept above the possibilities of consumption since the lumber code became effective last August, on the theory that every reasonable effort should be made to increase production, employment and sales. The result is that there has been some increase in inventories since the code went into effect, while the expected revival of building has not yet materialized."

PORTLAND QUIET

PORTLAND, June 21.—(AP)—Quiet prevailed on Portland's waterfront today as employers further perfected their plans for opening the port under adequate police protection, and in defiance of the ukase of union leaders that commerce must not move. There was no activity and no disorder. The tank steamer Lio which discharged about half of her 8,000,000 gallons of gasoline here yesterday while uniformed police, fully armed, protected the docks against onslaughts by strikers, was anchored in mid-stream today. It had been planned to discharge the rest of the cargo this afternoon.

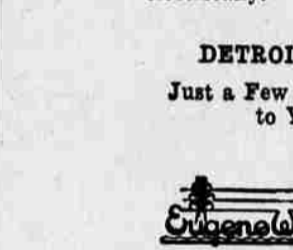
