NOT SINCE DECLINING ROME

NOT since the days when declining Rome was ruled by a series of degenerate emperors has the world witnessed anything quite like what is happening in bloody Germany. The events of the last few days seem to bear out some of the gloomy predictions of Spengler and the pessimist philosophers. Nobody can predict what will happen next in Germany or what its effect on the rest of the world will be, but the situation is at least clear enough to show the folly of those who hold the romantic notion that there is some cure for the world's ill in "dictators."

Hitler, a clap-net demagogue, without any real program for his country achieved a wide popularity by appealing to a wide variety of mass hatreds and suspicions. It was the money backing of the "junkers," the rich industrial class which financed his private armies and finally lifted him to power. The "junkers" thought to dominate him. They are finding out now how dangerous it is to bargain with him. Hitler is mad with the power madness which feeds on power.

With amazing cunning he has surmounted the dilemma in which he was asked to choose between "right" and "left." He was prepared for such an emergency. In the black-shirted "S.S." corps he had surrounded himself with a "praetorian guard," very much like the bodyguard of the Roman emperors, trained soldiers and gunmen, bound to him by lavish patronage and promises of power. He was able to strike first, and without remorse or pity he slaughtered his enemies on "right" or "left" till in all Germany he was once more the POWER.

How long he can endure depends somewhat on how long he can satisfy the bold and over-reaching Goering who is now slated to have Von Papen's job and the crafty Goebbels, master of the press and publicity. Hindenburg is on his deathbed; his great name is merely a pawn in the hands of the charlatans. There is a rumor that Hitler is to be made "president" when Hindenburg dies. That would make the bloodthirsty Goering chancellor and perhaps the real power, unless Hitler could maintain control by the mystic reputation he has built up with the masses.

If Hitler outlasts his dangerous companions, the world may see a display of Napoleonic madness. If he fails, it may see in Germany a more and more bloody succession of dictators. It is an appalling spectacle, worse than anything that has happened in Italy or Russia. Quacks and madmen rule an enlightened people.

"HALF-A-LOAF" ACCEPTED

WITH a fine of \$100 for "reckless driving," Clyde Foster escapes from the escapade which ended in the death of Patrolman Jackson a week or two ago. Originally charged with "involuntary manslaughter," a county grand jury refused to return a true bill. On a reduced charge of "reckless driving," a city jury refused to convict, split hopelessly. The city made to retry the case before a fresh jury, declined to reduce the reckless driving charge to something still easier. Because of blood-poisoning, attorneys for the young man advised him to enter a plea of guilty and ask leniency of the court. Recorder Bryson.

There you are. Either the young man was guilty of driving which had a most tragic result so far as one man was concerned, or he was totally innocent. There is nothing very convincing or satisfactory in an important case which is adjusted in this way, although such settlements are quite common in all our procedure. Though the city achieves a "technical victory," it certainly fails of any credit for efficiency in the situation. From beginning to end the state's case was poorly prepared and the presentation was strangely lacking in energy.

Mitigating circumstances such as youth and innocent intentions might justify mercy—after a proper case had been developed. Mitigating circumstances do not warrant the halfhearted handling of such a matter.

In the course of a year, scores of people pass through the courts and draw heavy penalties for relatively minor offenses. The handling of this affair is the sort of thing that produces "bolshie-riki" questions.

Governor Julius has just granted a flock of mid-summer pardons. Possibly the remaining members of the liquor board will get a reprieve.

WHAT OTHER EDITORS THINK

THE TWO SANTAMIAS

FROM time to time we have reported here the progress being made in the construction of highways in which the community is interested. Just now the two Santamias highways command, we believe, the largest local attention and we have secured the latest information regarding them to pass on to our readers. Frequently distinguished as the North Santamias and the South Santamias, the two highways are actually the Santamias and the North Santamias. The former runs from Sisters to Albany by the way of the Hogg pass; the latter takes off from the Santamias at a point west of Hogg pass near Little Nash crater and runs thence to Detroit and Niagara.

Starting with the Santamias we report that it is graded, surfaced and oiled from Sisters to just beyond Suttle lake. From this point to the summit just east of Hogg rock the highway is graded but as yet not

surfaced. Lack of surface is not serious, however, at this time of year, the chief discomfort to the motorist using the road being dust raised by other cars. Last summer most of the grading was done from the summit down to Little Nash. What remained is being finished this spring, the section requiring the most attention being that running below Hogg rock. The work is progressing rapidly and travel is possible over this section—at least on Sundays—over the Hogg grade, past Lost lake, over the sand ridge and down into the basin where Little Nash crater stands.

From Little Nash the Santamias is cleared for seven and eight tenths miles, if you care for the exact figures, and a grading contract is under way for five and three tenths miles. From the end of this clearing it is between five and six miles to the Tombstone prairie summit. This has yet to be graded but two and a half miles of the distance are cleared. The next control point is Sheep creek about 12 miles away. One mile of this section is under contract for grading. Thence the road is graded, with part of the distance surfaced and part of the surface oiled, all the way to Albany.

The grading under way west from Little Nash intercepts a forest road running north from Fish lake. As soon as it is finished one may go to Fish and Clear lakes this way instead of having to take the steep and difficult old Santamias road by Big lake and over Sand mountain. This will be sometime this fall.

Returning now to the junction to start off on the North Santamias we find that from this point to the next graded section it is 12.6 miles. All of the distance has been cleared or is under contract for clearing and three and nine tenths miles are under contract for grading with a short distance finished. By following the rough grade and a construction road adjoining it is possible to go through to the same road running north from Fish lake previously mentioned.

Beginning at the end of the 12.6 mile section just mentioned one finds the grade finished to Detroit. Thence to Niagara runs a forest highway finished years ago and badly in need of relocation and reconstruction. County funds run from here out to the Pacific highway and Salem.

The grading contract that starts at Little Nash ends at the road that runs north from Fish lake. By taking this road one may go to Big meadow, Independence prairie and so on to the new grade and out to Detroit. It is to be hoped that from the forest highway funds now in prospect there may be allocated a sum sufficient to make a big hole in the work still remaining to be done on these two roads.

WASHINGTON LETTER

 WASHINGTON, July 3.—Jack Garner, the vice president, is somewhere down around Uvalde, Tex., for a summer of hunting, fishing, and loafing.

Before he left, he blasted one large luncheon concerning him and carefully nourished another one.

He tramped with both feet on current reports that he was out of sympathy with the Roosevelt program. That was in a statement issued the New Deal, issued by the Democratic National Committee.

Those who have heard Garner speak in private of "that feller down in the White House" don't need his public assurance that he would follow Roosevelt through the fires of hell if F. D. happened to be going that way.

The fact is, Jack is a small town banker and he just loves the way Roosevelt has freed the government of Wall Street control.

But Garner also let his name be signed to a magazine article in which he wistfully confessed that he was just a "fifth wheel."

Insiders know better. The vice president is the authority on congress at cabinet meetings, and that's an important job. On the Hill, he's the man who knows what Roosevelt and the cabinet are doing and thinking.

He's continually consulted at both ends and probably knows more about what's happening and what's going to happen than anybody else in town.

His 30 years in the House, ending with the speaker's ship, have fitted him for an unprecedented though secret three-cornered liaison job with Roosevelt, House and Senate.

Don't imagine the old boy never speaks up at cabinet meetings. He talks plenty and frankly.

Secretary Roper once brought up the case of a Commerce Department employee who had received \$500 for a magazine article. Should federal employees be allowed to write for pay or not?

Although the Roosevelt family, White House secretaries and many other New Dealers had been doing just that, Garner argued vigorously against the practice. He insisted officials shouldn't take the money available only because they held public positions.

Roosevelt argued from one end of the table, Garner from the other. Nearly half the cabinet supported Garner! But the practice continues.

End of the college commencement season was almost as important as adjournment of Congress.

AN EDITORIAL ON HEALTH

THE light case of infantile paralysis which has attacked Ida Lupino, beautiful film actress, is one of what appears to be an epidemic of this vicious disease in California.

There have been previous epidemics in that state in 1925, 1927, and 1930. The epidemic of 1930 was the most extensive California ever experienced. In that year, 1930 cases were reported over 157 deaths.

At present the disease is spreading rapidly and there is no hope of a decrease before the coming of the first cold weather. It is typical of infantile paralysis that is a summer and fall disease.

In California the cold weather is not likely to appear until late November. For that reason doctors are advising people not to take small children into California at the present time, because small children are much more likely to catch this disease than are older people.

Infantile paralysis, like scarlet fever and diphtheria, is spread frequently by healthy people who are carriers of the disease, rather than by direct contact with the sick person.

A few years ago it was generally suggested that infantile paralysis might be prevented by inoculating children with the blood of those who have recovered from the disease. Later it was shown that even the blood of healthy grown-up persons has in it certain powers of protection against this disease, perhaps because of slight attacks of the disease and the carrying of antibodies of the disease in their blood.

Not enough evidence is available, however, to warrant a general recommendation for the inoculation of all children who might be exposed, either with the blood of persons who have recovered or with the blood of healthy grown-up people.

Indeed, there is still some doubt as to the value of the injections of the blood of those who have recovered, in treating a child who has been definitely diagnosed as having infantile paralysis.
