THEY BROUGHT IT ON.

SOME of the strongest arguments in favor of the stiff inheritance tax program brought forward by the administration are furnished by the very people whom such a program would hit. No newspaper reader can have missed these arguments.

During the last year or more there have been endless columns of stories about the litigation over the estate of the late Smith Reynolds, for instance. This young man inherited something like \$30,000,000. He married a young woman, was divorced, contracted a second marriage, and then died of a bullet wound under circumstances that made his death a nine-day sensation. Since his taking-off, his assorted relatives have been in and out of the courts trying to find out who is going to get that \$30,000,000. The whole business has been something of a spectacle, devoid of edifying features.

Then there has been the charming Barbara Hutton. This young woman, heiress to a 5-and-10-cent-store fortune, has also been in the papers considerably. To date she has two foreign titles to her credit, and reams upon reams of newspaper clippings; and to her fellow countrymen she has given an excellent demonstration of the way in which an ordinary American girl can win tabloid notoriety when she has more money than she really needs.

And then, of course, there is our old friend, Tommy Manville. Manville, whose forebears made millions by marketing a serviceable brand of asbestos, has won a reputation as a "Broadway playboy." He got into the papers most recently when his fourth wife, a young woman from a Broadway musical show, had some sort of spat with him. She was at pains to explain to reporters that she didn't want either a legal separation or a settlement of \$1000 a month, which is the figure at which her hubby's former wives have been pensioned off.

Now all this sort of thing is more than familiar to readers of Sunday supplements. The country has its full quota of young people who inherited great riches they never earned, and it is not at all surprising that some of them have managed to get into the newspapers rather frequently. What is surprising is that it has taken us so long to let their example remind us that the nation might take a far larger slice of that unearned wealth without doing an injustice to anyone. As between using a rich man's estate to help meet the nation's expenses and using it to buy foreign titles or provide \$1000 a month for deserving ex-wives of playboys—well, the ordinary citizen won't see much room for argument as to which is the socially wiser course.

FOR QUICK SETTLEMENT.

SENATOR NORRIS' proposal for a constitutional amendment to prevent five-to-four decisions by the U. S. Supreme Court on constitutional questions will provoke a great deal of debate, certainly; but there is one part of his plan which should meet wide acceptance, and that is his scheme for giving the supreme court original and exclusive jurisdiction in all lawsuits involving constitutional questions.

As things are now, if you wish to test the constitutionality of a law, you file suit in any federal district court. If that court feels the law to be unconstitutional, it can restrain enforcement of the law; and many months may elapse before the question finally reaches the supreme court.

Senator Norris would have the issue taken directly to the supreme court, without all these intervening steps, and his idea looks sensible. It might, in fact, be even more sensible to have the court decide on a law's constitutionality the moment it is passed, before any attempt at enforcement is made. Failing that, the Norris plan is at least a step in the right direction.

LAWYER'S SELF-CRITICISM.

MEMBERS of a middle-western bar association met the other night to discuss a proposed state law which would make membership in the association compulsory for all lawyers and give the governing board broad powers over all lawyers in the state.

One lawyer—Ed S. Wertz, former United States district attorney at Cleveland—objected on the ground that the bill would give big corporation lawyers control over the entire profession; and in making his objection he voiced a criticism that is worth reading. He said:

"It's not the ambulance chasers that are giving the lawyers a bad reputation. Our bad reputation is being earned for us by the high-priced lawyers who know how to get around the law in favor of the holding companies."

The criticism is as true as gospel. It isn't the shyster who is troublesome, but the lawyer of real ability who lends his talents to anti-social groups which are out to "do" the public.

WHAT CHANGING EDITORS THINK

CHANGING CHANCELLORS
 (Special Bulletin)
 ALTHOUGH the President M. Hunter will not take office as chancellor of the Oregon higher educational system until September 1, the mere announce-

ment of his appointment to that position has already brought calm where there was strife, has brought into the hope of progress. When Dr. Hunter does take office, he will have, we believe, the support of the state, of the schools, and of the faculties.

This is not said in derogation of William Jasper Kerr, the outgoing chancellor, but it would be an untruth to say that Mr. Kerr has enjoyed united support, or that he has enjoyed the unqualified confidence of all. To him it must be a relief that his tenure of office is so nearly ended. Past the three score years and ten when the average man is ready to begin to rest, if indeed he has not already started resting, with more than a quarter of a century of service as head of the college at Corvallis, and as chancellor, behind him, Mr. Kerr has earned the comparative quiet of private life which has been made available to him.

WASHINGTON LETTER

 WASHINGTON, June 29.—Ewing Mitchell would be the most popular man in town if he had been able to make his charges stick.

Neither the bungling attack of that ousted "little cabinet" member nor any conceivable amount of whitewash can bury the odds which emerge from the Department of Commerce under Secretary Dan Roper, the ex-lobbyist.

It will take an even more inept person than Mitchell to destroy the department's reputation here as the New Deal's chief citadel of favoritism and peanut politics.

If Mitchell had the faintest notion of how to assemble and present his charges and evidence effectively, he would have made much more of an impression.

About all he displayed, however, was a strong sense of indignation and a living exhibit of the type of folks who land in soft spots in the Roper organization.

The Levisian deal by which certain friends of the president and others were excused from penalties for non-operation was of debatable merit. Comptroller General McFarland opposed it. Roosevelt okayed it.

Many of the president's friends who would give up those yacht cruises with Vincent Astor and Kermit Roosevelt—two of the alleged beneficiaries—believing "it doesn't look good" and gives his enemies ammunition.

But in that, Mitchell was digging up old bones.

Fire Isn't Quelled
 Mitchell's flop will not divert fire from other sources at Roper's Shipping Board Bureau, Steamship Inspection Service, Bureau of Aeronautics, and other bureaus. His evidence of continuous excuses from penalty for violation of navigation laws, of ships allowed to go to sea inadequately manned or with broken propellers, and of steamship inspectors allowed to remain after being found to have taken "gratuities" still stands in the record.

The Morro Castle, which burned with loss of 100 lives after being held with government money, was found to have had passenger cabins and stairways made largely of wood—including Oregon pine in the latter case—which burned quickly.

"Hatchet Man" Rewarded
 Secretary Roper has hired a new crew of press agents and his critics believe he needs them. The department has been notorious for political spoilsmanship which trampled on many seasoned old-timers.

H. Russell Amory, hatchet man in the cleanout of employees and often credited with helping block confirmation of Dr. Willard Thorp as chief of the Bureau of Foreign and Domestic Commerce, has since been rewarded by a high post in the Shipping Board Bureau.

Some of the non-political old-timers in the department say they often pray for the return of Herbert Hoover as secretary of commerce.

Too Much Family
 After reporting the current local reaction to Mr. Roper, it is perhaps only fair to point out also that political activities of the Roosevelt boys, James and Elliott, have roused no great enthusiasm among many folks in the administration camp.

Obviously, this isn't a matter ever discussed publicly. But it's discussed plenty in private.

Some New Dealers are convinced that the activities of the presidential family, aside from Mr. Roosevelt, have been, politically, a net loss. There's some reason to believe that Jimmy, who has been given virtual patronage book of Massachusetts and has prospered in various lines of business, has lately been yanked out of the limelight for a while.

And you're likely to hear less of Elliott as a result of efforts to oust him from vice presidency of the Young Democrats of Texas.

Talks Out of Turn
 Even firm friends of Mrs. Roosevelt wish she had kept quiet about the Hauptmann trial and hadn't identified herself so completely with the humanitarian but now flailing subsistence homesteads program.

They admit that divorces in the Roosevelt family are the business of no one but those concerned, but are forced to admit that such incidents have been quickly seized upon by many persons anxious to make attacks.

Current "whispering campaigns," especially in the south, do not neglect the Roosevelt family. There is no shred of truth in any of the "whispers" thus far reported back to Washington.

AN EDITORIAL ON HEALTH

 'T wasn't many years ago that mothers used to dread the second summer of their babies. But that was when great numbers of infants died because of contaminated milk and water, and because infection was carried from one baby to another by flies and other insects.

Today summer is not considered any more dangerous than any other season of the year. In fact, it is welcomed as a period when the baby can get outdoors and have enough of the sunshine that is so useful in preventing rickets.

Probably the most important factor in lowering the number of deaths and the amount of illness during summer has been the provision of clean milk. By clean milk is meant not only that which is free from visible dirt, but milk that has no considerable quantity of dangerous germs.

Before the development of modern dairy methods, before homes were equipped with suitable systems of refrigeration, milk was likely to be contaminated not only as it was collected on the farm, but also in handling it in the dairy and during its delivery to the home.

Moreover, the milk would be kept in the city in a warm place and under the conditions of summer, and such germs as were present tended to multiply.

The reason why babies of an earlier period had no trouble during the first summer was the fact that their mothers were nursing them during that period, and, therefore, they were free from the danger of impure milk.

Nowadays it is important that the milk for the baby should always be put in sterilized bottles and that the bottles, nipples and nipple caps should be boiled at least three minutes before being used. After the milk formula is prepared, it also may be boiled for three minutes, then cooled and divided among the milk bottles by pouring it through a sterilized funnel.

If the baby's milk and water supply are carefully guarded in this manner, the child will be freed from the most dangerous hazard of the summer period.

The other hazards which occur are easily controlled, because they involve merely protection of the baby against undue heat.

Clothing for the baby in summer should always be light in weight and small in amount. When the temperature becomes exceedingly high, the baby need wear nothing except a band and a diaper.

The baby should always be protected against sunlight in too large amounts because there is danger of sunstroke due to overexposure. Children who are able to run about may be habituated gradually to the sun and allowed to tan without blistering.

A coat of oil or ointment on the skin, while the child is wearing its sunsuit during the summer, will permit it to tan gradually.

Guard also against dangerous infection of the feet by keeping children from running about barefoot over ground that contains broken glass, nails and other sources of danger.
