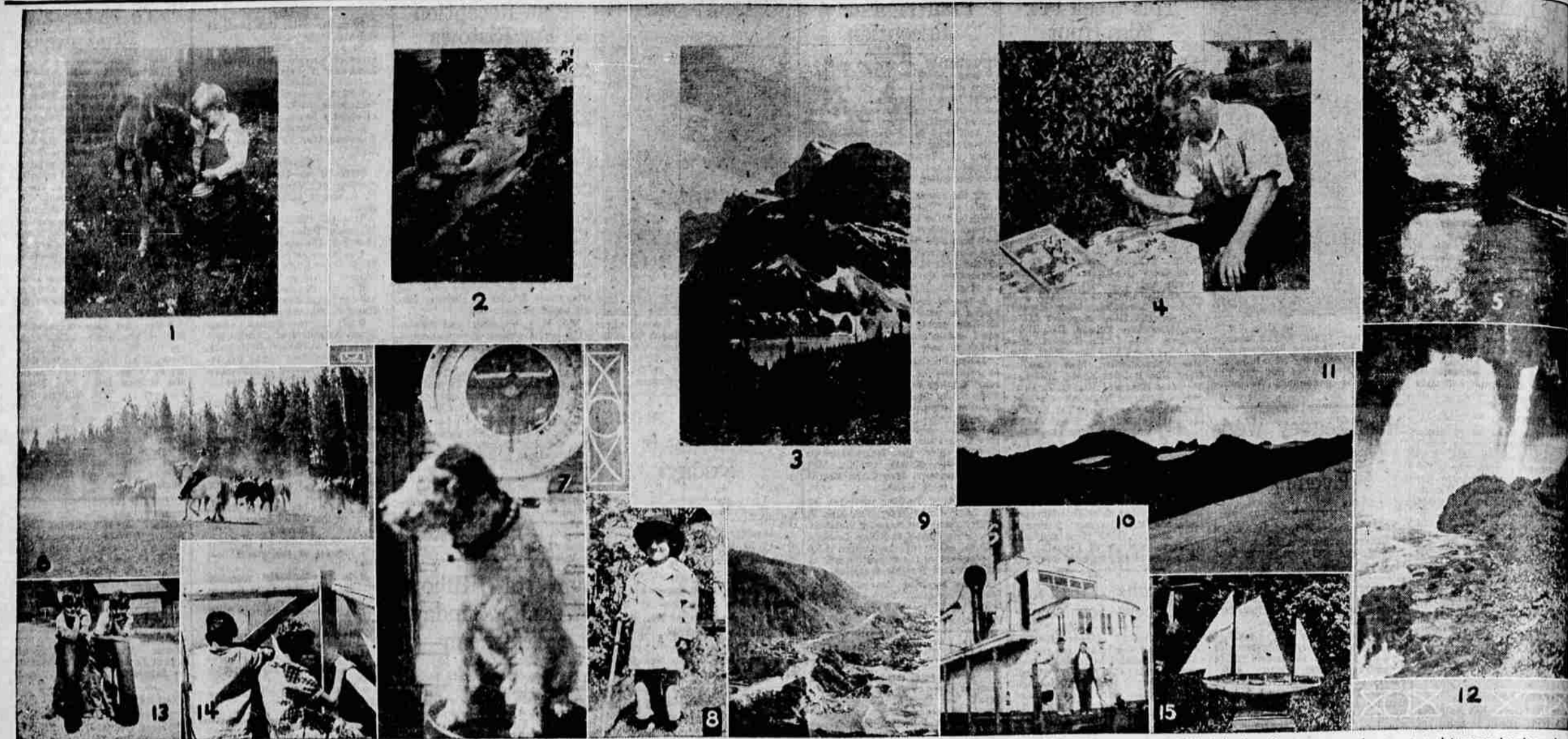

RAYON TAX DEMAND REFUSED BY SOLONS

WASHINGTON, July 20.—(AP)—The senate today overwhelmingly reaffirmed its decision against imposing a compensatory tax on rayon and other competitors of cotton by rejecting 62 to 15 a motion to reconsider the question.

Opponents of the rayon tax had denounced it variously as "unjust" and as a "surrender to the silk industry." Senator Wagner (D-N.Y.) argued that silk is a stronger competitor to rayon than rayon is to cotton.

Senator Russell (D-Ga.) made the motion to reconsider the vote by which the senate Thursday rejected the AAA amendment applying a tax on rayon equal to 125 per cent of the processing tax on cotton.

"The congress has gone to extremes in looking after the cotton growers," said Senator Glass (D-Va.) during furious debate on the proposal.

He said one rayon factory alone in Virginia employed 5,000 persons, which meant that 20,000 people were dependent upon it, "and yet the senate without one word of hearings precipitates this proposition to tax out of existence this industry that is yet in its infancy."

UTILITIES CHARGED WITH BUCKING PWA

WASHINGTON, July 20.—(AP)—Public Works Administrator Harold L. Ickes today joined congress' investigation of public utility companies by charging that their 22 court fights against federally-financed municipal power plants "apparently emanated from some central source."

So far, the government has won the right in nine cases to loan and grant money for city-owned facilities. Federal attorneys lost four times. Nine motions for dismissals still are pending.

"A concerted attack by utility companies to prevent the construction of municipal power projects voted by various communities with financing through PWA loans and grants has resulted in the filing of the court actions," Ickes said.

"In virtually every case, the language in the bills is similar insofar as questions of constitutionality are concerned. In a number of the bills the allegations of unconstitutionality are identical, indicating that they are drafted on forms or instructions emanating from some central source."
