NATIONALIZE EDUCATION?

IN education as in many other activities there is conflict between those who would centralize and nationalize and those who would cling to the older and more certain advantages of decentralized and localized school administration. The issue cropped out in the NEA convention at Portland in the renewed demands for "a place for education in the president's cabinet". The argument is, of course, that such recognition of education would inevitably bring larger federal appropriations in support of education and a great improvement in educational standards through coordination and standardization.

Very wisely, we believe, the NEA has shelved this program. If we interpret correctly the resolutions adopted by NEA, teacher opinion really runs in the opposite direction from nationalized education, for the teachers protest quite vigorously against national dabbles in education under the guise of welfare projects and relief. And they object most strenuously to legislation such as that enacted by Congress for the schools of the District of Columbia which seeks to restrict the freedom of teachers in action and belief.

Federal AID of education in states where support is weak is one thing and the teachers welcome that. But federal CONTROL of education such as might result from an elaborate bureaucratic setup might easily prove disastrous. The creation of a separate Department of Education with its chief sitting in the president's cabinet might not be any more dangerous than the present department of education which has only the power to encourage and assist the schools of the 48 states, but the tendency in every full-fledged national department is to seek more and more power till control becomes absolute.

In education, perhaps more than in any other field there is a certain definite strength in decentralization. Oregon or Arkansas or Pennsylvania may lag behind California or Massachusetts or Iowa in certain particulars, but who knows what really constitutes educational progress. If Tennessee or Michigan happen to enact silly laws affecting schools, those laws do not affect the freedom of the schools in any other state, and education everywhere derives the benefit of competition and criticism between states. The dispersion of educational control is a first line of defense against those forces which have made nationalized education the right-arm of propaganda in dictator-ridden European states.

Political dangers aside, nation-wide "standardization and coordination" in education is open to the widest debate.

OREGON COUNTRY INVITES.

IF the "Glorious Fourth" in Oregon "ain't what she used to be," as one old timer remarked the other night while ducking a whizzbang, it is mainly because times and conditions have changed. If the old time rousing celebration which used to feature the Fourth in Eugene has given way to a much quieter observance, it is mainly because the modern highways and the modern automobile have opened the whole Oregon country to holiday-minded people of Eugene.

There used to be a good reason for the much mourned community celebration. In the Gay Nineties, the cruising radius of a family was about 10 miles; today it is anything up to 200 miles. Always there are plenty of formal celebrations for those who prefer to celebrate with crowds. This year the Eugenean has his choice of the big bridge dedication down at Reedsport or the Water Carnival at Bend or the Calapooia Roundup or the Baker Miners' celebration. Or he can have "privacy" in any one of dozens of forest service camping grounds.

Paw can get in a bit of judicious fishing and return to the family campfire to guzzle fried chicken and watermelon, and little Willie and his sister Nell can shoot the fireworks on a gravel bar without burning either Grandma's hair or the house down. The spirit of the Fourth has not been impaired. Never were the roads to "life, liberty and pursuit of happiness" so clear. Even Old Roxy-beak who proposes merely to pitch a hammock between the big maples in the back yard will savor freedom, undisturbed. In the Land of the Free, the Day of Freedom is here.

ERIC MERRELL, ABLE MERCHANT.

ONE of the ablest businessmen of Eugene was Eric Merrell whose career has been cut off abruptly by an illness which began with a seemingly mild throat infection. Like many strong men, Mr. Merrell did not "favor" little disorders. Extremely energetic and always absorbed in his work he was accustomed to "throw off" illness. Death tricked him.

Mr. Merrell's business career was characterized by staunch faith in Eugene. His latest enterprise was founded when depression was most severe. Several friends who were full of their own "woes" advised strongly against any new ventures at such a time. It was during that period when there was more earnestness than jest in that talk that the wise man should "hunt himself a canyon and dig in". Mr. Merrell argued that whatever might be happening to the rest of the country there was still "a future for Eugene." He argued stubbornly that the day of the independent merchant was far from done. He proceeded to demonstrate his theory. Cities are built by determined men.

WARNING FOR THE FOURTH

WE cannot have too many reminders that the "safe and sane" Fourth of July is still to be attained.

Fireworks still are dangerous things for children. Last year they killed two dozen persons and blinded 57. This year, unless parents are far more watchful than they were last year, explosives will exact an equally heavy toll.

Under existing laws there is not very much the police can do to prevent these tragic accidents. For the most part, the job is up to fathers and mothers. If they can't keep fireworks out of their

youngster's hands altogether, they can at least see to it that the things are discharged with the proper care.

A firecracker, after all, is nothing but a miniature bomb. It needs to be handled with the same kind of caution that is given to its full-grown military brother.

WASHINGTON LETTER

 WASHINGTON, July 3.—Few other developments, if any, stand out in retrospect after the Democratic convention as conspicuously as the decision of the major party to stress in its campaign the distinction between the Constitution and the U. S. Supreme Court.

It is the present intention of Roosevelt and his New Dealers to hammer away on this line through the campaign. The argument will run like this: The Constitution is a great and immortal document and should not be tampered with unless conditions obviously require and public opinion overwhelmingly demands.

But the supreme court is made up of nine human beings, prone to human weaknesses and prejudices, including certain reactionary gentlemen who are neither abreast of the times nor free of the background of special privilege and corporate exploitation from which they rose to the bench through appointment by Republican presidents.

This will be something of a theme song among Democratic orators—unless, you must bear in mind, popular reaction seems unfavorable.

LARGER BENCH IN PROSPECT

The implication which will be stressed, more or less specifically, is that Roosevelt hopes for vacancies on the court which will allow him to appoint judges of liberalism as well as high standing.

Privately, the president has given serious consideration to the proposal that he ask Congress for the power to appoint additional justices to the court, so that a liberal majority might outweigh what is now the conservative majority, consisting of Justices Sutherland, Van Devanter, McReynolds, Butler, Roberts—and sometimes Chief Justice Hughes.

Opinions of the liberal minority of Brandeis, Stone and Cardozo—and sometimes Hughes—will be accepted somewhat as party dogs insofar as these men have held certain New Deal measures to be constitutionally valid and have accused the court's conservatives of deciding issues on a basis of economic prejudices rather than on points of law.

DECIDE TO TAKE PLUNGE

Prior to the convention, Roosevelt and his strategists hadn't quite dared make such an argument. They told themselves the public mind was so unaware of the facts and so worshipful of the court that "you couldn't make the tortured bodies and souls of men who work and pray, of women whose God-given right is not fulfilled in a sweatshop, and of children whom we have sought to restore to the schoolroom and the playground."

The first official departure from this attitude came in Senator Alben Barkley's keynote speech, through White House instigation. Barkley directly attacked the five justices who killed the New York minimum wage law.

BARKLEY SETS PACE

"Over against the hosannas of Hoover," Barkley said, "for the tortured interpretation of the Constitution, I place the tortured bodies and souls of men who work and pray, of women whose God-given right is not fulfilled in a sweatshop, and of children whom we have sought to restore to the schoolroom and the playground."

Senator Joe Robinson, speaking as permanent chairman, followed with more of the same. Considerable research has been done lately into the backgrounds of the conservative justices, and the logical follow-up of the language of the platform and Roosevelt's acceptance speech (either an immortal declaration for human rights or an attempt to "stir up class hatred," as you prefer) will be to show that these justices are "servants of special privilege" rather than friends of the plain people.

Unless planned campaign tactics are reversed, you will be hearing that:

Justice Van Devanter is an ex-politician and corporation lawyer, an attorney for the Union Pacific railroad in its land-grabbing days, who later, as a judge, awarded the Union Pacific land along its right-of-way worth millions of dollars—and has decided for the railroads in every major railroad case before the supreme court.

Justice Sutherland was a Republican senator, protégé of Senator Reed Smoot of Utah and buddy of Harding, who, as a justice, has described as an "extraneous circumstance" the fact that a woman employee "needs to get a prescribed sum of money to insure her subsistence, health, and morals."

Justice Butler was a lawyer for the Chicago, Milwaukee and St. Paul railroad, who, as regent of University of Minnesota, forced out professors who disagreed with his ideas about valuation, rates, and municipal ownership.

And, of course, Hughes was counsel for Standard Oil and many other big corporations and so was Robert Taft, the latter's clients being the anti-labor union Pennsylvania railroad.

No one can say now whether such line of attack will be effective. It might turn out to be a big mistake. (Copyright, 1936, NEA Service, Inc.)

AN EDITORIAL ON HEALTH

CHILDREN differ considerably in the ways they develop their teeth. They differ even in the difficulties they have during teething. But even the healthiest children may be fretful and have poor sleep for two or three nights, when the first teeth come through.

They have a disposition to put fingers in their mouths and to indicate discomfort in other ways. Sometimes there is considerable drooling, or flow of saliva, with loss of appetite.

There also may be slight fever and looseness of the bowels, and the appearance of undigested foods in the excretions. In most instances, these symptoms will last only three or four days, and there may be no gain in weight for three or four weeks.

If symptoms of teething are severe, the mother should consult her doctor for aid in prevention of pain, and in encouraging development of the teeth.

It is useful to know the sequence in which the teeth usually appear. First come the two central lower teeth during the period from the fifth to the ninth month. Next are the four upper central teeth, which come in from the eighth to the twelfth month.

The other two lower central teeth and the four front double teeth follow in the twelfth to the eighteenth month.

Altogether there are 20 teeth in the first set. The remainder appear between the eighteenth and the twenty-fourth months, excepting the four back double teeth which usually appear between the twenty-fourth and thirtieth months, but may be even later.

The importance of teeth for health and long life cannot be overestimated. Few mothers realize that first attention to the teeth of the child must begin before the baby is born.

The mother should visit her own dentist early, as I pointed out in the series on prenatal care. She must keep her own teeth clean and take care of any cavities or decay which develop.

She must always eat the right foods, so that the child's teeth will develop properly. Proper foods for the expectant mother include plenty of milk, fresh vegetables, eggs, cooked fruits, cereals, and a sufficient amount of calories to provide energy.

The foods to be avoided are sweets and meat in excess, gastrics, and highly seasoned substances.
