## Christmas Seals Have Arrived Here

Christmas seals which Lane  
 county residents will receive from  
 the county tuberculosis association  
 through the mail Monday, Novem-  
 ber 22, have arrived in large quan-  
 tities at the association's office.  
 Volunteer committees have been  
 appointed in the various communi-  
 ties and work is already under  
 way to prepare to mail the seals.  
 Loy W. Rowling, county chairman  
 of the campaign, said Wednesday.

The Christmas seal sale, held by  
 the association in conjunction  
 with the nation-wide campaign, is  
 the only appeal made throughout  
 the year for funds to support the  
 work of tuberculosis control.  
 Ninety-five per cent of the money  
 raised through the sale remains in  
 the state. Five per cent goes to  
 the national tuberculosis associa-  
 tion which, in addition to many  
 activities on tuberculosis work on  
 a national level, supports exten-  
 sive medical research in the field  
 of tuberculosis.

Winfield H. Atkinson, president  
 of the Lane County Public Health  
 (tuberculosis) association, states  
 that the budget committee has set  
 the goal of the 1943 sale at \$5500,  
 the amount required to carry on  
 the work planned for the coming  
 year.

Atkinson advises that stamp  
 collectors should get in touch with  
 the association immediately in or-  
 der to get the new seals.

## Pickers Needed if Army Gets Turkey

"If the people of Lane county  
 expect their boys in the service  
 —both in this country and over-  
 seas—to eat turkey and chicken  
 during the coming holidays, more  
 pickers must be forthcoming to  
 take care of the ever-growing  
 number of fowls being brought to  
 our packing houses."

So stated C. V. MacDonald,  
 manager of the U. S. employment  
 service. "This is the last part of  
 a great job of harvesting well  
 done," he said. "We know that  
 there is a number of capable pick-  
 ers in this area not now employ-  
 ed and we urge them very strong-  
 ly to meet this present crisis. It  
 will mean a lot to our boys to be  
 thus taken care of at Thanksgiv-  
 ing and Christmas, and we know  
 that we can expect a large num-  
 ber of pickers to respond to this  
 call."
