Denial Trifles Late Dewey said the president attempted to "softly deny" he wanted the support of the communists but charged the "soft disclaimer" came "a trifle late."

"Only last week in Madison Square Garden Earl Browder, the head of the communist party in America, proclaimed to 15,000 cheering adherents that the election of my opponent was essential to his aims," he added. This is the same Earl Browder, now a patriot, who was convicted as a draft dodger in the last war, convicted again as a perjurer and pardoned by Franklin Roosevelt in time to organize the campaign for his fourth term. The soft disclaimer does come a little late."

Dewey charged also that the democrats were relying on a "solid block of votes in states where millions of American citizens are deprived of their right to vote by the poll tax and by intimidation," adding: "Not once in 12 years has my opponent lifted a finger to correct this and his platform is cynically silent on the subject."

He also accused Roosevelt of attempting to "play politics with the soldier vote" and predicted that the average vote from servicemen would be even larger than the civilian vote.

Dewey's Program The republican standard bearer reiterated that a republican victory would mean no change in the country's military leadership and added the promise that forming the peace would continue on a non-partisan basis. He said he planned to retain the help of the ablest Americans of both parties.

The governor recalled that he had promised to: Restore the department of labor with "an able and experienced man from the ranks of labor at its head," and guaranteed the continuation of free collective bargaining.

Work for a lasting peace through an international organization with adequate force to back it up. Expand social security to all the people. Conduct a government which has equal respect for the rights

Public Association Approves Health Plan

NEW YORK—The American Public Health Association's governing council has approved a national program for medical care including "essential preventive, diagnostic and curative services" for those unable to pay individually.

A national plan to provide comprehensive hospital, physician, laboratory and diagnostic services for all people in every area of the country; financing the services by social insurance supplemented by general taxation; establishment of a single responsible agency to coordinate administration, and financial assistance for qualified professional and technical personnel in obtaining post-graduate

made his way to the most forward point of the hill, and silenced an enemy machine gun.

"On two other occasions he again made the hazardous journey to the exposed point and killed two snipers located to the rear of the hill.

"Later the enemy laid a tremendous volume of small arms and mortar fire on the platoon's position. Expecting a counter-attack, Private Gisborne made his way to a point within 30 feet of the reverse slope of the hill. As the Germans came into view over a ledge, Private Gisborne courageously rose to a standing position and calmly fired into their ranks, killing four and wounding one, to repel the attack.

"Wounded in this action, Private Gisborne refused to leave his comrades and remained to aid in repelling numerous attacks. His courageous determination and fighting spirit provided an inspiration for his fellow soldiers and his performance reflects the finest tradition of the American soldier."

WASPS Will Be Taken From Action—Arnold

WASHINGTON—Gen. H.H. Arnold has announced the army air forces will inactivate the women air force service pilots (WASP) on Dec. 20 "unless there are unexpected and much higher combat losses in the air war over Germany."

The announcement said the decision to release the volunteer women pilots from further service was based on present indications that by mid-December sufficient male pilots will be available to fill all flying assignments in this country and overseas. The WASPs have been largely used in ferrying services.

Recruitment for the WASPs was halted last spring.

Gen. Arnold said in a statement: "I am proud of the WASPs and their record of skill, versatility and loyalty. They have done outstanding work for the AAF, even exceeding our expectations when the program was begun in 1942."

He added there are now approximately 1,000 members of the women's flying force capable of operating all types of aircraft, including the fastest fighters and B-29 super-bombers. Thirty members of the corps have been killed in service.
