

Bridges' Dockmen To Vote On Strike

SAN FRANCISCO, Jan. 26.—(AP)—More than 30,000 longshoremen in California, Oregon and Washington will vote next week on a recommendation made yesterday by the CIO International Longshoremen's and Warehousemen's negotiating committee to strike on or before April 1.

The strike recommendation climaxed a day of rapid fire developments in the six-month-old negotiations between the union and waterfront employers over the 1946 contract.

Harry Bridges, ILWU president, made the following moves: 1. Appealed to President Truman to intervene to avoid what he called an "inevitable" west coast shipping tieup.

2. Accused the waterfront employers association of breaking off negotiations in an effort to nullify the wage-hour law.

The union is asking an hourly wage increase of 35 cents, from \$1.15 to \$1.50; \$2.25 an hour for work in excess of six hours and \$3.37 1/2 for night work on Saturday, Sundays and holidays and all night work after the first six hours between 5 p.m. and 8 a.m. on Monday through Friday.

lath, cast iron soil pipe and fittings, cast iron radiators, bathtubs, lumber and millwork. The civilian production administration anticipates that through this priority program, about half of the critically short materials produced in 1946 will be made available for construction of homes for veterans costing \$10,000 or renting for \$80 or less.

Priority Regulation 33 requires that applicants must furnish description of the structures they plan to build, the price or rental at which they will make it available to veterans. The FHA must be satisfied that the proposed sales price or rent is reasonably related to the proposed accommodation. The regulation further requires that applicants must show they will be ready to start construction within 90 days and demonstrate that they have effective control of the land, that financing is assured, and that arrangements have been made for local building permits, utility services and the like. Applicants must agree to make the housing available only to veterans during the period of construction and for 30 days thereafter. In his sales agreement, the veteran or other purchaser is pledged to the same 30-day waiting period in case of a re-sale, and the sale must be made at or below the maximum sales price originally paid.

Conversion of existing structures also is made possible by the regulation, where it is shown that increased dwelling units will result. It also covers construction of dormitories or group housing for educational institutions for the benefit of veterans. Housing already under construction may be brought under the reconversion housing program if it meets the standard set in priorities regulation 33.

Johnson emphasized that while the \$10,000 sales price, which includes land and improvements, or the \$80 a month rental, are minimum figures, every effort will be made to encourage the production of housing at price levels as much under the \$10,000 maximum as feasible.

Application forms may be obtained from the local rental lumber dealers and the chamber of commerce, he said.

Chamber of Commerce Vice President Orlando Hollis presided at Friday's meeting in the absence of President Herbert J. Cox. Others at the speaker's table included Eugene's Mayor Earl McNutt; James Rodman, Jr., president of the Eugene realty board; Walter Schmieding, chairman of the Retail Building Materials association's public relations committee; and Carl O. Hendrickson, secretary of that association.

The Cowles broadcasting company, operators of radio station WOI here, announced today that they are seeking federal permission to erect an experimental facsimile broadcast station in Washington.

"This new station," the company said in a statement, "will be erected for the purpose of demonstrating the feasibility of utilizing radio electronic methods for the distribution and delivery of printed news."

"The first step in the experimental stationing of news is necessary for the maintenance and operation of such a station in the service of the public."

State and federal entomologists from five northwest states meeting here to consider suggestions for the 1946 tree fruit spray program have discovered that DDT, the war developed insecticide that kills one time, can also cause the insect to thrive and lead a happy and prolific life.

When entomologists began comparing research notes they found that not only does DDT fail to kill the cherry fruit fly, but it actually serves as a tonic to the pest. One worker reported there were more cherry fruit fly maggots in cherries sprayed with a DDT mixture than on cherries in the unsprayed control plots.

FEPC Filibuster In Second Week

WASHINGTON, Jan. 26.—(AP)—Throat-weary southern democrats filibustering against fair employment legislation in the senate yesterday continued their tactics to permit a pro-FEPC colleague to "express his views."

The effect of the move, coming as the filibuster dragged along in its second week, was to give southern larynxes a rest without bringing the legislation any nearer to a vote.

Sen. John L. McClellan (D-Ark.), a leading foe of the proposed permanent fair employment practice commission, consented for Sen. Alexander Smith (R-N.J.) to make a speech in favor of the bill.

Smith called for passage of the bill to give "the Negro equality of opportunity and education."

Denying they are "an inferior race," as the southerners contend, Smith said Negroes are entitled to a chance to take advantage of the American opportunity. He said the bill did not "as some believe"—have anything to do with "the inter-marriage of the races."

Meanwhile, nearly 40 senators had signed a petition to break the filibuster by limiting debate.
