Oregon Granted Planning Funds

**WASHINGTON (AP) — The
Federal Works Agency disclosed
Tuesday it has appropriated Wash-
ington state \$803,298 and Oregon
\$460,364 for use in planning pro-
jects for the state and local public
works reserves which the agency
said now exist in the United
States.**

The agency said it has approved
planning for projects totaling
\$11,777,000 in Washington and \$6,
064,000 in Oregon.

The approved requests were for
projects included in a proposed
Oregon list suggesting possible
work totaling \$7,652,000 and from
a similar Washington list suggest-
ing \$37,747,000 in projects.

In Oregon, the agency said, \$6,
625,000 in other projects has been
planned without federal aid and in
Washington \$10,053,000 worth.

An additional \$36,475,000 in
Oregon projects and \$58,018,000 in
Washington work is in the design
stage, the FWA said.
