Irate Woman Foils Bridge

EL VERANO, Calif. — (U.P.) — This little city in the Sonoma Valley hills had its troubles Tuesday.

Mrs. Ruth Denny, an elderly property owner, is dead set against the city's proposal for a new bridge across Sonoma Creek to replace the historic one of 1888 vintage. Her property is adjacent to the new bridge site and when crews came in Friday to work she promptly stood in front of a bulldozer and halted the operations.

Forest Income Down \$500,000

Heavy snows in the Northwest and Rocky Mountain states contributed to a \$500,000 drop in national forest income from timber sales, according to a recent announcement by the Forest Service.

Receipts for the first quarter of the year were listed at \$4,884,740, as against a total of \$5,345,201 for the same period last year.

However, the total income for the first three quarters of the fiscal year approached \$22,500,000—which is only two million less than the income for the entire previous year.

Forest Service officials expect that the total income will surpass that of the previous year, up to then the all-time high.

Bathing Beauty Dies in Crash

GUYMON, Okla. — (U.P.) — A brunette Chicago beauty queen, named "Miss Windy City" in a contest three weeks ago, was killed in an auto crash as she drove home from a Hollywood screen test, authorities have announced.

The victim was 18-year-old Mrs. Corine Bartolini O'Leary. She had married David O'Leary, 24, only a few days after she won the beauty contest at Chicago's Palace Theater on June 21.

She and O'Leary had made the trip to Hollywood, which she won in the contest, as a honeymoon.

O'Leary escaped with only minor injuries in the accident.

Authorities said Mrs. O'Leary was driving when their car skidded on wet pavement and hit a shoulder softened by recent rain. The car overturned and the top crushed down on her.

She died in an ambulance taken to a hospital.

Prisoner Weds In His Cell

SAN DIEGO, Cal. — (U.P.) — Prisoner James Edward Burns, who married under a false name two years ago to escape capture, was remarried in county jail this week by his cellmate, an ordained minister.

The Rev. Joseph Belton Stacey of the Faith Home Rescue Mission in Los Angeles performed the ceremony for Burns and his wife, Edith. Stacey was in jail on a wife beating charge.

Burns was picked up here by the FBI which said he was an escaped prisoner from the Washington State Reformatory. He previously was married in Chicago under the name Flynn to conceal his identity from the FBI, which was looking for him.

Fish Packers Amend Charge

SALEM—(U.P.)—A group representing the Columbia River Packers Assn. has filed an amended complaint in Marion County Circuit Court seeking a perpetual injunction against the State Fish Commission from enforcing the law banning set nets and fixed gear for fishing in the Columbia River.

The complaint also seeks to have the statute, adopted by the voters last November, declared unconstitutional.

Signing the complaint for the packers' group were Charles R. Miles, Elmer H. Beebe, Agnes M. Beebe, Carl Eastland, Hjalmer F. Hjorten, Fred R. Hjorten, Ray H. Hoagland and Robert M. Hoagland. Also signing the complaint was H. K. Parker.

At the same time, the Columbia River Fishermen's Protective Union sought to intervene in the case.
