**Eugene People  
Get Dunked**

Five Eugene residents were dumped into the waters of the Umpqua River mouth on the coast Sunday when their boats upset in a heavy fog, Mr. and Mrs. William H. Jenkins and Mr. and Mrs. J. B. Armstrong were able to reach the jetty when their motorboat turned over, and the Coast Guard brought them safely in.

William Huey was fishing from a skiff with Robert Hendricks and Lulu Wilson of Florence, and the trio were thrown into the water by heavy seas. A passing fish boat pulled them to safety, the Associated Press reports.

Keep Firemen Busy**

BETHEL—Two blazes Saturday kept firemen busy here, but no damage was reported.

An alarm summoned firemen to Roosevelt Blvd. and Highway 99 N. at 3:21 p. m. to a trash fire behind the Roy Dickson store. Cause was unknown.

The other blaze was a grass fire in a vacant lot at the corner of Concord and Pattison Streets. Firemen who extinguished it also reported the cause unknown.

**Portland Airport  
Mystery Solved**

PORTLAND—Flares, apparently part of a fireworks display atop Mt. Hood, caused confusion and uproot at the Portland Airport Saturday night, and still weren't fully explained Monday.

A Northwest Airlines pilot, Paul Thresh, radioed into the airport late Saturday night and reported "a cluster of red lights." He also reported a white flare.

That immediately caused control tower operators to close off the airport, fearing a plane was in distress and might have to use the field on an emergency basis. Several passenger planes were held up from their takeoffs or landings for about three or four minutes.

On his return flight east to Yakima and Spokane, Thresh reported he could see nothing.

A check with the Hood River police department revealed that a mountain climbing organization—the Crag Rats—was holding its annual celebration on the mountain Saturday night, and part of the event was a fireworks display.

Claude Collins, Hood River police desk sergeant, said "those places they're shooting off on top of the mountain seem to be the thing that's causing the emotion."

**Hoarder Leaves  
Large Estate**

SEATTLE—A man who lived in a dilapidated shack, ate only stale bread and potatoes and all, his brother said, because he wanted to save for security, died Friday leaving an estimated \$50,000.

For more than 20 years Fred Wilson, about 75, lived the life of a pauper. He collected wood from the ship canal and sold it to his neighbors.

"He apparently was just saving for security," said Raymond C. Punnett, his investment broker. Wilson is survived by a brother in California.

**Truman Views  
Greek Aid**

WASHINGTON—President Truman Monday told Congress that chances of a Communist victory in Greece now are more remote than at any time since the Balkan nation was freed from the Nazis in 1944.

A tone of optimism pervaded the President's report to Congress on the Greek-Turkish aid program. It covered the first quarter of 1949.

Mr. Truman said Greece, with U.S. economic and military aid, "has succeeded in slowly reducing (Communist) guerrilla capabilities to achieve dominance by military force."

"As a result, the possibility of the political, economic or military collapse of Greece is now more remote than at any time since the liberation of Greece in 1944."

He said Greek armed forces are now more efficient than at any time since 1941, when the Nazis crushed them after they had turned back an Italian invasion.

The President reported, however, that during the first quarter of 1949, the Communist-dominated neighboring countries of Albania, Bulgaria and Yugoslavia continued to pour in aid for the guerrillas.

It stated that the transfer to the Turkish Navy of two U. S. cruisers, the Lansdowne and the Lardner, had been authorized and would take place as soon as the vessels were reactivated.

**Clark Naming  
Said 'Insult'**

NEW YORK—The Civil Rights Congress Monday termed the nomination of Attorney General Tom C. Clark as an associate justice of the U. S. Supreme Court "a gratuitous insult thrown into the faces of the negro people."

Clark elevation to the court would constitute a "major threat to the future of American constitutional liberty," the congress declared in a telegram sent jointly to Vice-President Alben Barkley and Sen. McCarran (D-Nev.).

It urged Barkley and McCarran to do "everything in your power" to persuade the Senate not to confirm Clark's appointment.

Text of the telegram was released here.

Clark has cited the organization as subversive.

The telegram accused the attorney general of conducting a "witch hunt" in his anti-Communist campaign. It also charged, among other things, that he had refused to use the power of his department to "prosecute the Klan or any other group which conspires to lynch or to otherwise discriminate" against negro citizens.

"Instead of furthering these un-

democratic policies by appointing Tom Clark," the congress said, "President Truman can advance American democracy by appointing any one of scores of qualified negro jurists to the office formerly held by Justice Murphy, who was an ardent champion of the liberties and the constitution Mr. Clark seeks to destroy."

**Chinese Free  
US Consuls**

SHANGHAI—(P)—Reuben Thomas, U. S. consulate administrative officer, was free to leave the consulate Monday after being held in the building for 30 hours by former U. S. Navy employees.


He had not left the building late Monday, however.

The workers—Chinese, some Indians and White Russians—blocked Thomas and other American officials from leaving the building on Friday. They demanded severance pay and bonuses of six and one half months' wages as Navy employees discharged when the Navy pulled out of Shanghai upon the approach of the Communists.

Still in the building late Monday with Thomas were Cmdr. Morgan Slayton, Navy attaché, and Walter McConaughy, acting consul general.

The men were to go to the Communist Labor Board Building

for further negotiations some time Monday. Only a handful of the more than 100 former employees remained in the consulate building. Thomas had been questioned more than 30 hours before he was permitted to get some sleep. Shaking off snow from evergreens with a broom during heavy storms will save them from possible breaking under weight.
