

'Old Joe' Incident Nation-Wide Story

The story behind the story about Gen. Dwight D. Eisenhower's reference to "Old Joe" Stalin in Eugene Tuesday night was revealed Wednesday by Ed Boehnke, Lane County Republican central committee chairman.

It was just four years ago that President Harry S. Truman, in a train talk here, said he liked "Old Joe." Ike read a telegram to his Eugene audience which quoted the Register-Guard on the point. He then said the President is trying to cover up his own mistakes by blaming Ike for mis-gauging Russian intentions and thereby periling the nation in 1945.

The President recently blamed the general for his testimony on Russia at that time.

Veteran newsmen on the Ike train hailed the Eisenhower rebuttal as of major importance and indicative that Ike is beginning more forcefully to strike out at the administration. They filed numerous stories from Oakridge which were being spread across newspapers of the nation Wednesday.

Boehnke Wednesday told this account: Tuesday, he said, Jim Rodman, former Republican party state chairman, and Boehnke compiled a report of the President's 1948 speech from files of the Register-Guard. They telegraphed it to Salem and Albany to make sure it would get aboard the Ike train.

The message was received, and Ike appropriately reminded the President that it was here in 1948 that the President said he was on friendly terms with the Russian leader.

Except for the Stalin reference by Eisenhower, newsmen said the Ike speech was pretty much routine. But because of the incident, the Eugene talk was being publicized nationally.

Hearst Estate \$40,499,214
 LOS ANGELES — William Randolph Hearst's estate has been appraised at \$40,499,214 on the basis of assets listed so far, but attorneys indicated Wednesday that still other assets to be listed will boost the gross value to \$56½ million.

A previous inventory listed assets at \$16,070,255, mostly stocks in oil companies and enterprises other than newspapers. The second inventory, filed Tuesday in Superior Court, includes 88,667 shares of non-voting common stock of the Hearst Corp., valued at \$40,000,200.

The publisher died Aug. 14, 1951, at the age of 88. He left most of his estate to his widow, Mrs. Millicent V. Hearst, their five sons and charitable foundations.
