

# McCarthy Puts 128 on the Spot

WASHINGTON (AP)—Since Feb. 20, Sen. Joseph R. McCarthy has linked the names of 128 persons with his investigations into communism and espionage risks.

Eight of these he has connected with the State Department. He named as having been connected with the White House the administrations of Franklin D. Roosevelt or Truman. Others have been connected at various times since 1950, including the period of McCarthy's investigations at the Ft. Monmouth, N.J., radar center.

The 38 connected by McCarthy to the State Department still are employed there. None of the 38 ever has been convicted in any court because of charges brought by McCarthy, though one—Owen Lattimore—is under indictment for perjury.

While 27 no longer are employed in the State Department, because of security orders the department will not say who resigned without being aware that his loyalty was questioned, who was forced out or who resigned rather than face investigation.

Some apparently are working in other federal agencies. In a broadcast April 6, 1954, McCarthy said his permanent subcommittee on investigations had questioned 128 witnesses in a little over a year and that 84 of these had refused to answer on "the ground that if they told the truth they might go to jail."

These 84 are included in the 128 total. McCarthy said in that broadcast over the Columbia Broadcasting System that "24 witnesses with Communist backgrounds have been discharged from jobs in which they were handling top secret contracts for material."

Early this year McCarthy's subcommittee released a printed report of its activities for the past year. It listed 79 persons who refused to reply to questions. Seventy-one refused on the grounds of the First Amendment to the Constitution. Two declined on the basis of marital privilege; that is, a husband does not have to testify against his wife. One witness refused without invoking any constitutional privilege.

**Included in Figure**  
The 79 witnesses listed by the McCarthy committee report are included in the 84 figure used by McCarthy in his broadcast.

Twenty of the 79 witnesses were labeled by McCarthy as writers whose works were used in either the Army or State Department information programs. Three of the 79 were employed by the government at the time they were questioned, though one of these was subpoenaed in connection with gambling activities and not communism.

The remainder of the 84 mentioned in the broadcast had various backgrounds — employees of former employees of defense plants, officials or members of the Communist party, employees of private organizations, or teachers.

On March 8, 1950, McCarthy appeared before a special subcommittee of the Senate Foreign Relations Committee and named nine persons. They were: Phillip C. Jessup, U. S. ambassador-at-large. Owen Lattimore, Johns Hopkins University professor. Haldore Hanson, chief of the technical cooperation projects staff of the Point Four program. Ester Calkin Brunauer, State Department administrative aide. Gustavo Duran, employed by the State Department 1943-46. Dorothy Kenyon, New York attorney and former member of the Commission on the Status of Women in the United Nations Economic and Social Council. Frederick L. Schuman, professor at Williams College. John Stewart Service, State Department adviser on Far Eastern Affairs. Harlow Shapley, professor of astronomy at Harvard University.

**'Unusual Affinity'**

The subcommittee majority said: Lattimore was not in any proper sense an employee of the State Department and "we find no evidence to support the charge that Owen Lattimore is the 'top Russian spy' . . . or any other sort of spy."

The subcommittee Democrats also said: "Far from being the 'chief architect of our Far Eastern policy,' we find that Lattimore has had no controlling or effective influence on that policy."

On Dec. 16, 1952, a grand jury in Washington indicted Lattimore on seven counts of perjury following a subcommittee investigation into the private research organization, the Institute of Pacific Relations, to determine whether it was infiltrated with Communists and whether it influenced U. S. foreign policy.

**Four Counts Tossed Out**  
In May 1953 four counts were tossed out by U. S. Dist. Judge Luther Youngdahl, former governor of Minnesota. Youngdahl said there was some doubt as to whether the remaining three counts would pass the test of materiality.

The chief charge against Lattimore is that he lied when he said he had never been a Communist sympathizer or promoter of Communist interests. The government has appealed for reinstatement of the four counts, and the case still is pending.

McCarthy charged Hanson was "a man with a mission—a mission to communize the world." The subcommittee majority reported: "On the basis of our record and the result of the FBI investigation as indicated by the loyalty board's action, we do not find Haldore Hanson to be disloyal, or a man with pro-Communist proclivities or a mission to communize the world."

McCarthy charged Mrs. Brunauer was pro-Communist and said her case was "one of the most fantastic" he knew about. The subcommittee majority found: ". . . There is no evidence that Mrs. Brunauer is disloyal, a Communist sympathizer or a security risk."

The subcommittee majority held that Shapley was not in the proper sense an employee of the State Department. Shapley told the committee that since he had never been on the State Department payroll, he had no desire to dignify the charges by appearing before the committee.

From time to time McCarthy named other persons, either in committee sessions or on the Senate floor. They included John Carter Vincent, minister to Switzerland; John Paton Davies Jr., now counsel to the U. S. Embassy at Lima, Peru; Lauchlin Currie, aide to President Roosevelt; David Demerest Lloyd, speech writer on the White House staff of President Truman; and Philo Nash, another Truman White House aide.

McCarthy said Vincent "is charged with being a member of the Communist party and to the best of my knowledge, is also charged with espionage activities in Switzerland."

**Vincent Cleared**  
Vincent was declared completely cleared of the charges by a State Department loyalty review board in February, 1952.

Davies was accused by McCarthy of following the Communist party line in China. He said also that there was "a vast amount of information on his Communist activities."

Davies, who has been investigated—and cleared—eight times by the State Department, recently was recalled from Peru to undergo another investigation.

McCarthy said, "The full outlines of Currie's betrayal have yet to be traced."

Currie denied before a Senate committee that he was pro-Communist or had any Communist connections.

Lloyd was listed by McCarthy as a man who engaged in Communist activities. Lloyd previously had been cleared by a security board. Nothing ever developed in his case.

Nash was accused of having been in close contact with the Communist underground in Washington. He called McCarthy charges "a contemptible lie." He subsequently was promoted by President Truman.

**Senate Speech**  
McCarthy in a Senate speech named 26 persons as being suspected of disloyalty. He said all were in the State Department, three—Jessup, Vincent and Davies—he made public previously. Of the remaining 23, six worked for the United States Information Service. Two of the six are still employed in the information service, which has been transferred from the State Department and is now called the United States Information Agency.

Old records of the information service show that, of the four no longer employed, one resigned and two left under reductions in force. As for the fourth, the records show three persons by the same name, all of whom resigned.

Nine of the 23 still are on the State Department payroll. The others resigned or were fired.

Two other names helped put McCarthy in the spotlight this year—those of Irving Peress and Annie Lee Moss.

Peress, an Army dentist, was described by McCarthy at a hearing as a "Fifth Amendment Communist." He had been given an honorable discharge as a major after it was discovered he had declined to answer certain security questions.

McCarthy clashed with the Army when he demanded to know who was responsible for granting such a discharge to Peress.

**Top Secret Papers**  
Mrs. Moss was described at another hearing as having been identified by an undercover investigator as a Communist in the 1940s. McCarthy said she was employed as a clerk handling top secret Army material.

Mrs. Moss appeared before McCarthy's committee and denied she ever had been a Communist. She said several other persons with the same name live in Washington. The Army said she handled only coded messages. Mrs. Moss subsequently was returned to employment in the Army in another job, pending completion of the Army's own security investigation.

The subcommittee majority reported: "On the basis of our record and the result of the FBI investigation as indicated by the loyalty board's action, we do not find Haldore Hanson to be disloyal, or a man with pro-Communist proclivities or a mission to communize the world."

McCarthy charged Mrs. Brunauer was pro-Communist and said her case was "one of the most fantastic" he knew about. The subcommittee majority found: ". . . There is no evidence that Mrs. Brunauer is disloyal, a Communist sympathizer or a security risk."

The subcommittee majority held that Shapley was not in the proper sense an employee of the State Department. Shapley told the committee that since he had never been on the State Department payroll, he had no desire to dignify the charges by appearing before the committee.

From time to time McCarthy named other persons, either in committee sessions or on the Senate floor. They included John Carter Vincent, minister to Switzerland; John Paton Davies Jr., now counsel to the U. S. Embassy at Lima, Peru; Lauchlin Currie, aide to President Roosevelt; David Demerest Lloyd, speech writer on the White House staff of President Truman; and Philo Nash, another Truman White House aide.

McCarthy said Vincent "is charged with being a member of the Communist party and to the best of my knowledge, is also charged with espionage activities in Switzerland."

**Vincent Cleared**  
Vincent was declared completely cleared of the charges by a State Department loyalty review board in February, 1952.

Davies was accused by McCarthy of following the Communist party line in China. He said also that there was "a vast amount of information on his Communist activities."

Davies, who has been investigated—and cleared—eight times by the State Department, recently was recalled from Peru to undergo another investigation.

McCarthy said, "The full outlines of Currie's betrayal have yet to be traced."

Currie denied before a Senate committee that he was pro-Communist or had any Communist connections.

Lloyd was listed by McCarthy as a man who engaged in Communist activities. Lloyd previously had been cleared by a security board. Nothing ever developed in his case.

Nash was accused of having been in close contact with the Communist underground in Washington. He called McCarthy charges "a contemptible lie." He subsequently was promoted by President Truman.

**Senate Speech**  
McCarthy in a Senate speech named 26 persons as being suspected of disloyalty. He said all were in the State Department, three—Jessup, Vincent and Davies—he made public previously. Of the remaining 23, six worked for the United States Information Service. Two of the six are still employed in the information service, which has been transferred from the State Department and is now called the United States Information Agency.

Old records of the information service show that, of the four no longer employed, one resigned and two left under reductions in force. As for the fourth,
