Wheat Quota Voting Friday

Lane Polling Places In Eugene, Junction This Friday, at two different polling places, wheat growers of Lane County will vote for or against marketing quotas for the 1955 crop.

ELIGIBLE TO VOTE

Chairman Myers urges every eligible wheat grower in Lane County to vote if he will have more than 15 acres of wheat on his farm for harvest in 1955.

PRICE SUPPORT

If quotas are approved, Myers added, there will be marketing penalties on any "excess" wheat produced outside the acreage allotment - and the full level of price support authorized for 1955 will be available for those who comply with their allotments.
