Kerby), Commercial Street side (east) parking lot entrance next to the new gymnasium. **CONTRACTOR SHALL NOT PARK IN THAT LOT.**

Prevailing wage rates must be paid on the project in accordance with ORS 279C.800 to 279C.870. Applicable rates are July 1, 2012 and amendment dated October 1, 2012.

The Commission may reject any bid not in compliance with all prescribed public bidding procedures and requirements, and may reject for good cause any or all bids upon a finding of the Commission that it is in the public's interest to do so.
