guarantee better health outcomes for African-Americans. Healthcare providers have a responsibility to deliver inclusive, quality care that considers the needs of the whole patient. That means providing patients with relevant, reliable information that empowers and engages them to make choices for a healthier life.

The truth is that all healthcare providers should strive to provide an environment where no one is excludedwhere everyone has access to compassionate, personalized care and the opportunity for better health regardless of their struggles or station in life. And that's the right model for all providers. Because we must get to know our patients on an individual, holistic level-not pre-

scribe a one-size-fits-all approach—if we intend to truly improve their health outcomes.

Finally, our policymakers, civic leaders and all who have a stake in the health of our community must address the social determinants that influence and widen the diabetes equity gap. 
